3. Board of Supervisors liaison report, Cristina Arzaga-Williams

BOS is staring the new year. Jack Sellers, from District 1 is the new elected Chairman of BOS and Bill Gates from Central Phoenix is the Vice Chair. BOS are working on getting the new budgets from all the different departments and agencies. Also, BOS is working closely with the AZDHS to roll out the vaccine to the priority groups.

4. Head Start Director's Report, Eve Del Real

The Head Start Program completed most of the Chromebook distribution last week. It was prioritized to the families with the highest need and didn't have accessible equipment to complete virtual instruction. Thanks to Maricopa County Leadership families can keep them and utilize to connect to other resources, apply for jobs, and schedule COVID testing and medical appointments. Until now we have distributed around 200 laptops. We're still in the process of coordinating additional equipment delivery for families that don't have accessible transportation. This week we are distributing school supplies bag that include multiple materials that support learning at the home.

Head Start staff got the opportunity to get the COVID 19 vaccine. COVID cases continue to rise and our program will continue to offer virtual services until the end of March. We understand the hardship this creates. We will review the local data at the beginning of March to determine if it's safe to resume in person services.

5. Lead Hazard Presentation, Shannon Gongora and David Underdonk

Lead base paint is extremely dangerous to young children under age 6 and pregnant women. It's commonly found in homes built before 1978. Maricopa County Human Services Department provides a no cost lead-based paint program to create safer and healthier homes for low income households with children. The program is available for families that live in Guadalupe, Gila Bend, Tolleson and Youngtown.
