CRIMINAL JUSTICE SYSTEM Monthly Changes – January 2015

Adult Jail Incarceration

- **Bookings increased** from 7,775 in December to 8,482 in January.
- **Releases decreased** from 8,160 in December to 8,108 in January.
- The **Average Daily Population (ADP) increased** from 7,535 in December to 7,664 in January.
- The **Pretrial ADP increased** from 5,772 in December to 5,904 in January.
- The **Sentenced ADP increased** from 1,538 in December to 1,539 in January.
- The **Agency Hold ADP increased** from 184 in December to 185 in January.
- **Overall Average Length of Stay (ALOS) at release decreased** from 29.7 in December to 28.4 in January.
- The **ALOS in days for Pretrial increased** from 9.2 in December to 9.3 in January.
- The **ALOS in days for Sentenced decreased** from 25.1 in December to 24.6 in January.
- The **ALOS in days for Agency Holds maintained** at 77 from December to January.

Superior Court Filings & Case Processing

- **New Criminal Case Filings increased** from 2,562 in December to 2,765 in January.
- **Case Terminations increased** from 2,496 in December to 2,615 in January.
- The resulting **Clearance Rate** was 95%.
- The **Active Pending Case Inventory decreased** from 11,642 in December to 11,421 in January.
- **Regional Court Center filings decreased** from 1,391 in December to 1,383 in January.
- **Early Disposition Court filings increased** from 836 in December to 1,125 in January.
- The **Number of Trials Completed increased** from 42 in December to 47 in January.
- The **Trial Rate** was 1.7%.

Justice Court Filings

- **DUI Filings decreased** from 945 in December to 739 in January.
- All other **Criminal Traffic Filings decreased** from 3,541 in December to 3,055 in January.
- **Civil Traffic Filings decreased** from 9,942 in December to 9,675 in January.
- **Eviction Action Filings increased** from 5,190 in December to 5,515 in January.
- **Total Filings decreased** from 27,063 in December to 26,563 in January.

Adult Probation

- **Pretrial Standard Supervision decreased** from 1,955 in December to 1,888 in January.
- **Pretrial Electronic Monitoring increased** from 641 in December to 658 in January.
- **Adult Standard Probation Supervision increased** from 22,552 in December to 22,700 in January.
- **Adult Intensive Probation Supervision increased** from 1,004 in December to 1,014 in January.
- **Adult Unsupervised Probation Supervision decreased** from 5,307 in December to 5,262 in January.

Juvenile Detention and Probation

- The **Average Daily Detention Population increased** from 163 in December to 165 in January.
- The **ALOS in juvenile detention increased** from 14.0 in December to 15.1 in January.
- **Juvenile Standard Probation increased** from 1,912 in December to 1,952 in January.
- **Juvenile Intensive Probation decreased** from 205 in December to 204 in January.
- **Monthly commitments to Arizona Department of Juvenile Corrections increased** from 17 in December to 22 in January.

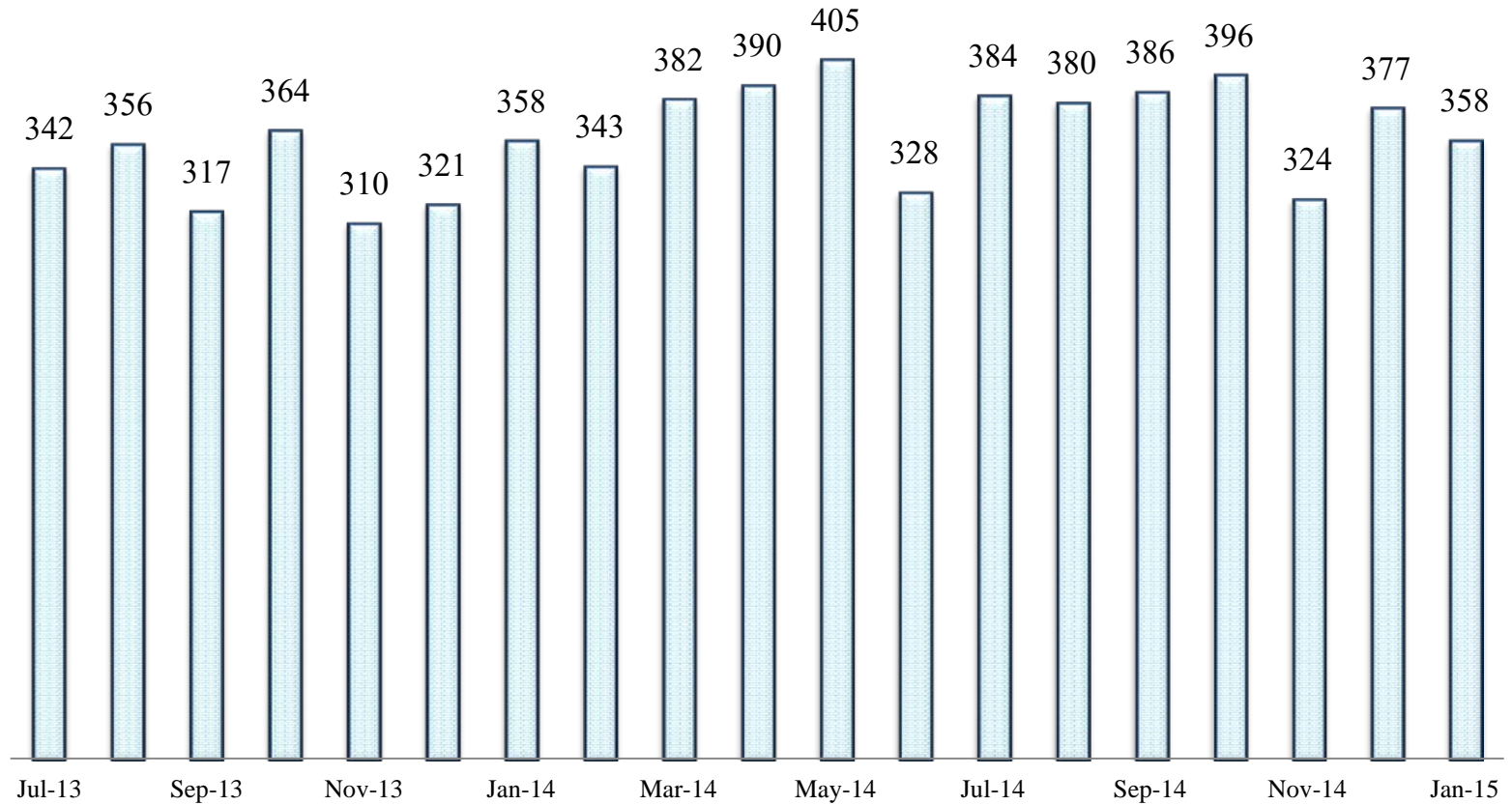

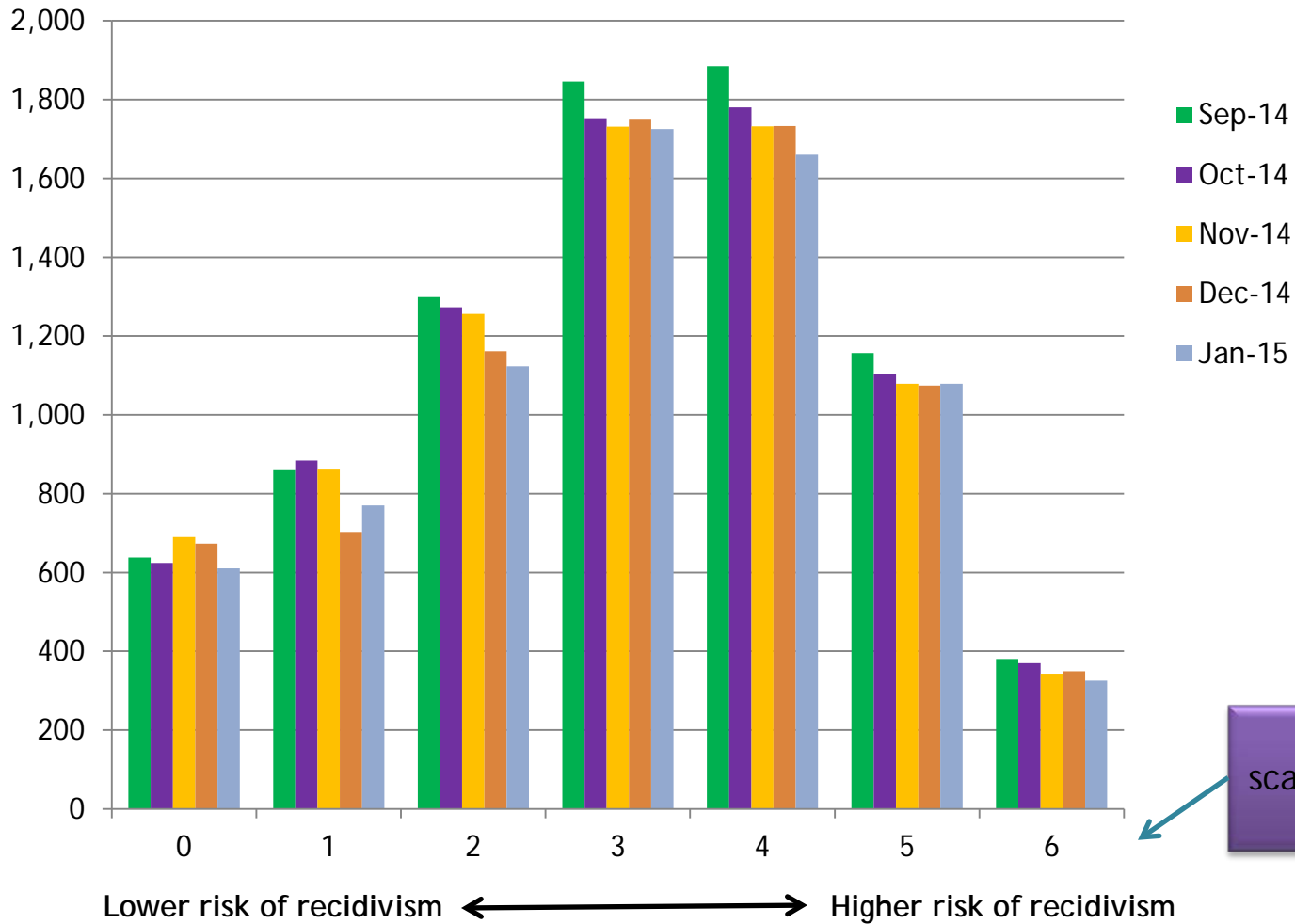

Number of Dependency Petitions Filed Juvenile Court



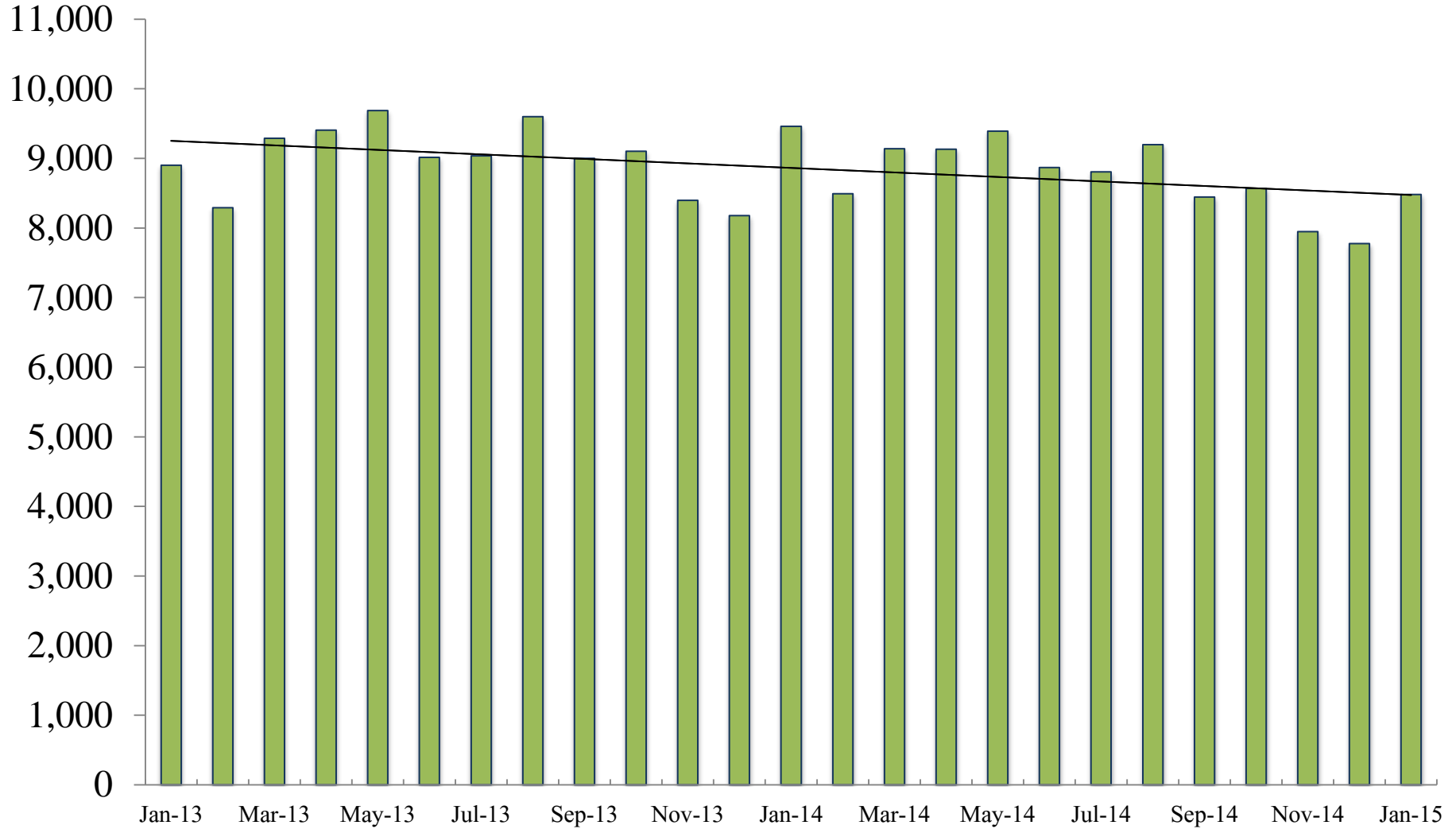

Recidivism Risk Score (RRS / "Proxy") Distribution Among Current Jail Population:

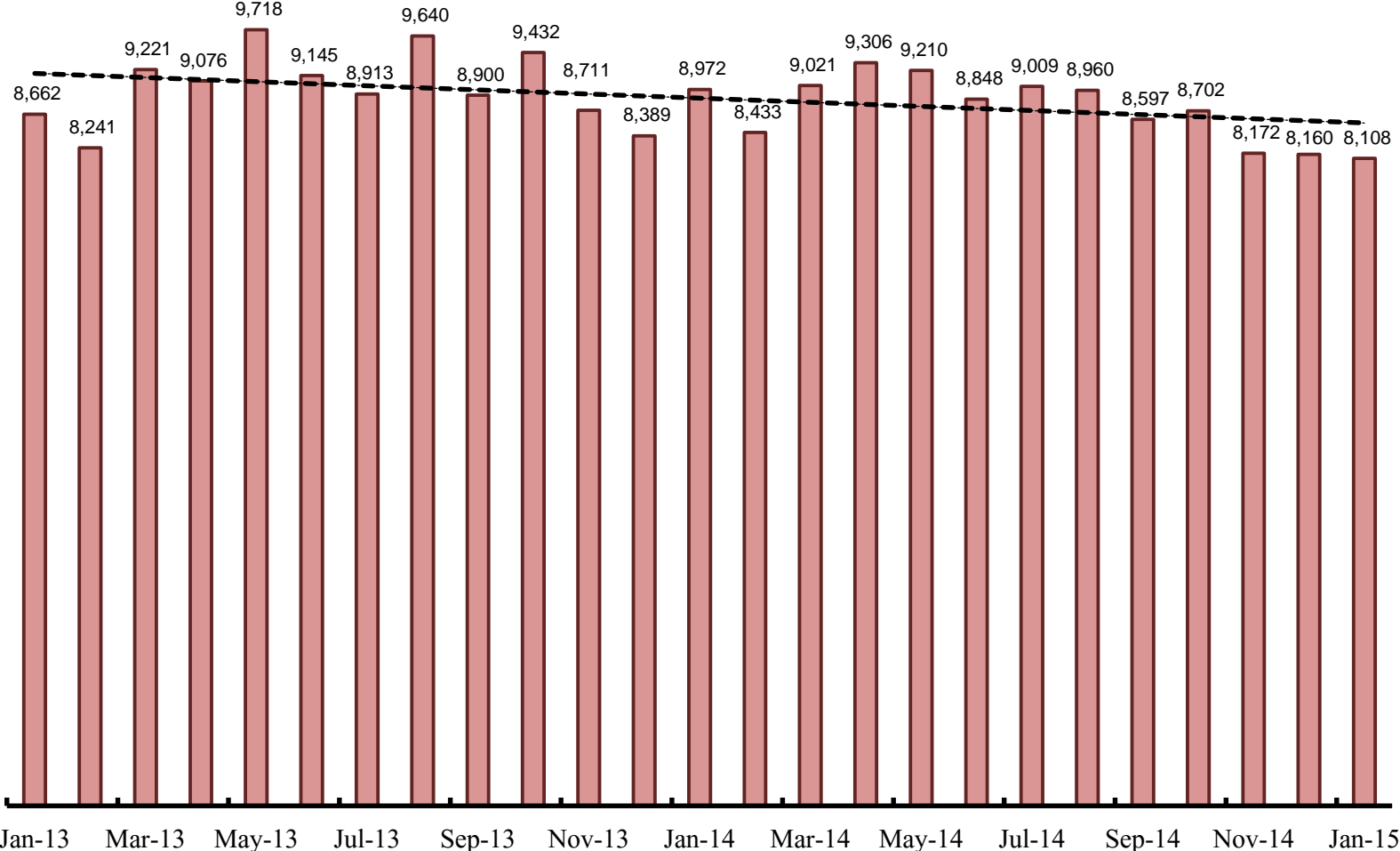

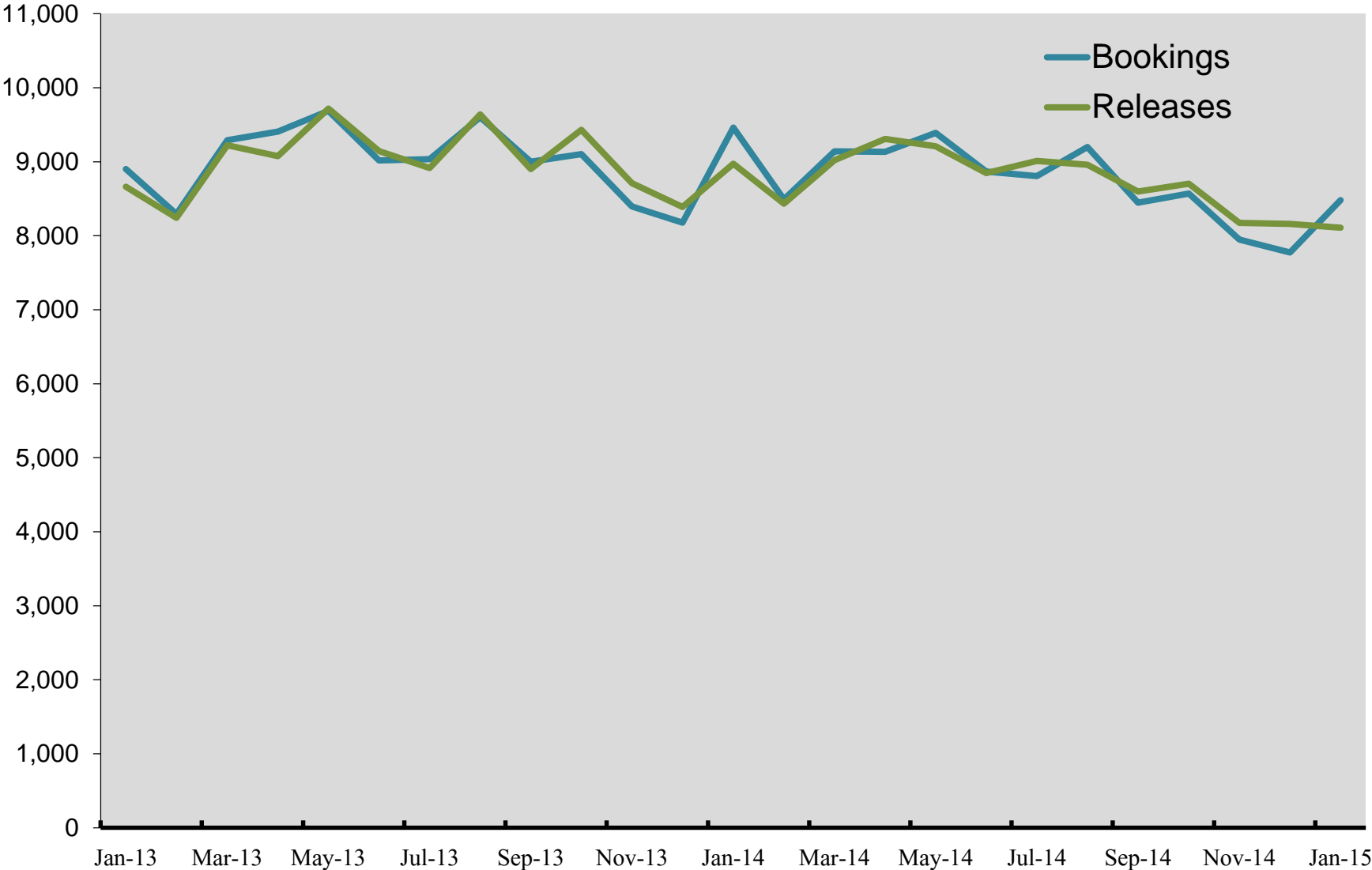

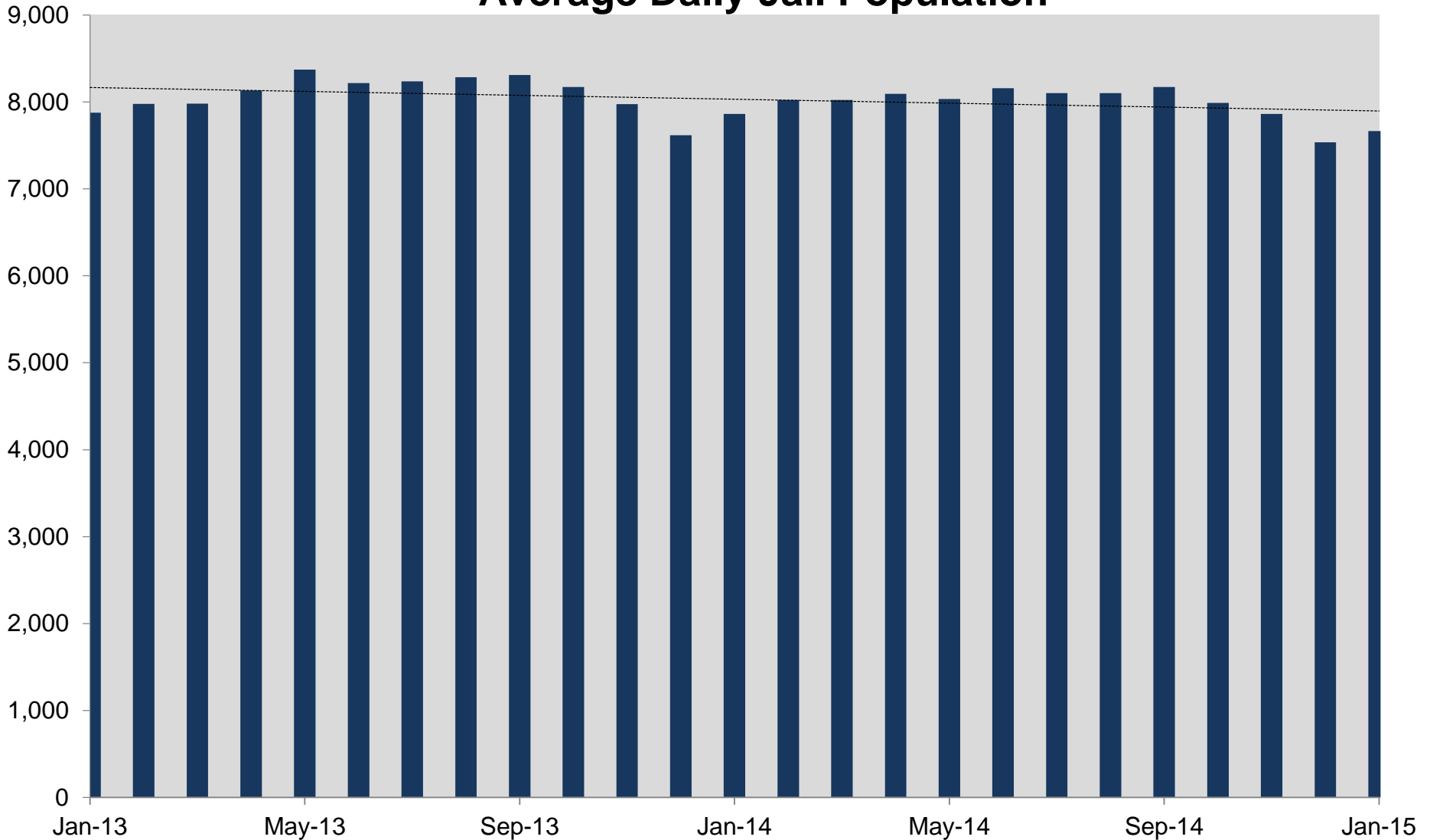

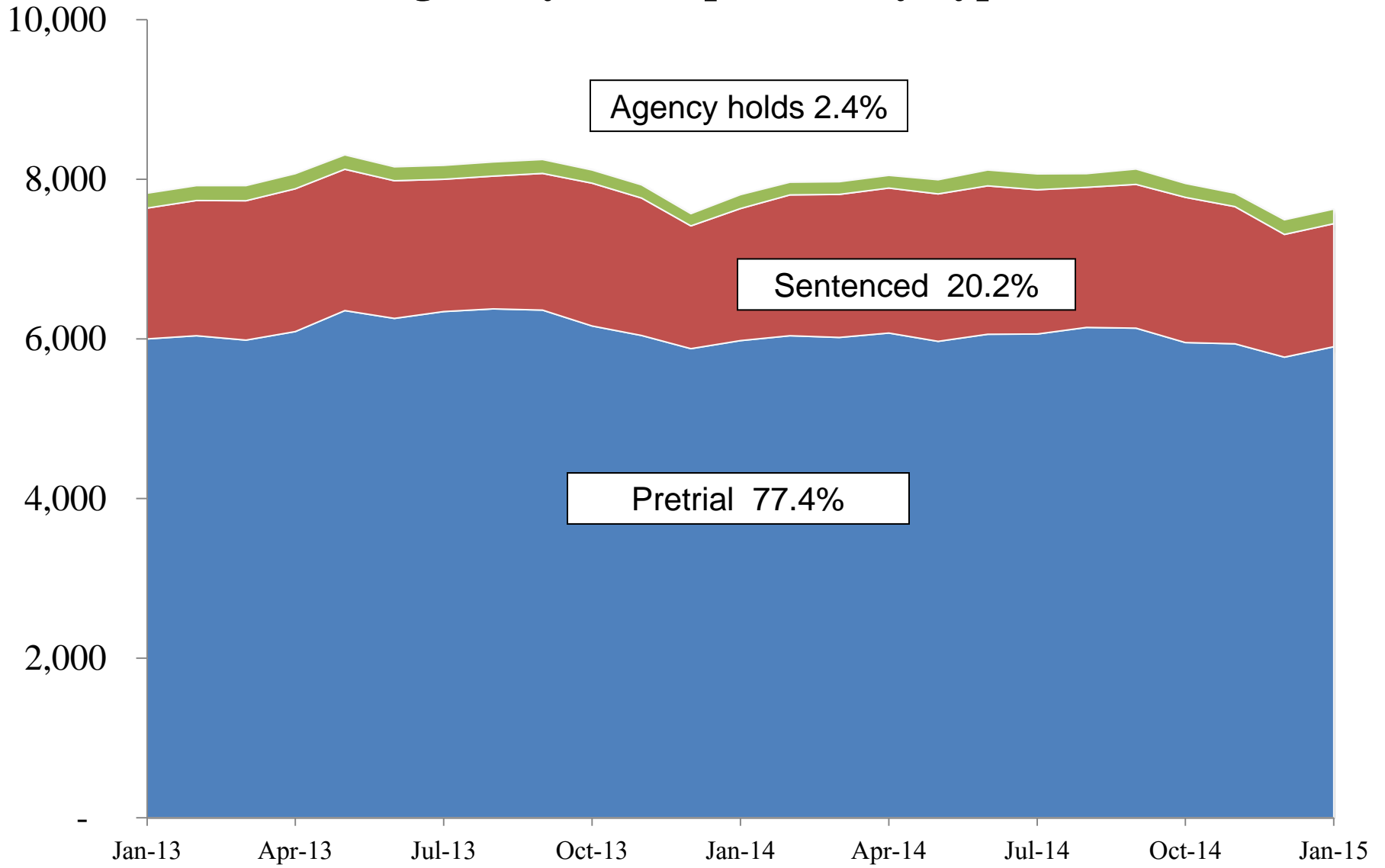


Average Daily Jail Population

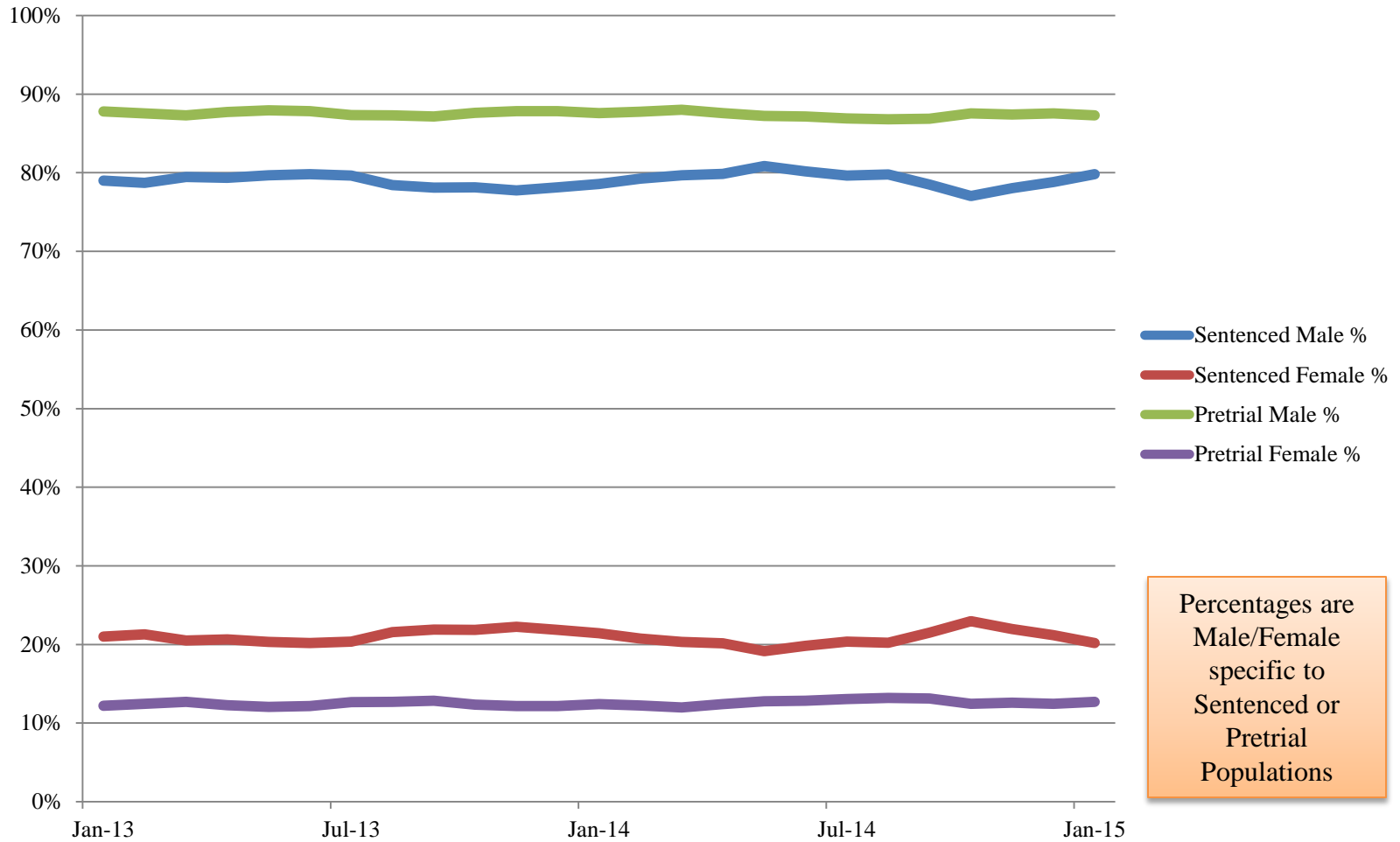

Average Daily Jail Population by Type

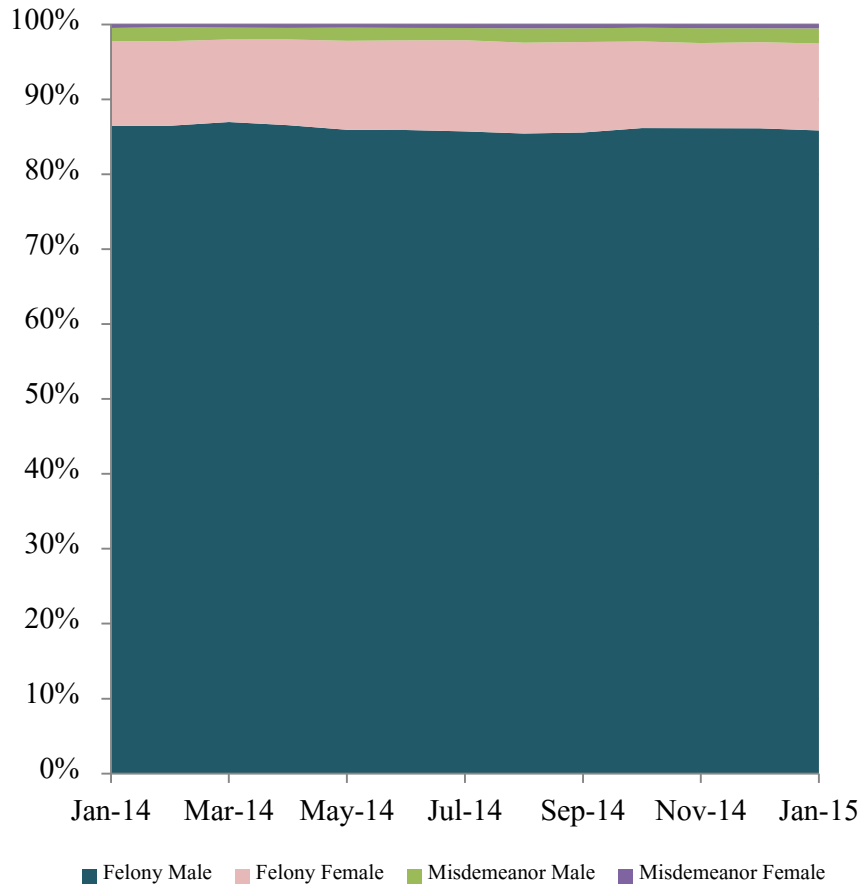


Average Daily Jail Population by Gender

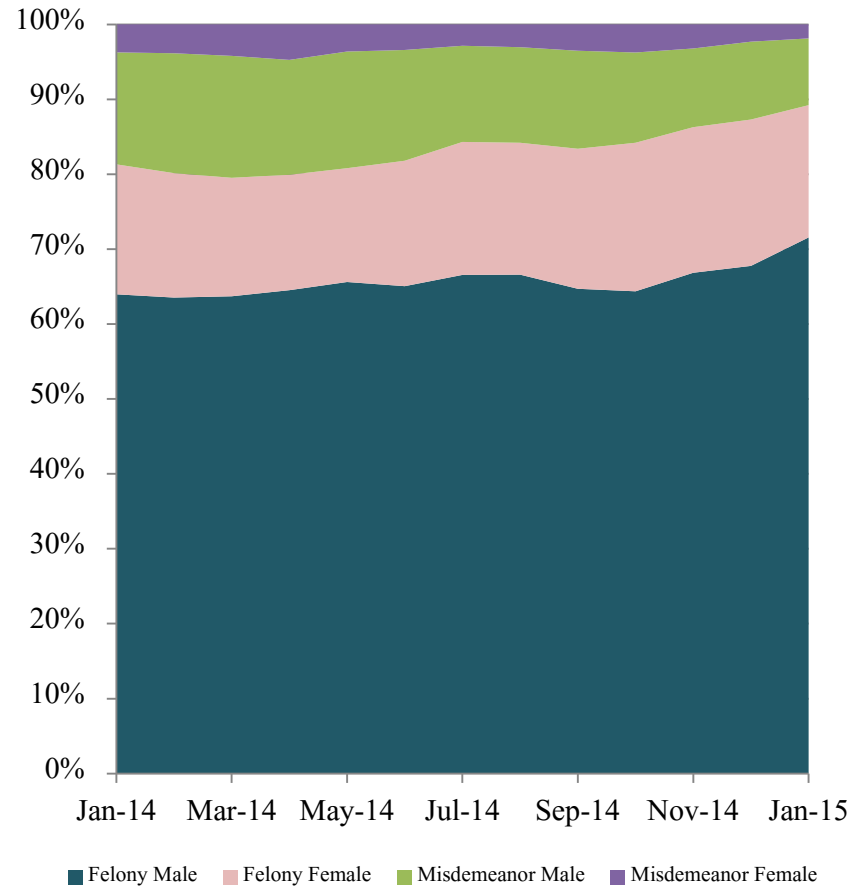


Average Daily Jail Population Charges by Gender within Specific Populations

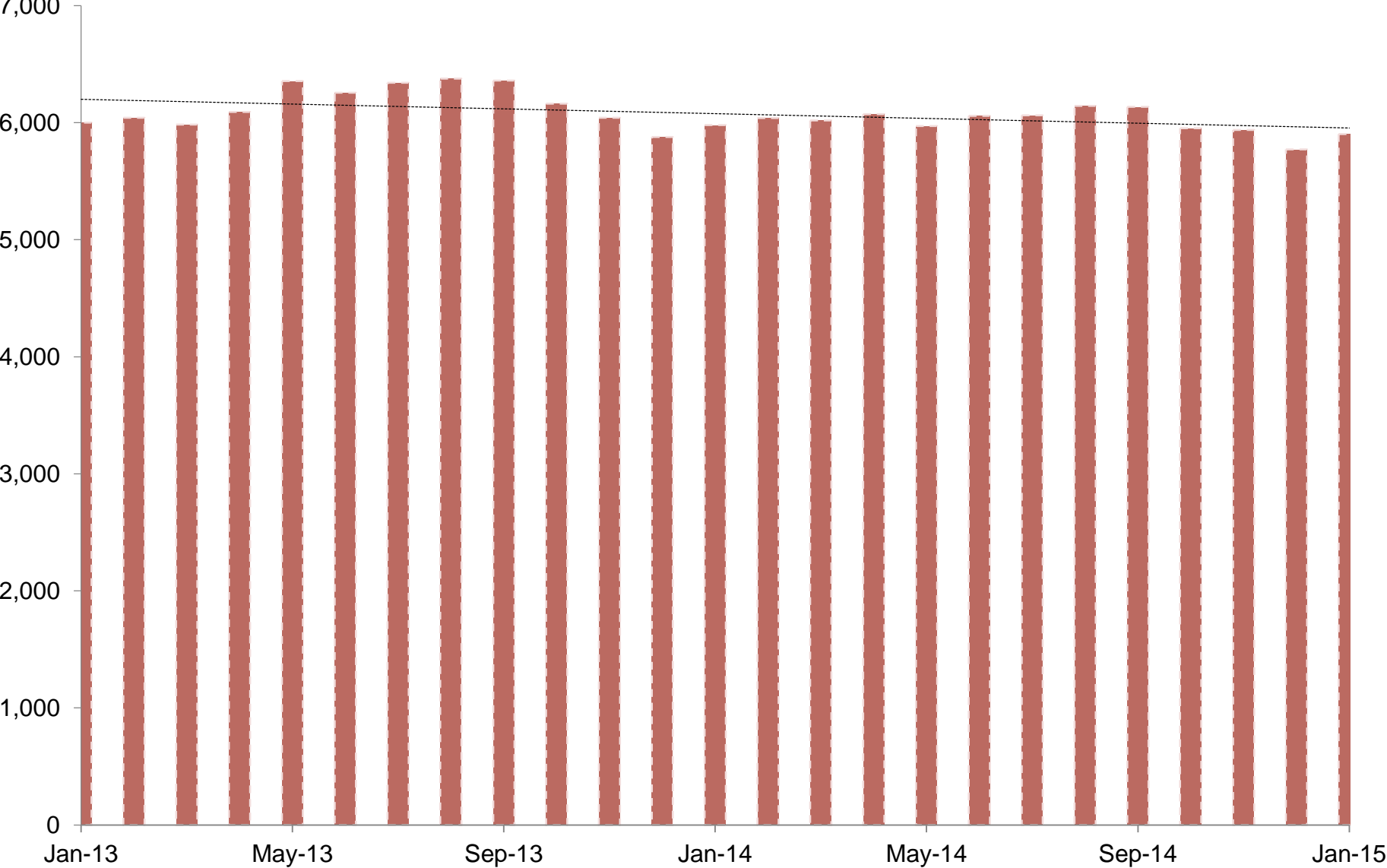
Pretrial Distribution



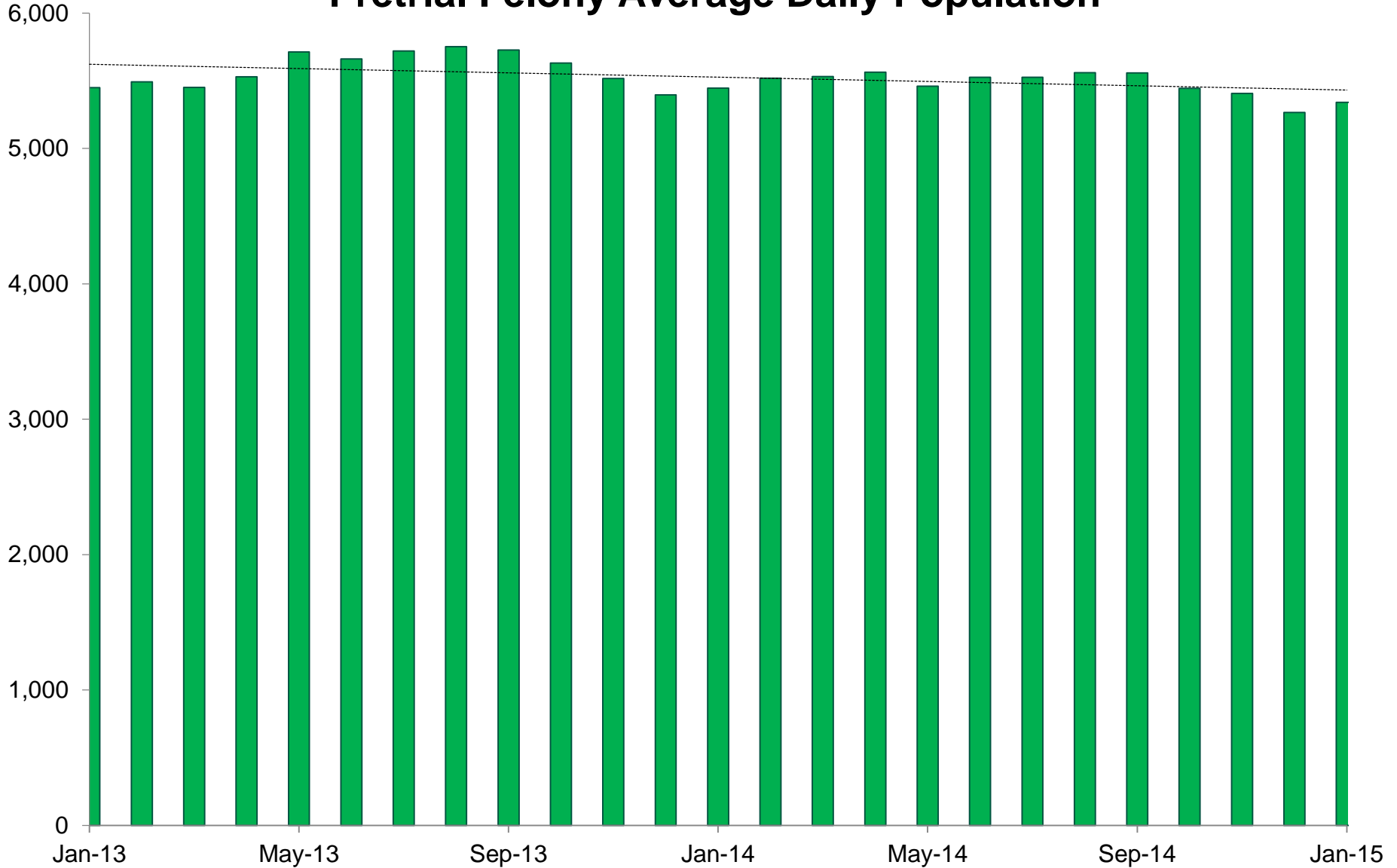
Sentenced Distribution



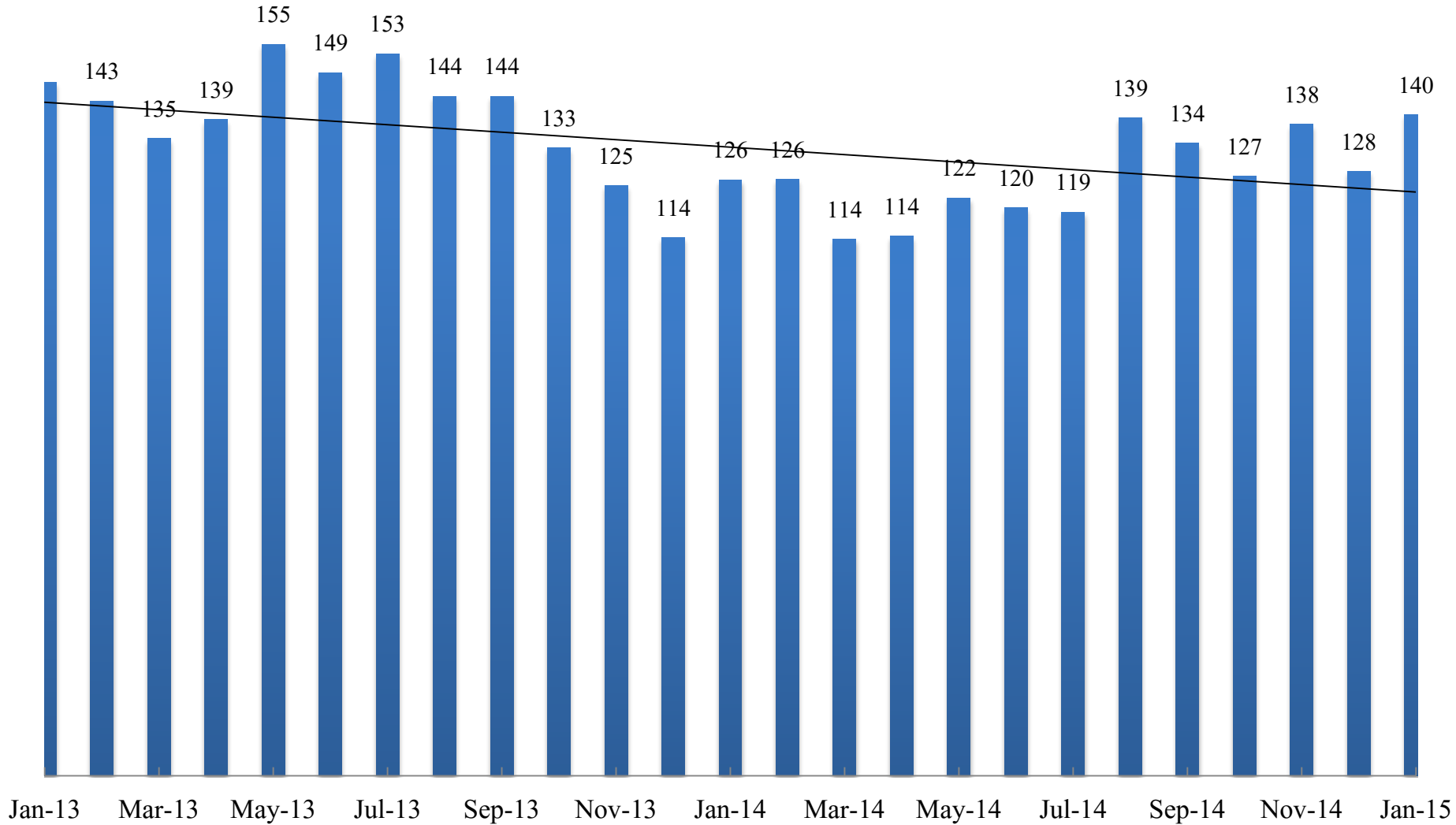
Pretrial Average Daily Population



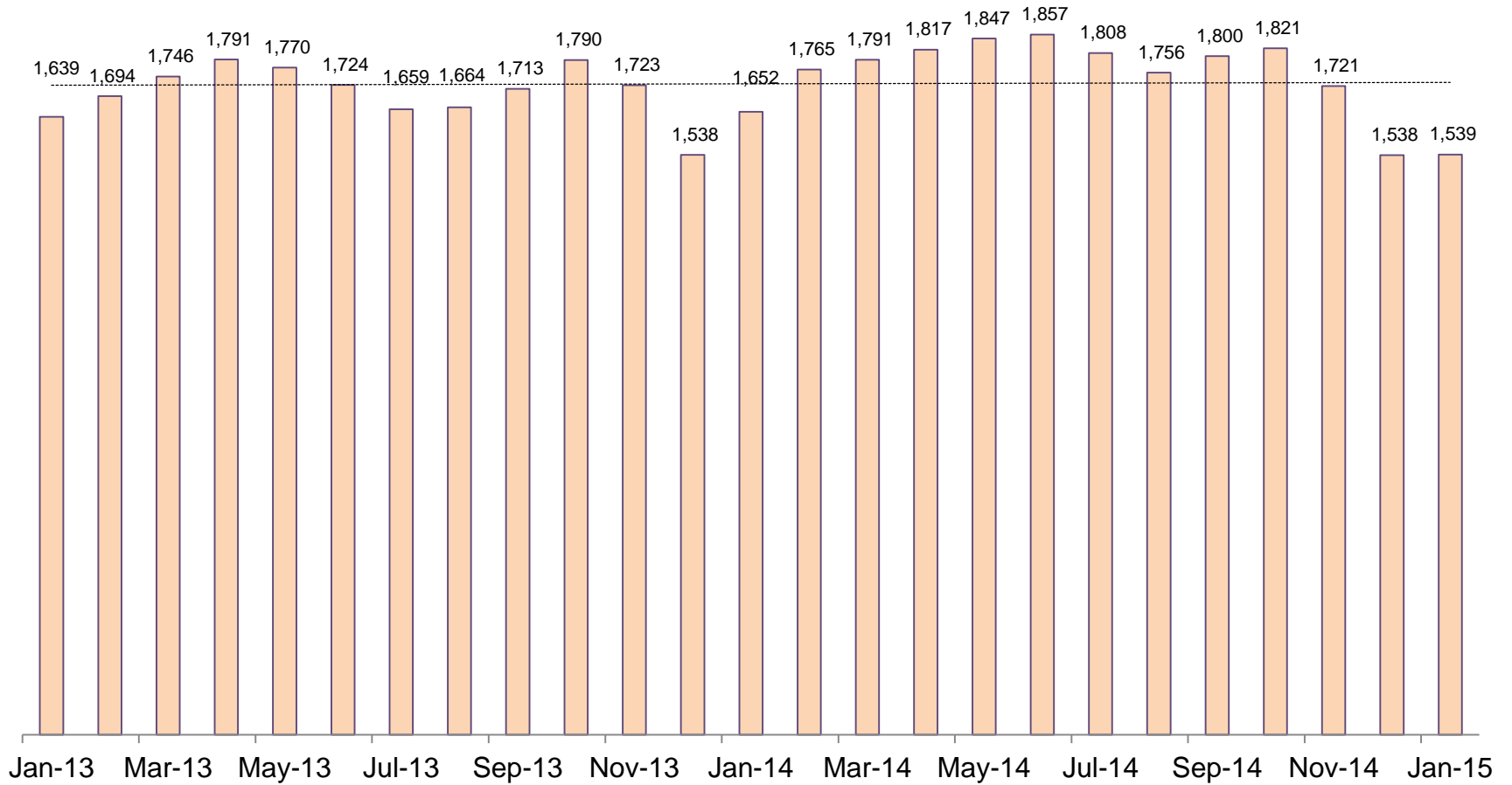
Pretrial Felony Average Daily Population



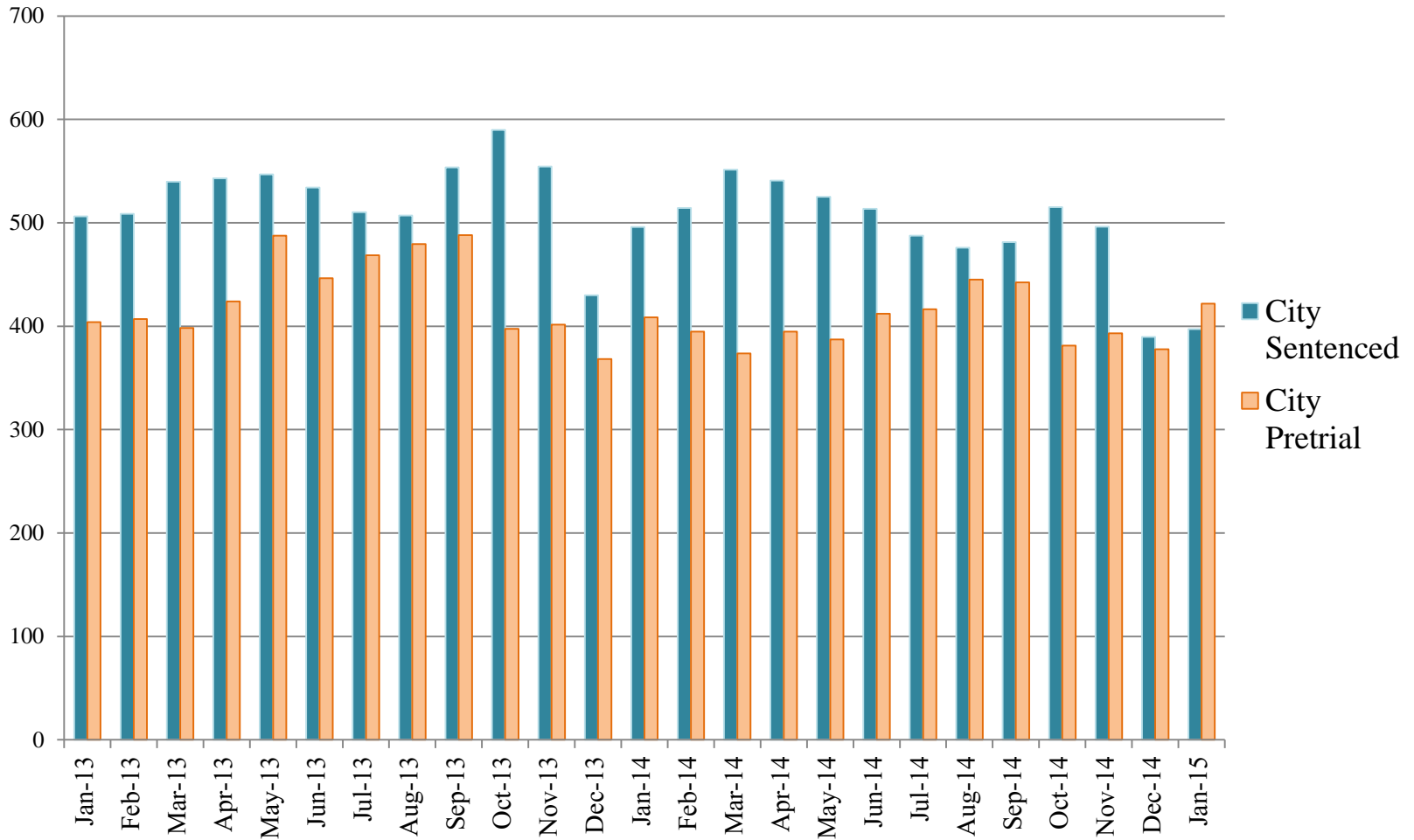
Pretrial Misdemeanor Average Daily Population



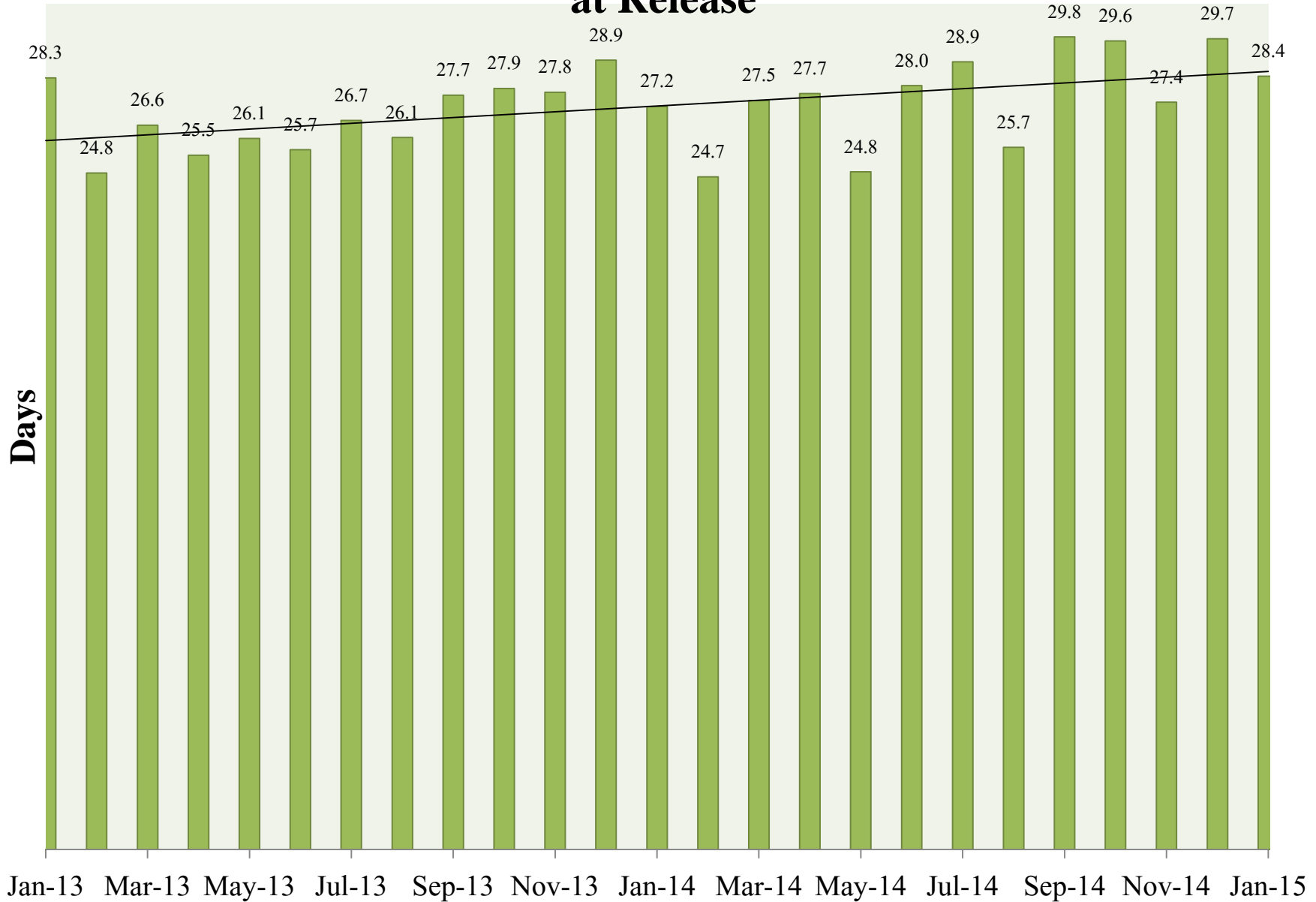
Sentenced Average Daily Population



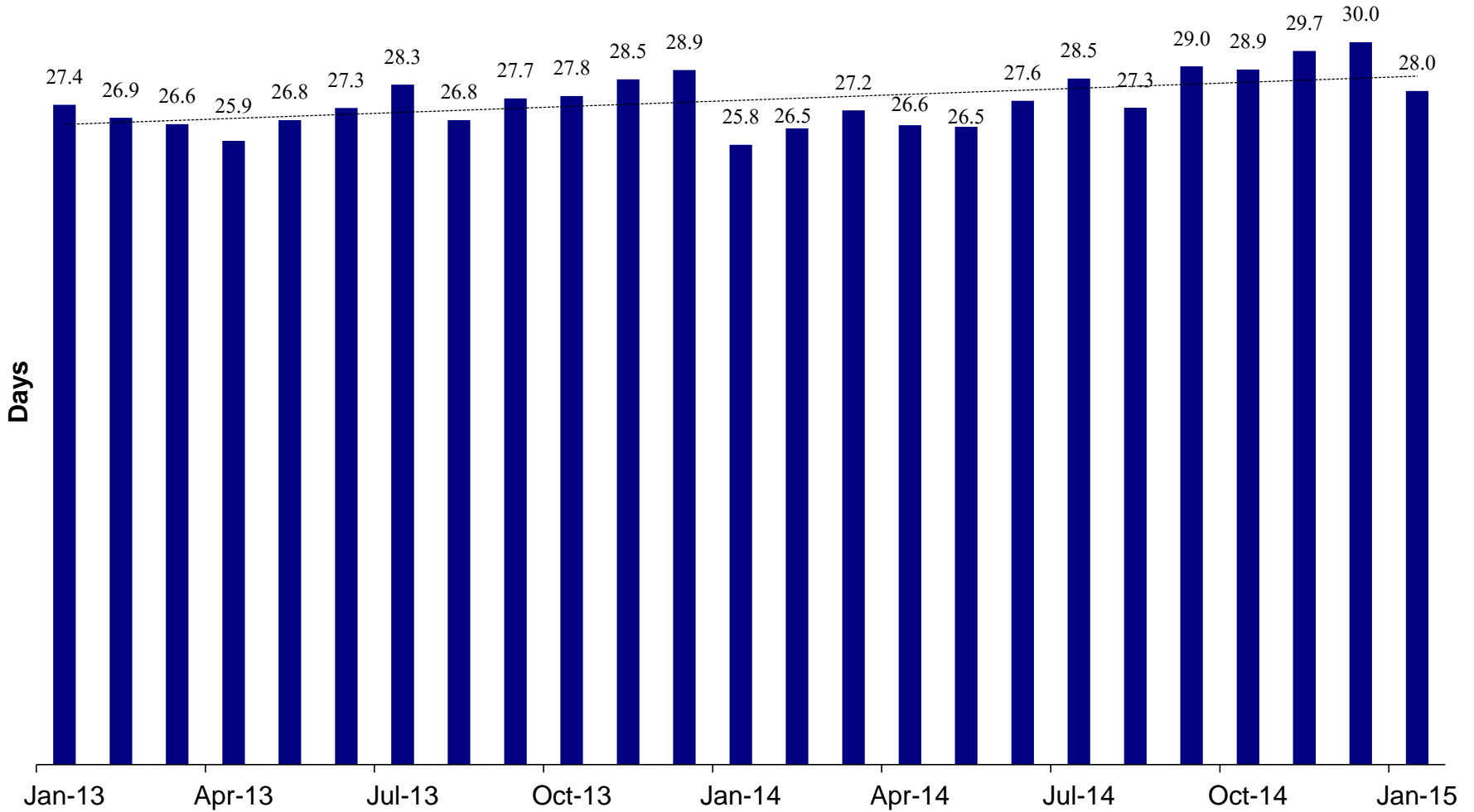
Average Daily Jail Population of City Offenders



Overall Average Length of Stay in Jail at Release

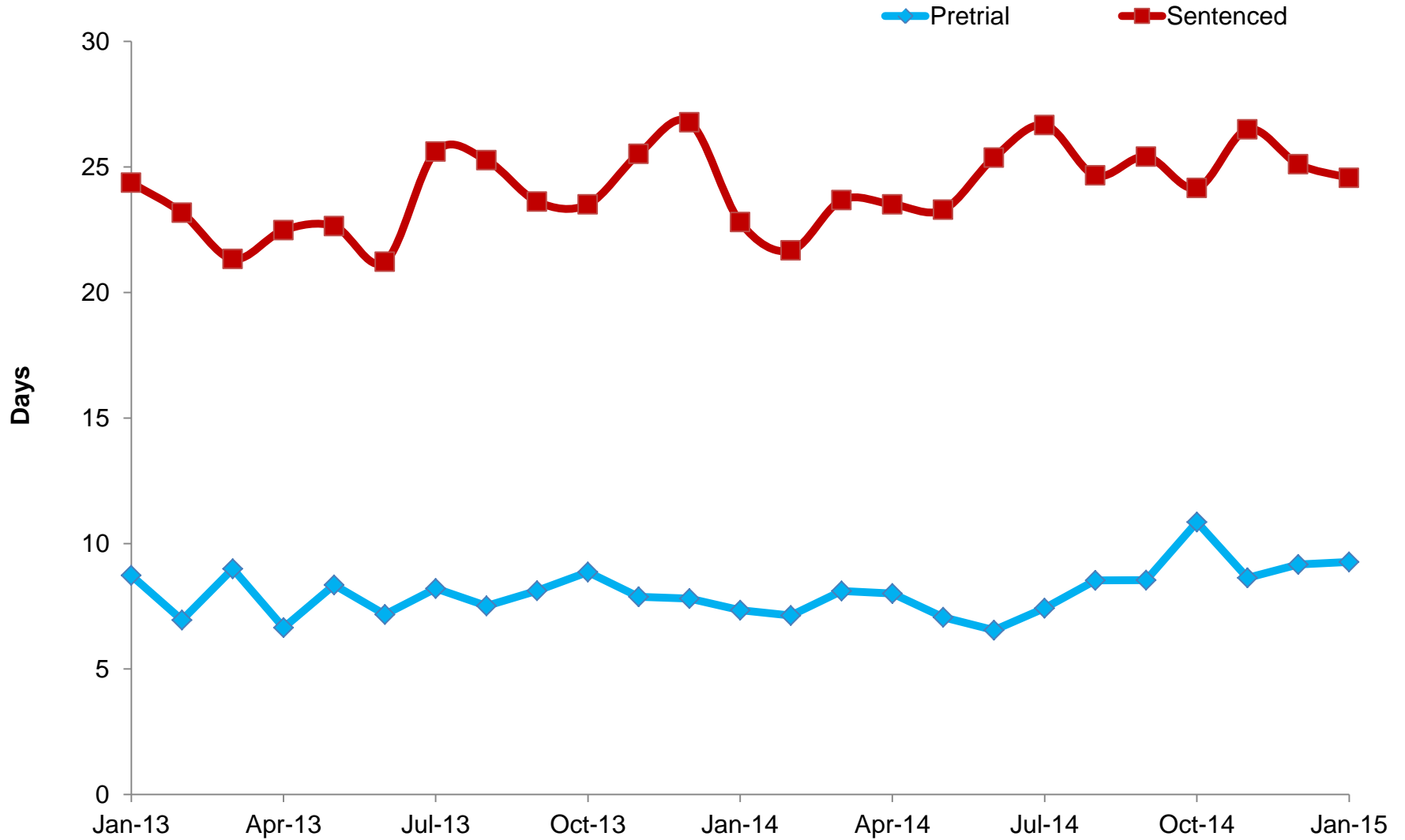


Overall Average Length of Stay in Jail In Custody*

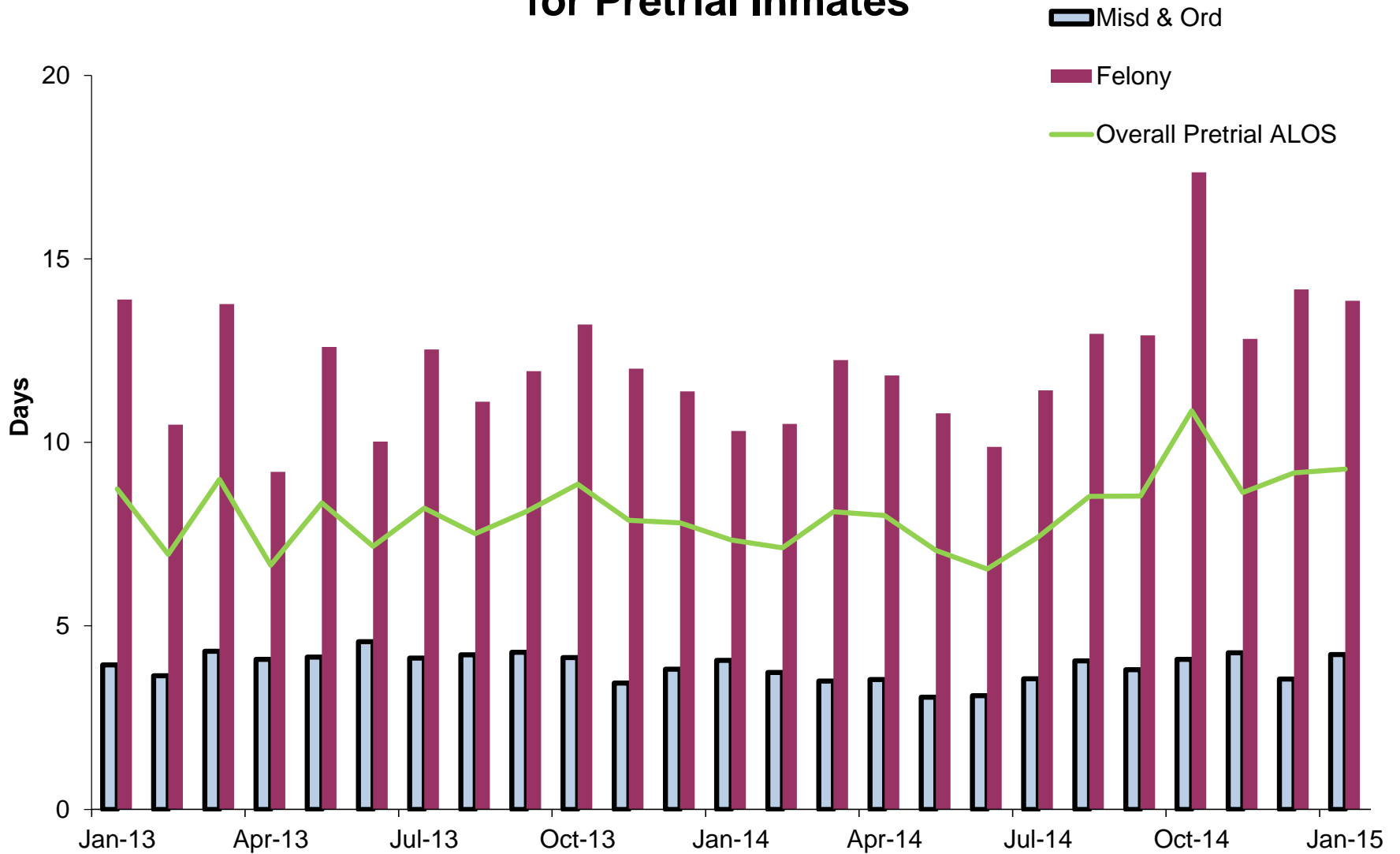

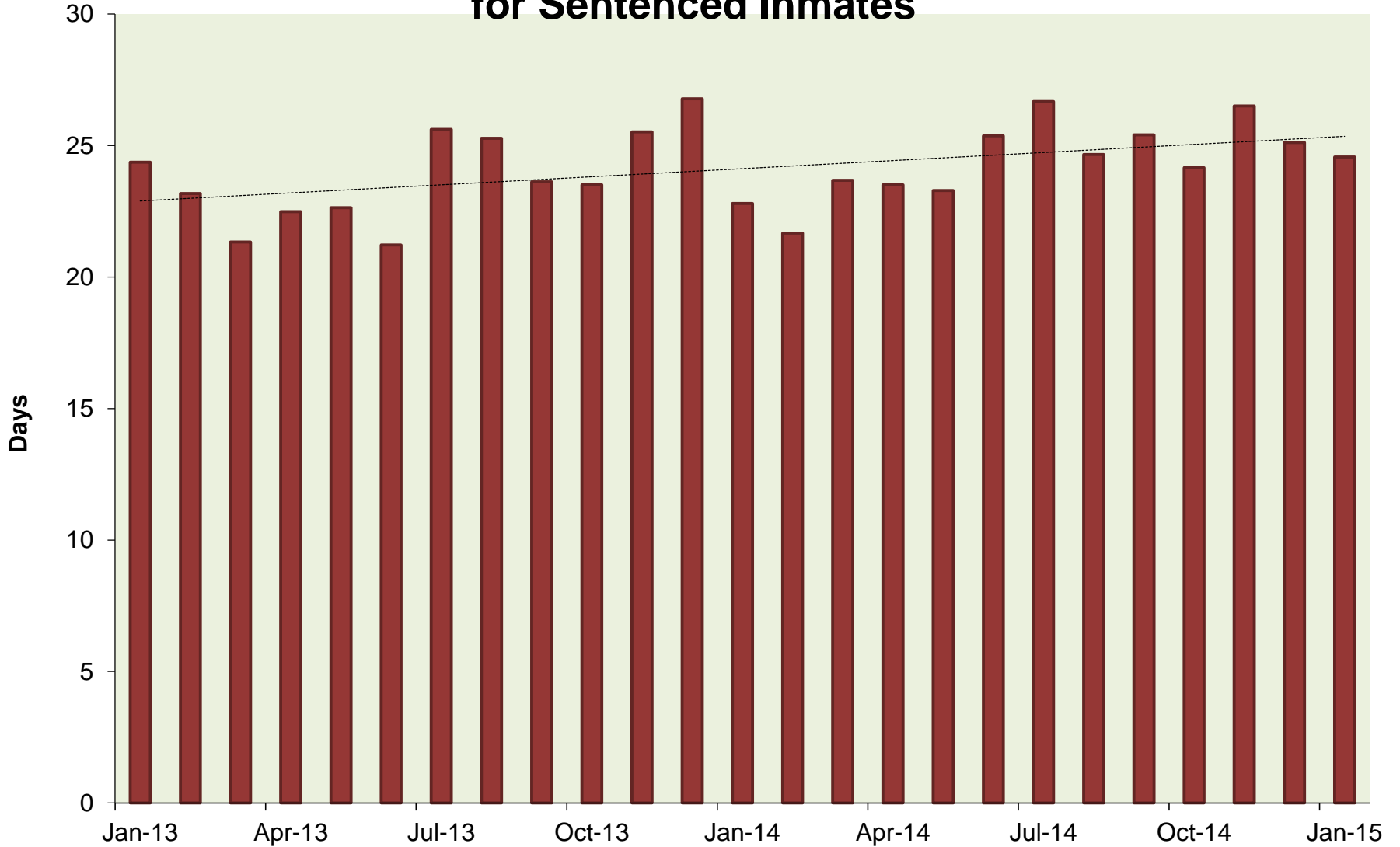
Average Length of Stay in Jail Pretrial and Sentenced Inmates



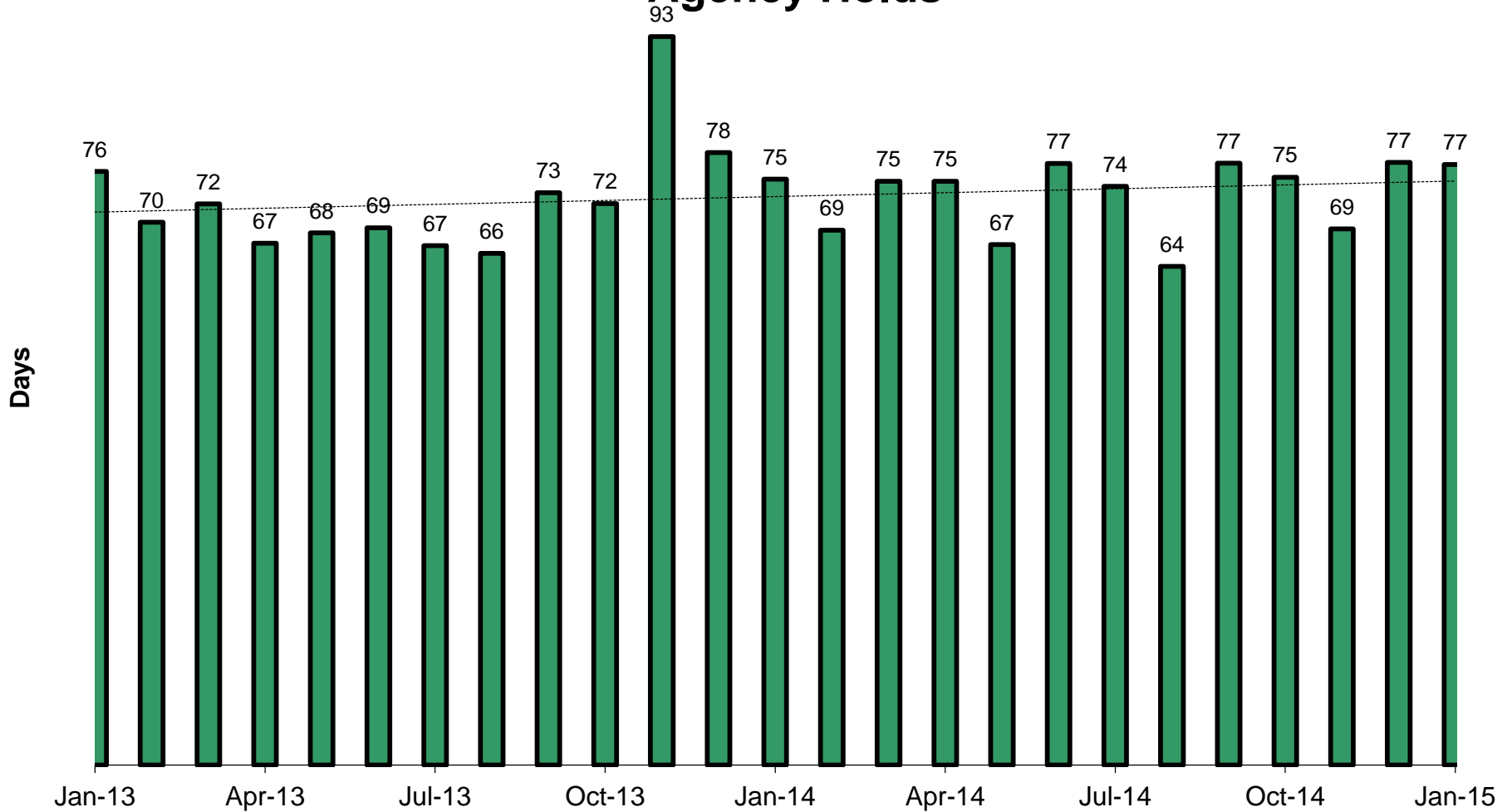
Average Length of Stay in Jail for Pretrial Inmates



Average Length of Stay in Jail for Sentenced Inmates

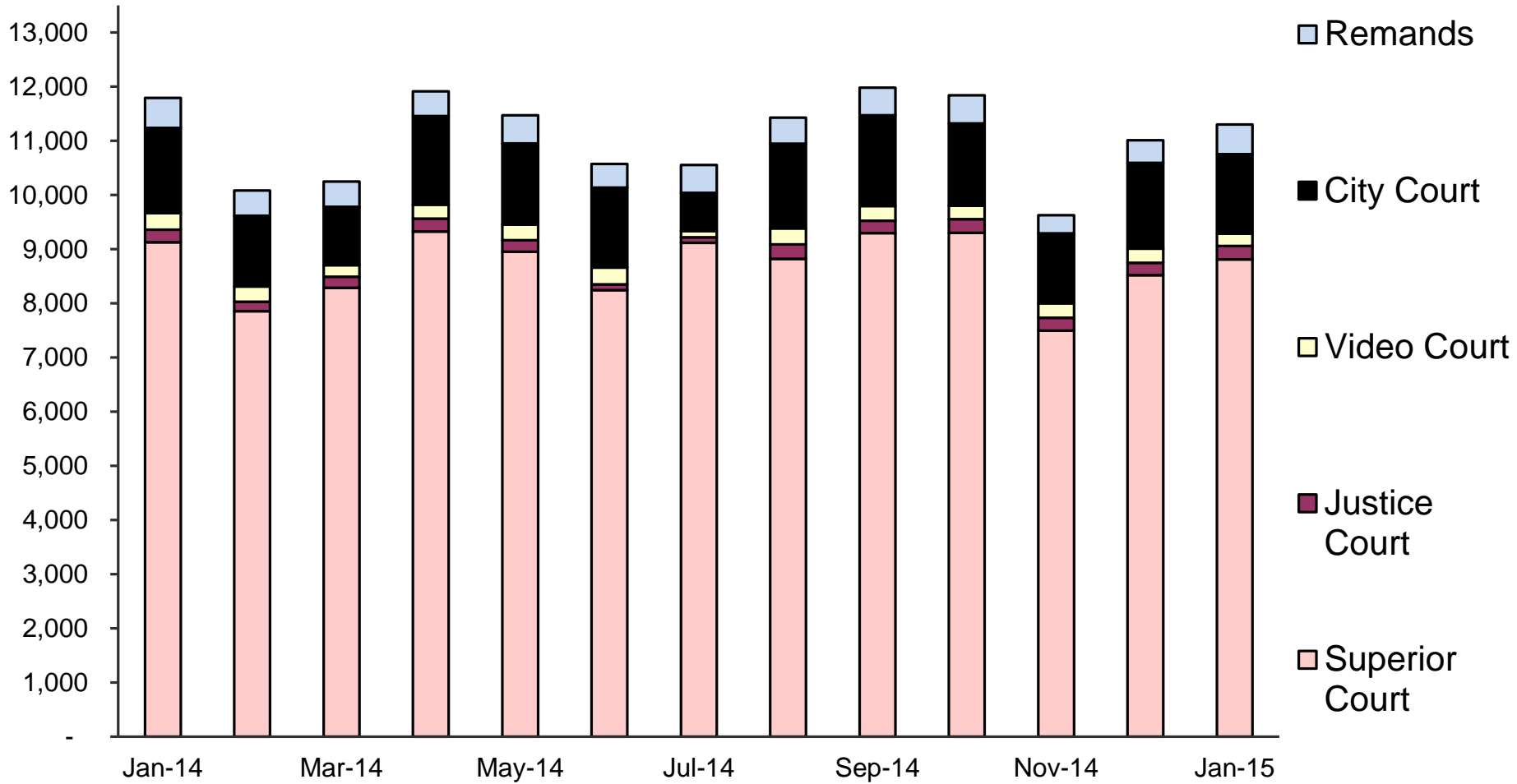


Average Length of Stay in Jail Agency Holds



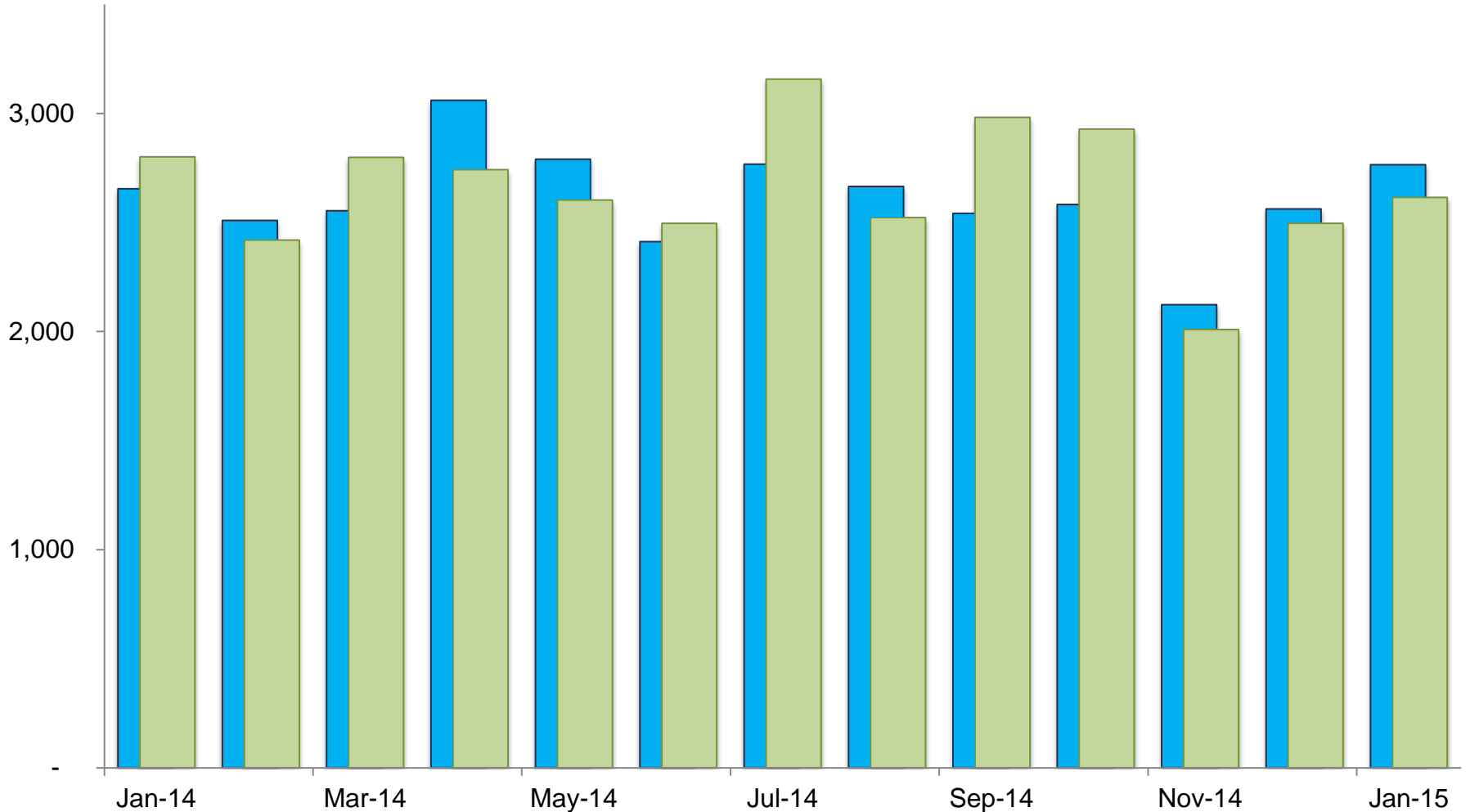

Sheriff's Office Transports for Inmate Court Appearances



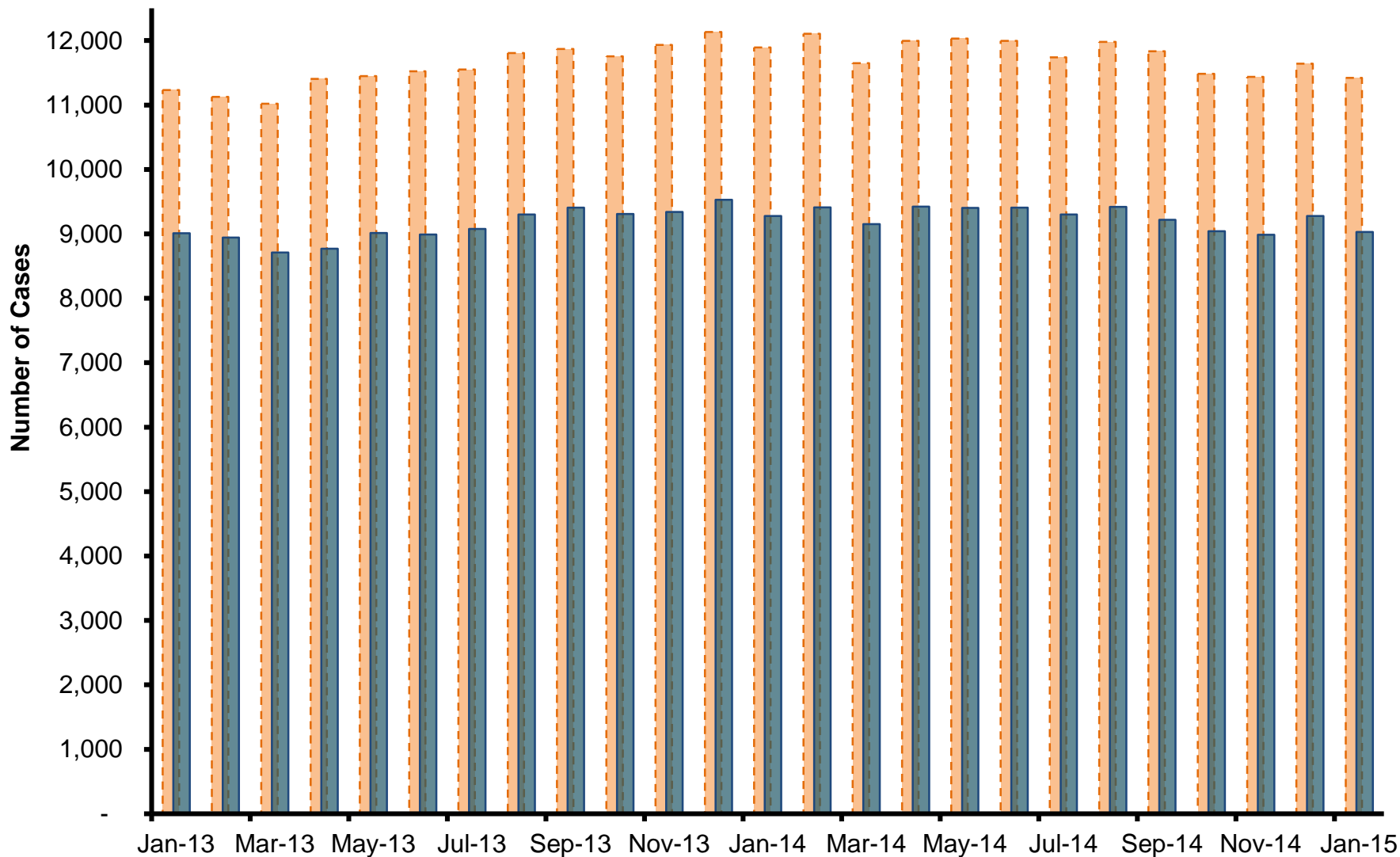
Superior Court Criminal Case Filings and Terminations

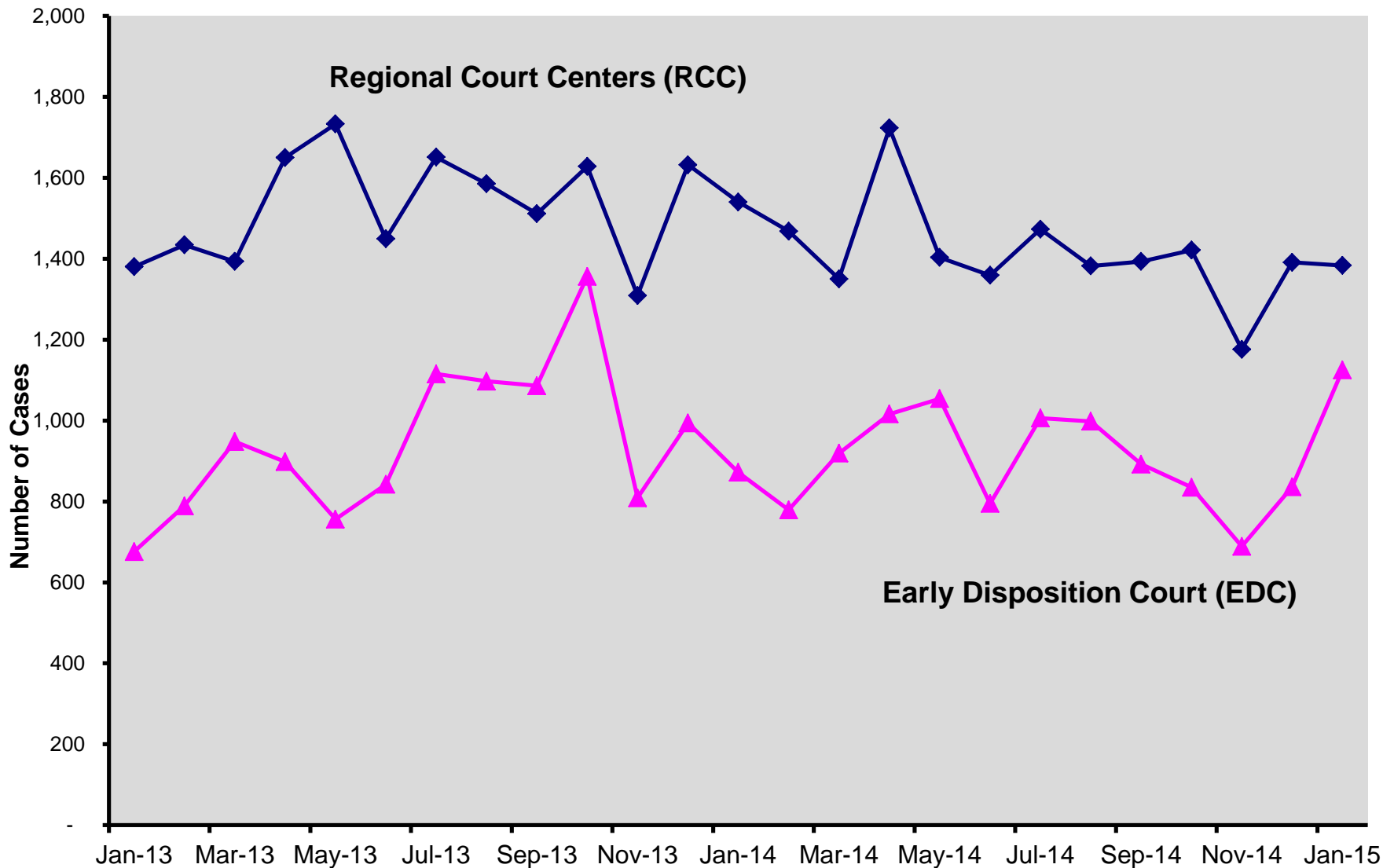


Active Pending Criminal Case Inventory

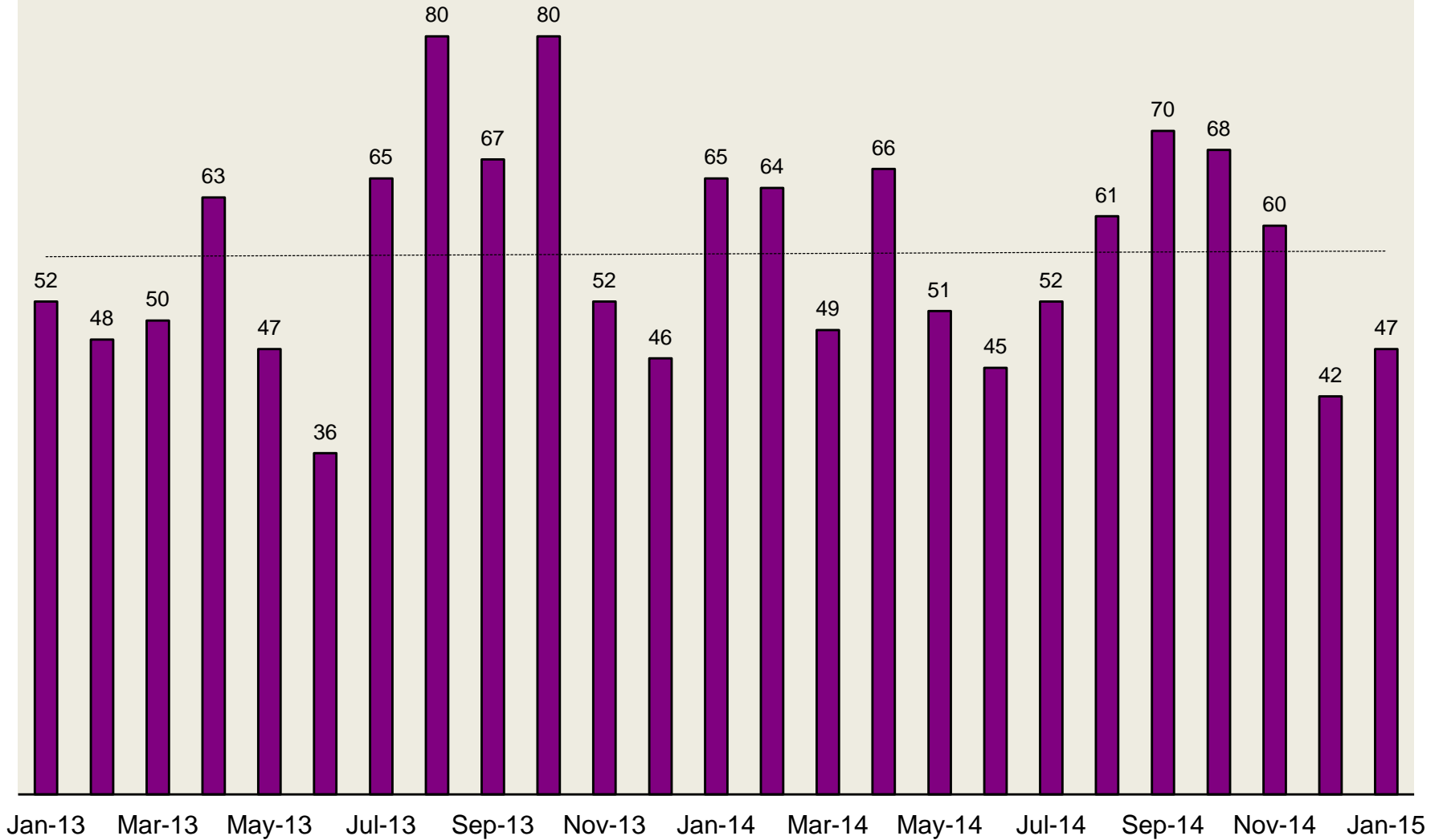

Superior Court Trials Completed

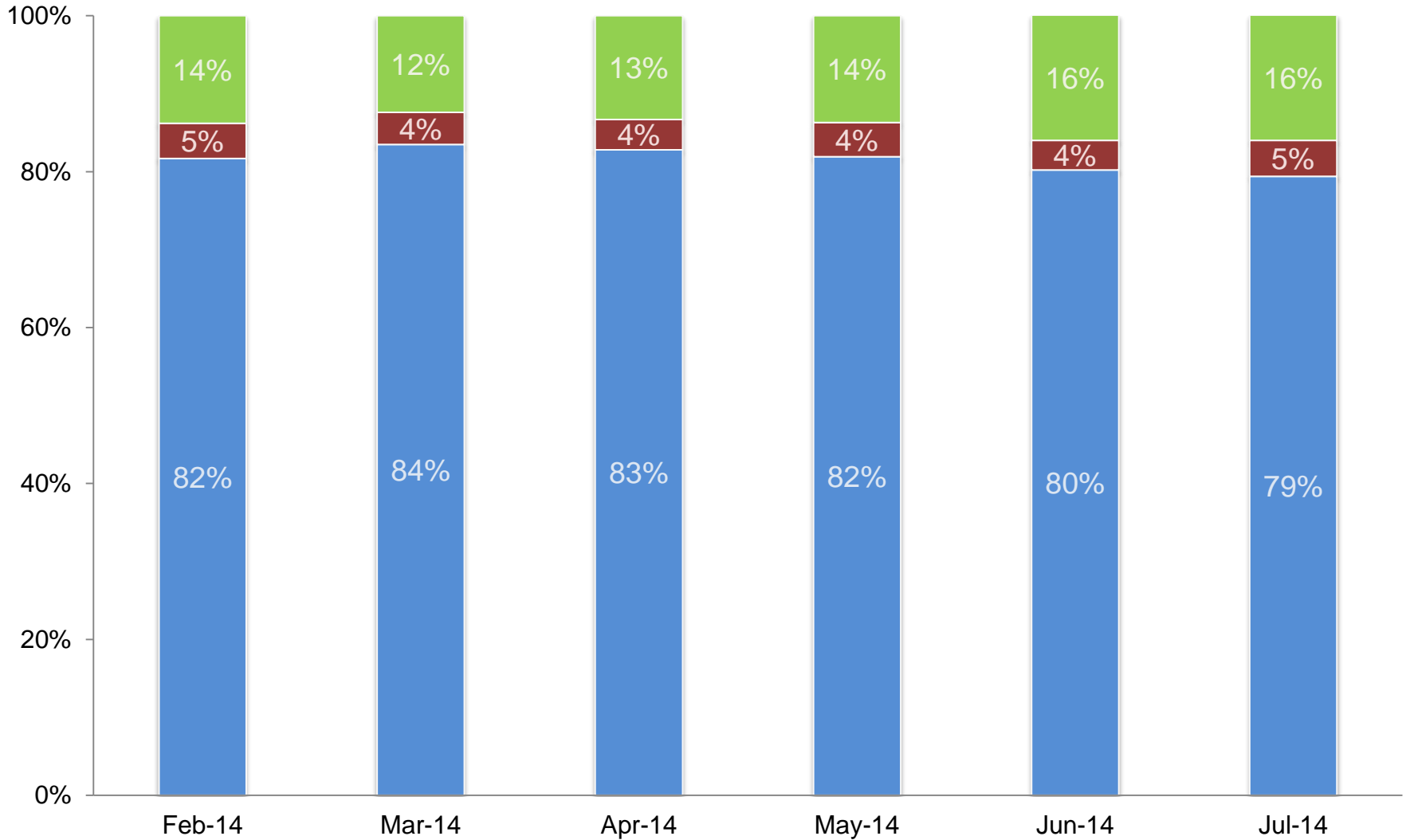


Status of Cases After 180 Days

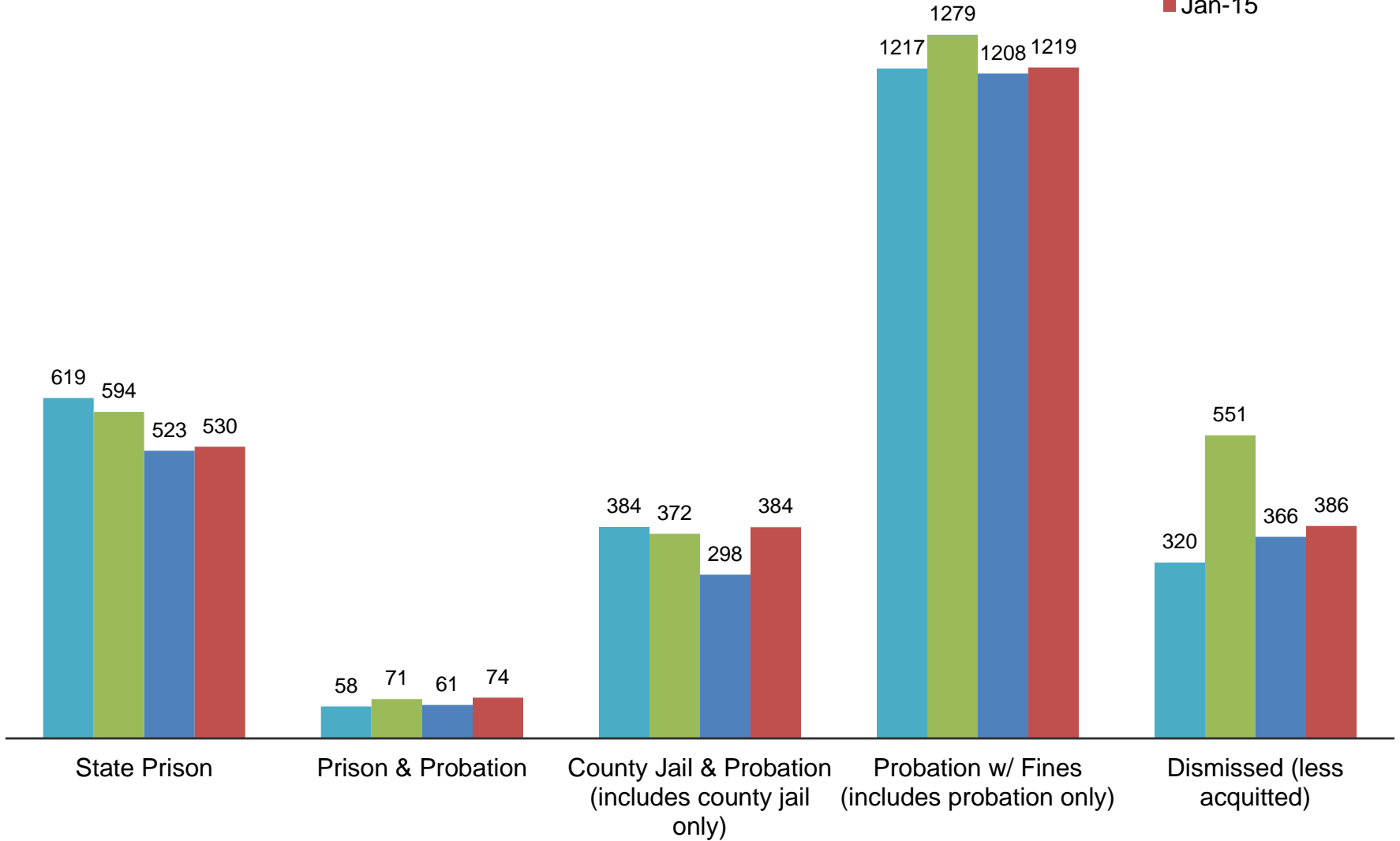

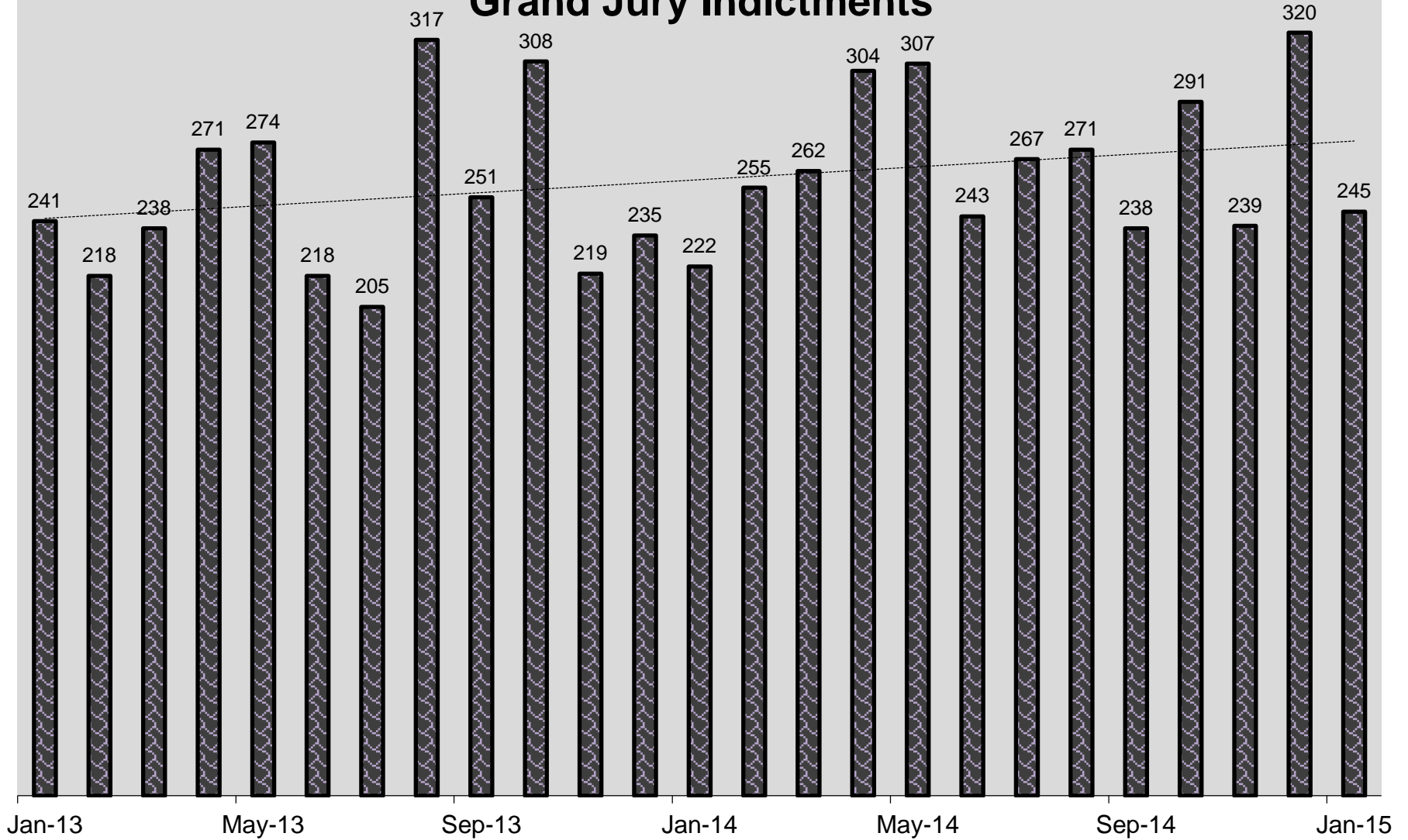
Disposition of Cases Terminated

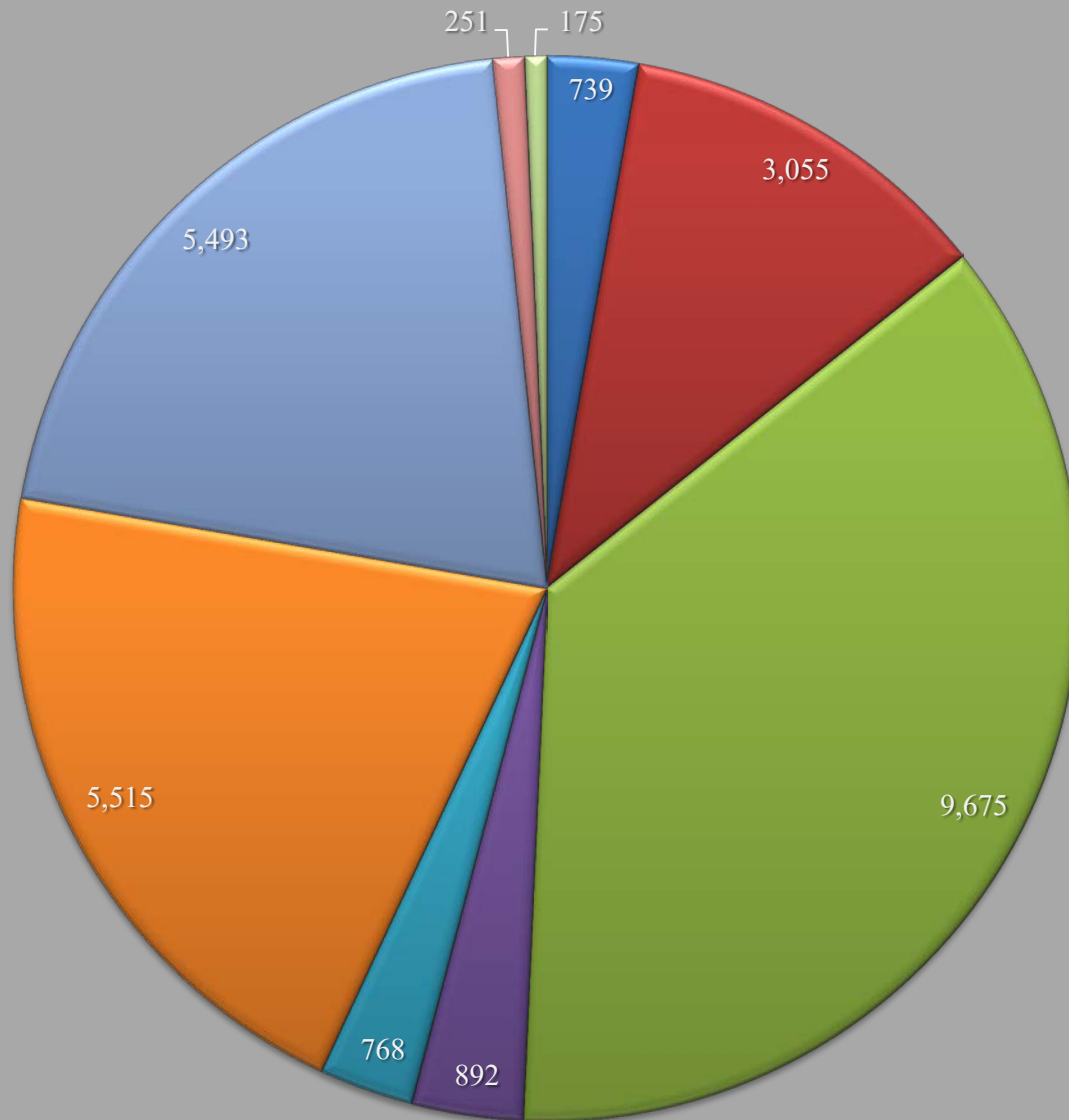


Grand Jury Indictments

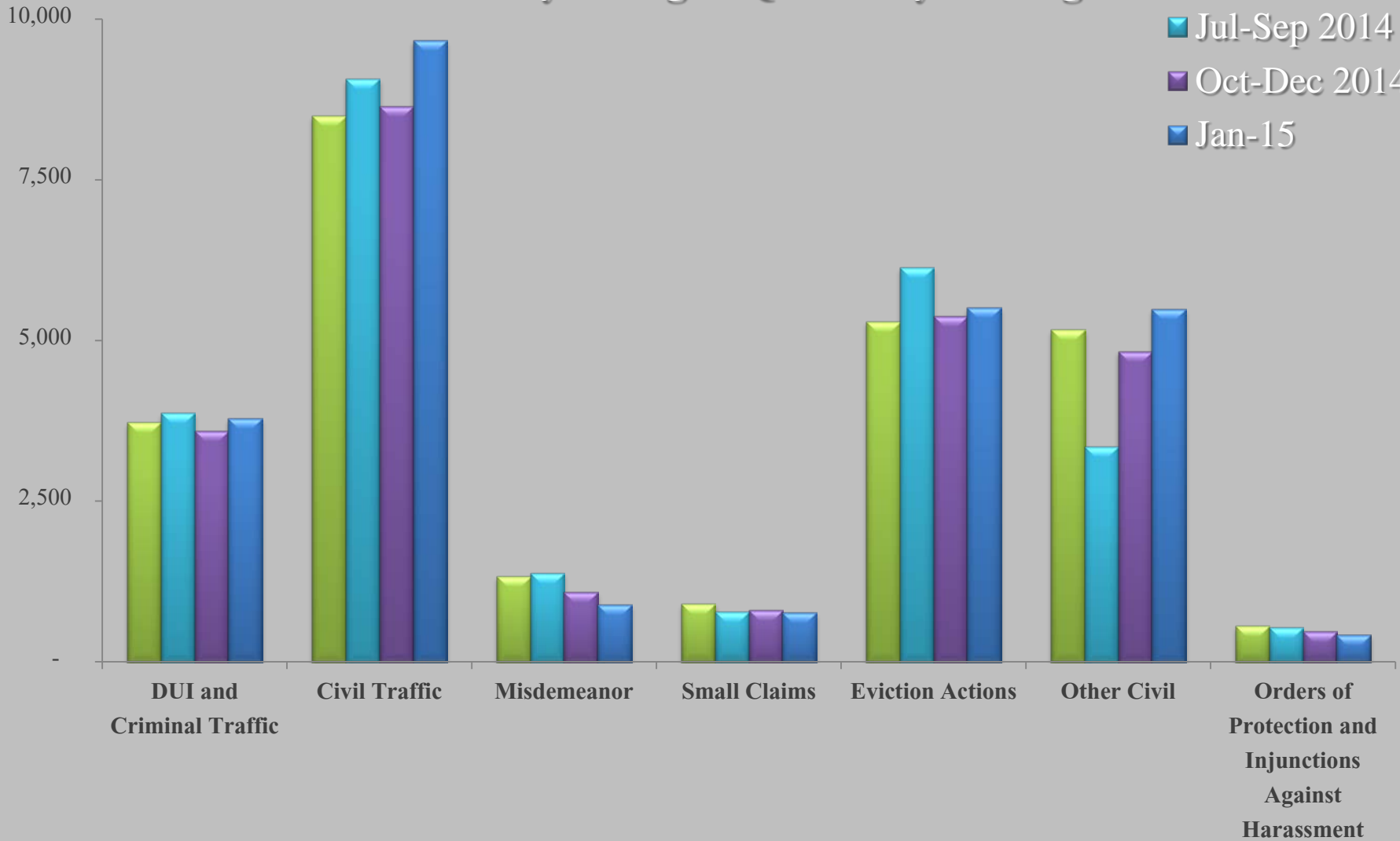

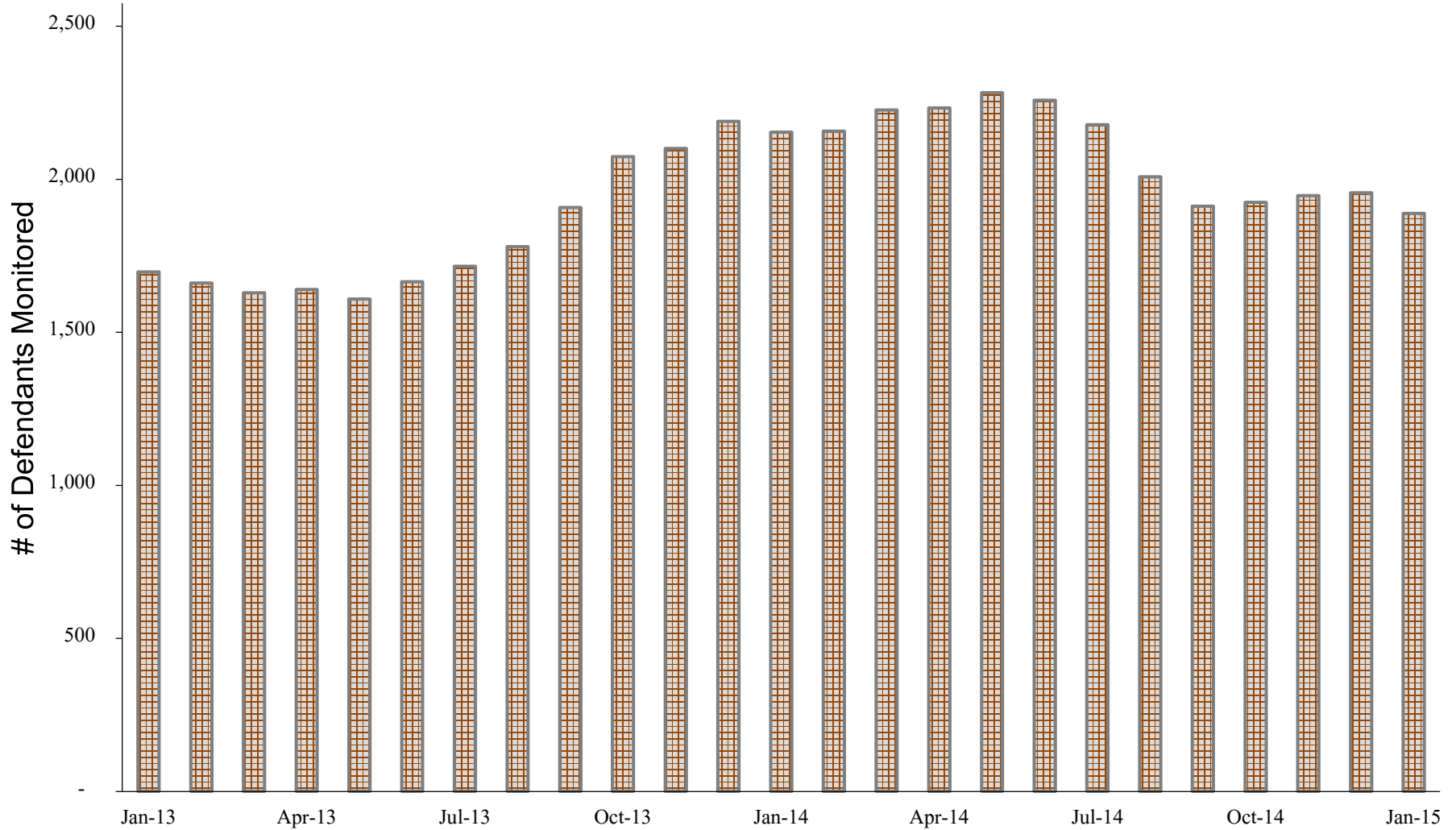

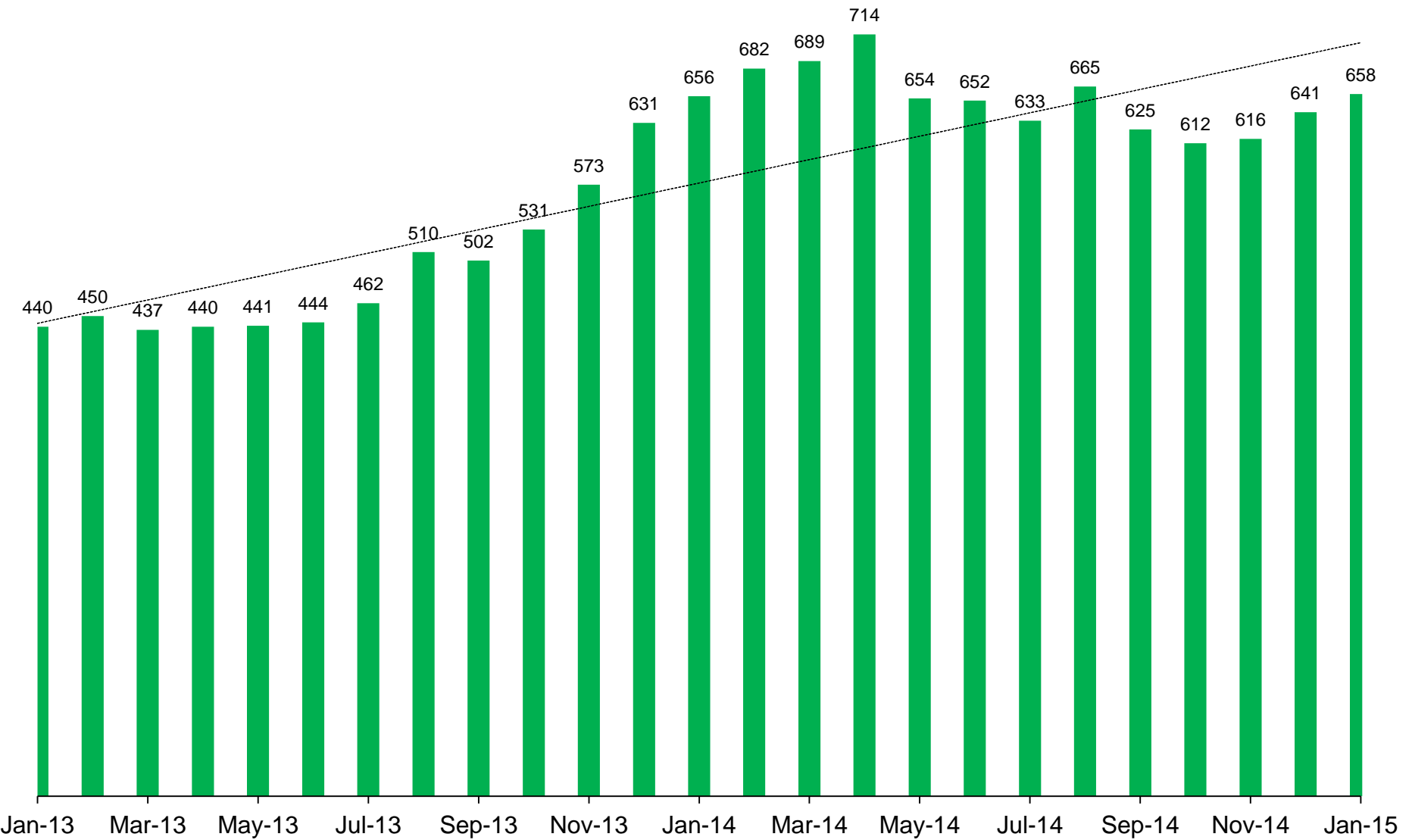


Pretrial Supervision Defendant Monitoring Unit Average Daily Standard Caseload

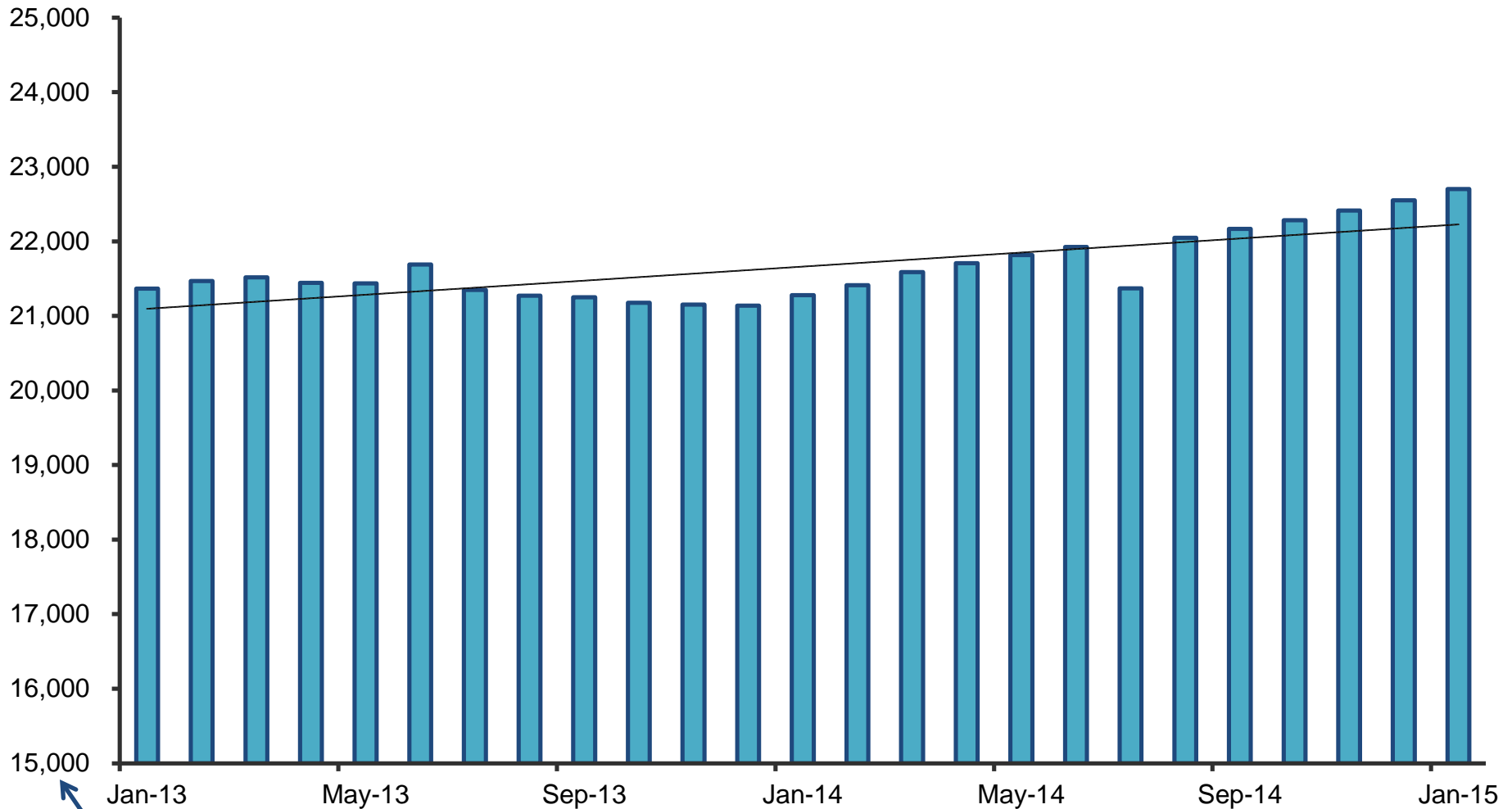

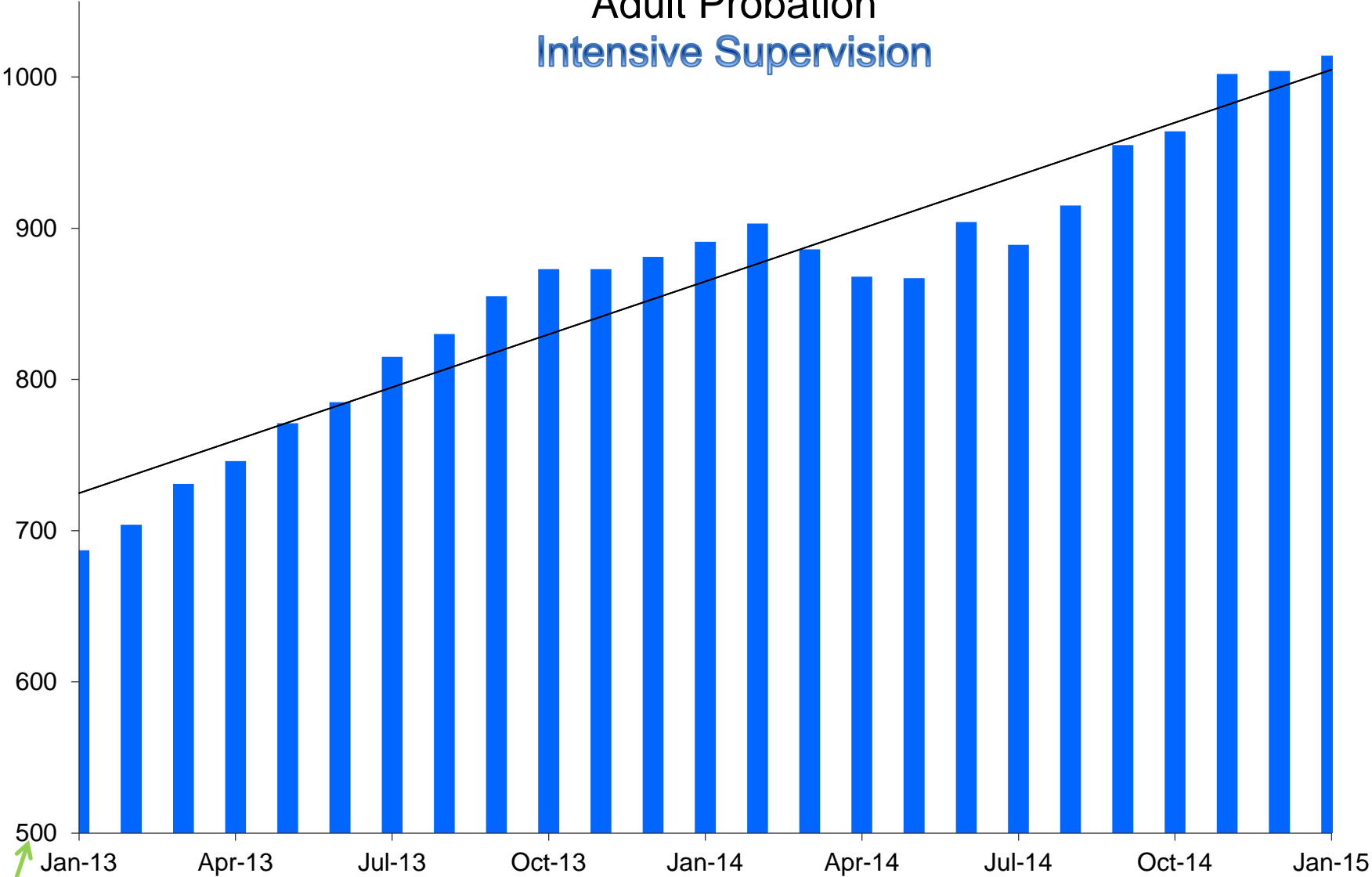


Adult Probation Department Standard Supervision



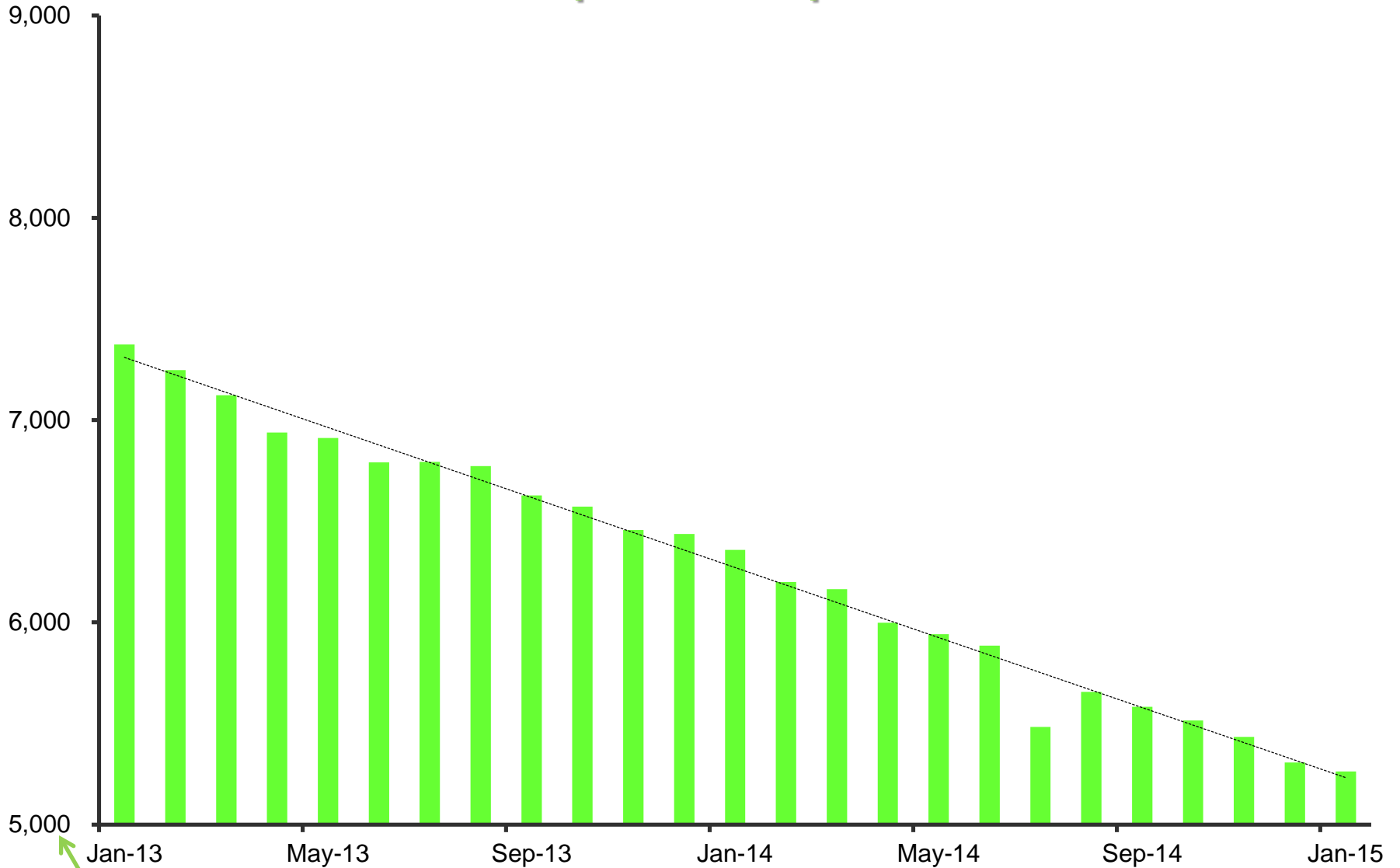

Adult Probation Intensive Supervision



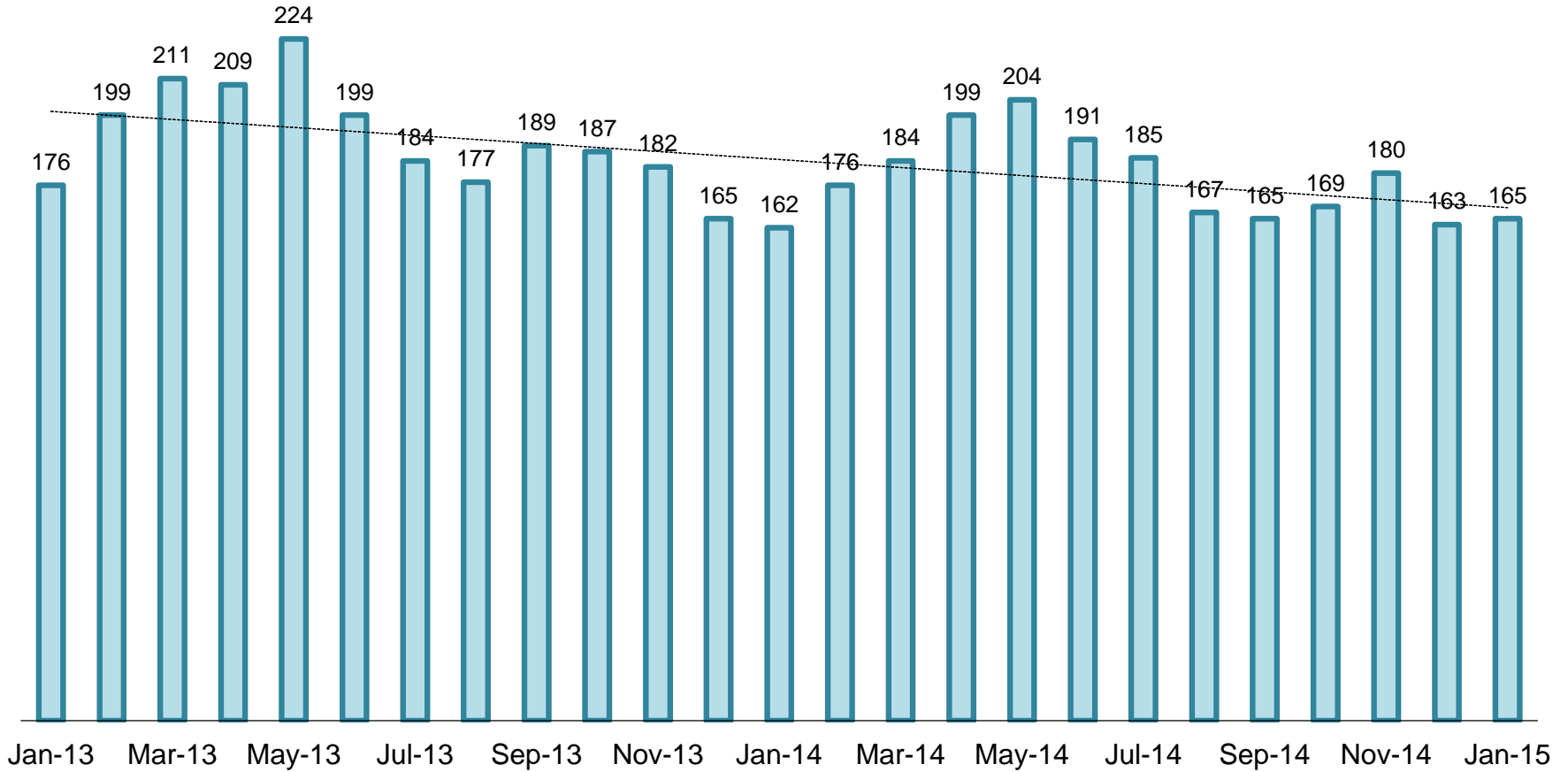

Adult Probation Unsupervised Population

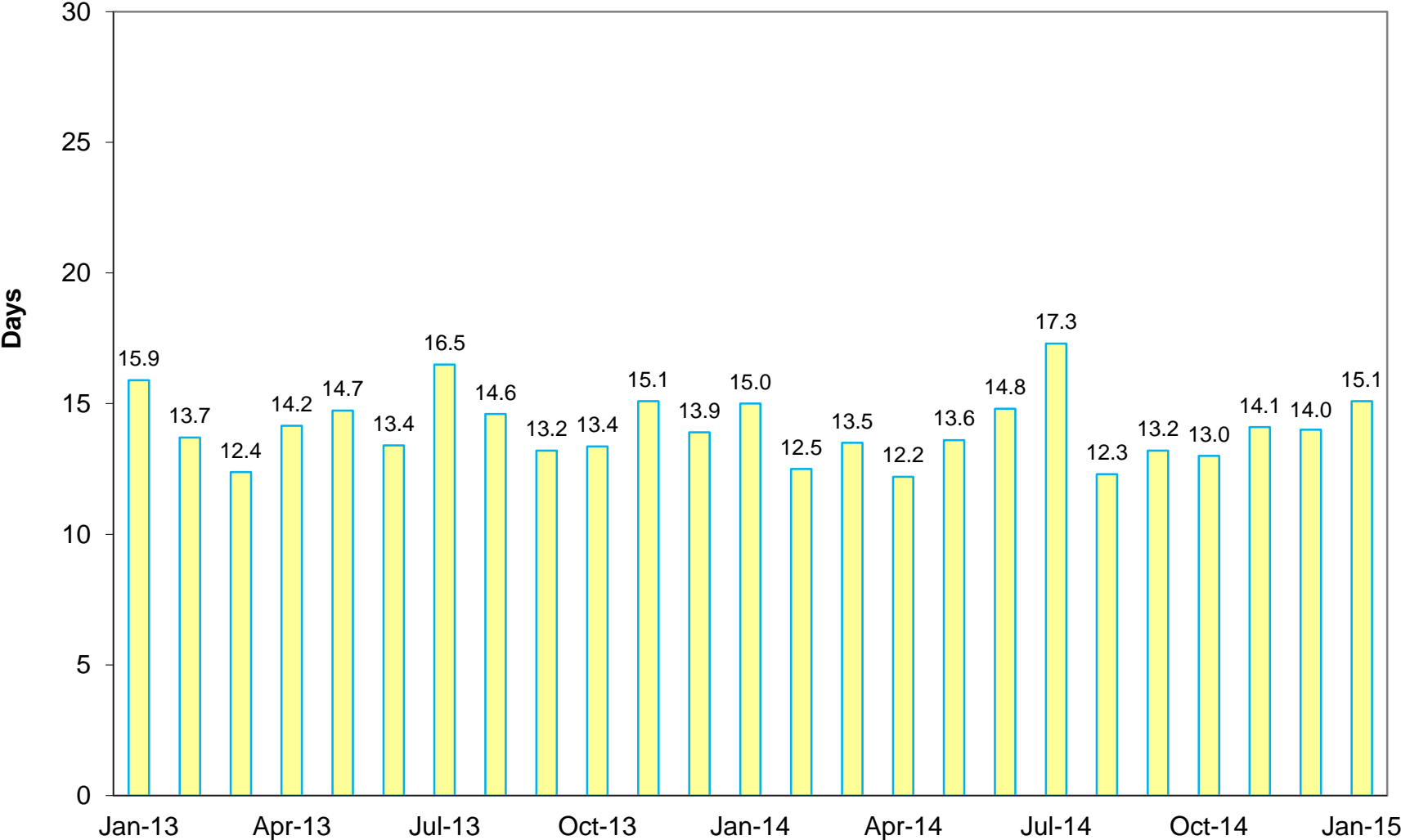

Juvenile Detention Average Daily Population

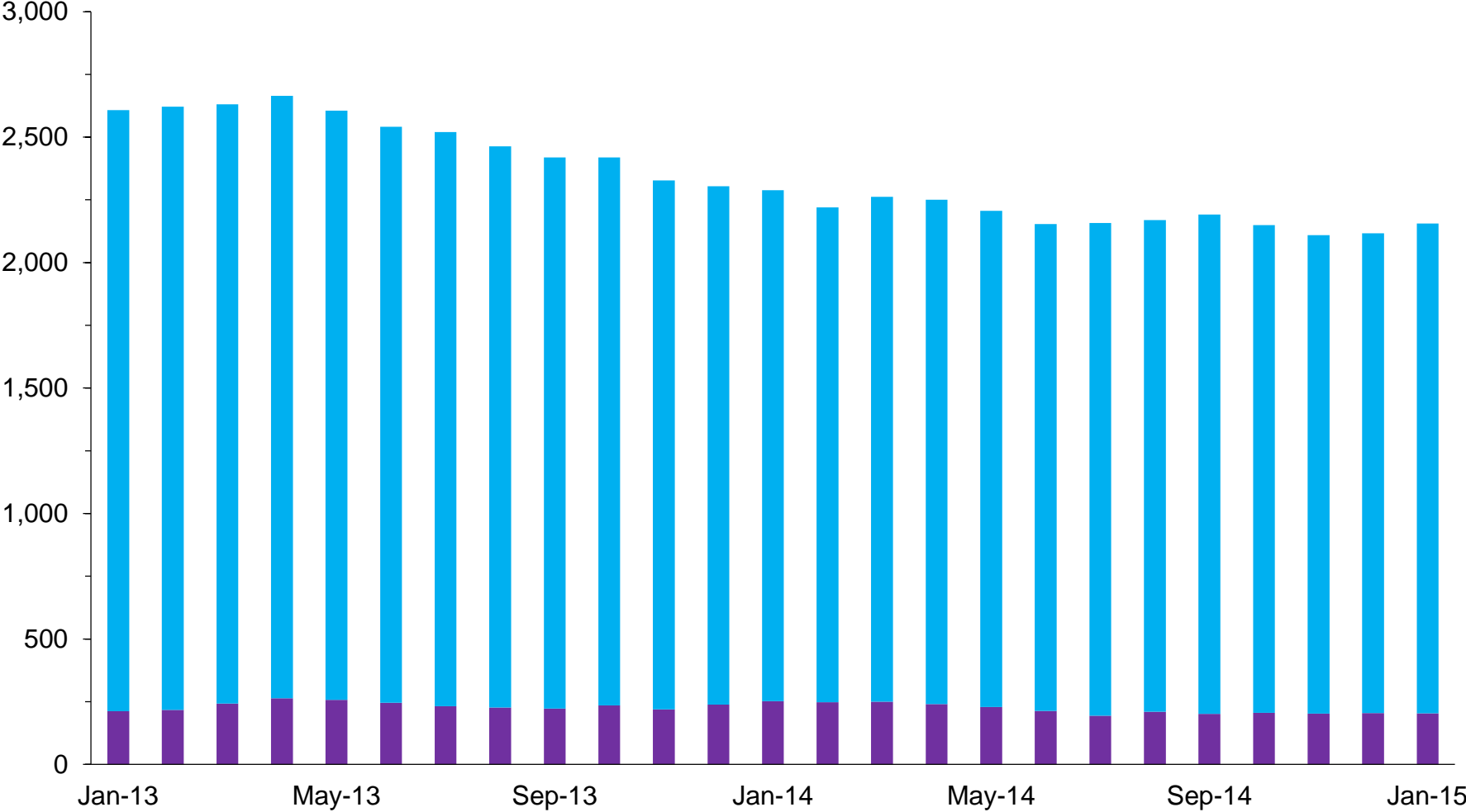


Juvenile Detention Average Length of Stay

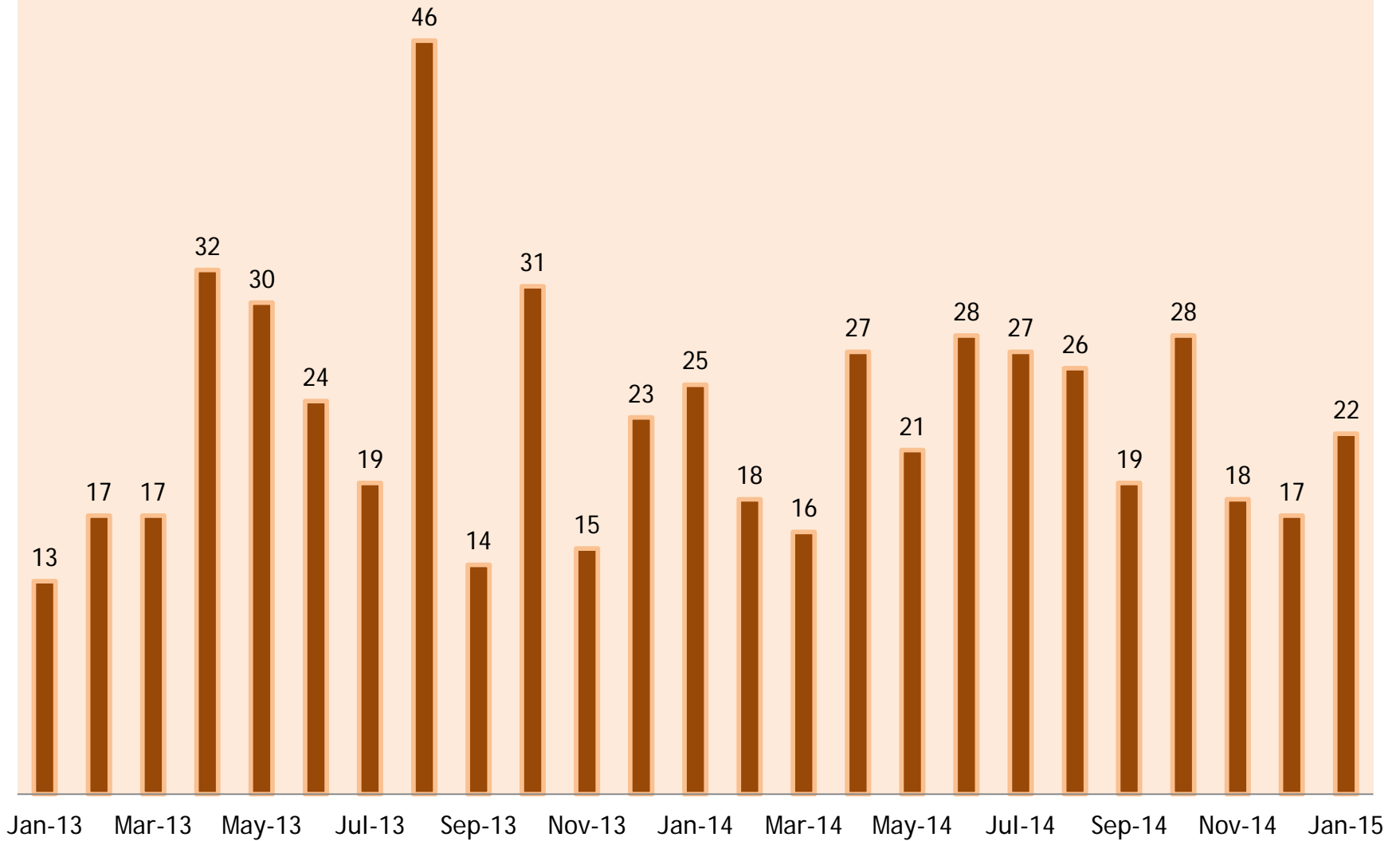

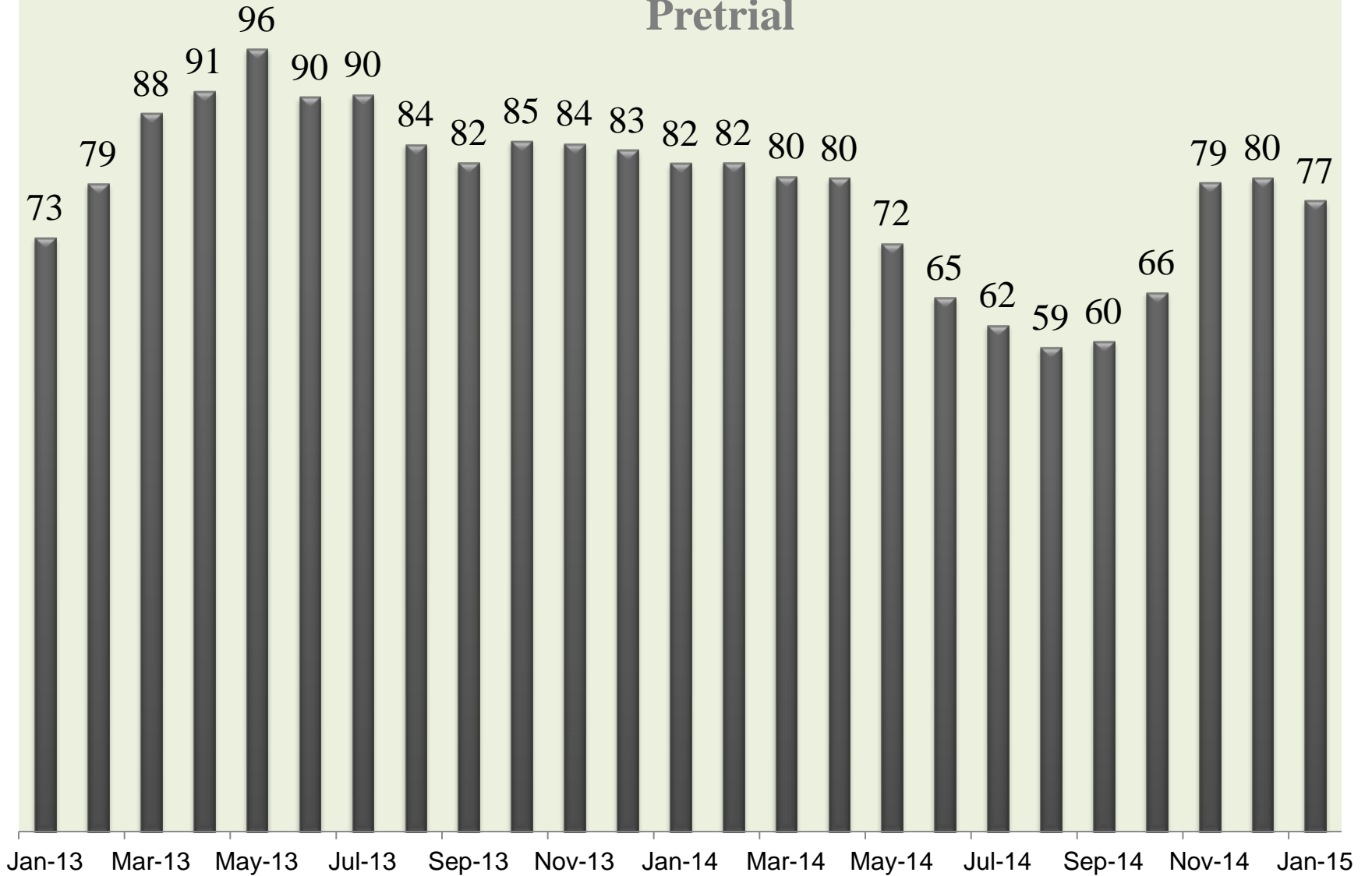
