CRIMINAL JUSTICE SYSTEM NEWS – AUGUST 2006

Adult Incarceration

Bookings increased from July's 10,381 to August's 10,925. **Average Daily Population decreased** for the fourth month in a row, from 9,292 to 9,095. This is the lowest population since March 2005 (8,998). The **pretrial population was down** from 6,064 to 5,825, the lowest since May 2005 (5,862). However, the **sentenced and hold populations increased**: sentenced from 2,798 to 2,822 and holds from 383 to 398. **Overall Average Length of Stay decreased two days**, from 27.8 to 25.8 days. **The ALOS measurement for agency holds increased** from 67.9 to 68.7 days. **Pretrial ALOS decreased** from 8.0 to 7.1 days, while **sentenced ALOS was unchanged** at 30.9 days. Breaking down the pretrial population, felony ALOS decreased from 12.5 to 10.3 days, while misdemeanor ALOS remained the same, at 3.5 days.

Superior Court Filings & Case Processing

Criminal filings and terminations increased in August, filings from 2,962 to 3,229 and terminations from 2,925 to 3,573, resulting in a termination rate of 110.7%. **The active pending case inventory increased slightly** from 10,676 to 10,719. **August filings into the RCC and EDC increased**. RCC filings went from 1,656 to 1,820 while EDC went from 918 to 1,053. **90 trials were completed in August**, compared to 62 in July. **The August trial rate was 2.8%**, the highest monthly rate ever.

Justice Court Filings

This information is new to the report. **DUI filings are 20% higher** this FY-to-date compared to the same time last fiscal year. **Criminal Traffic filings are 58% higher** this FY-to-date than the same time last fiscal year.

Adult Probation

All levels of pretrial supervision increased from July to August: general from 919 to 928; intensive from 1,166 to 1,183; and electronic from 214 to 229.

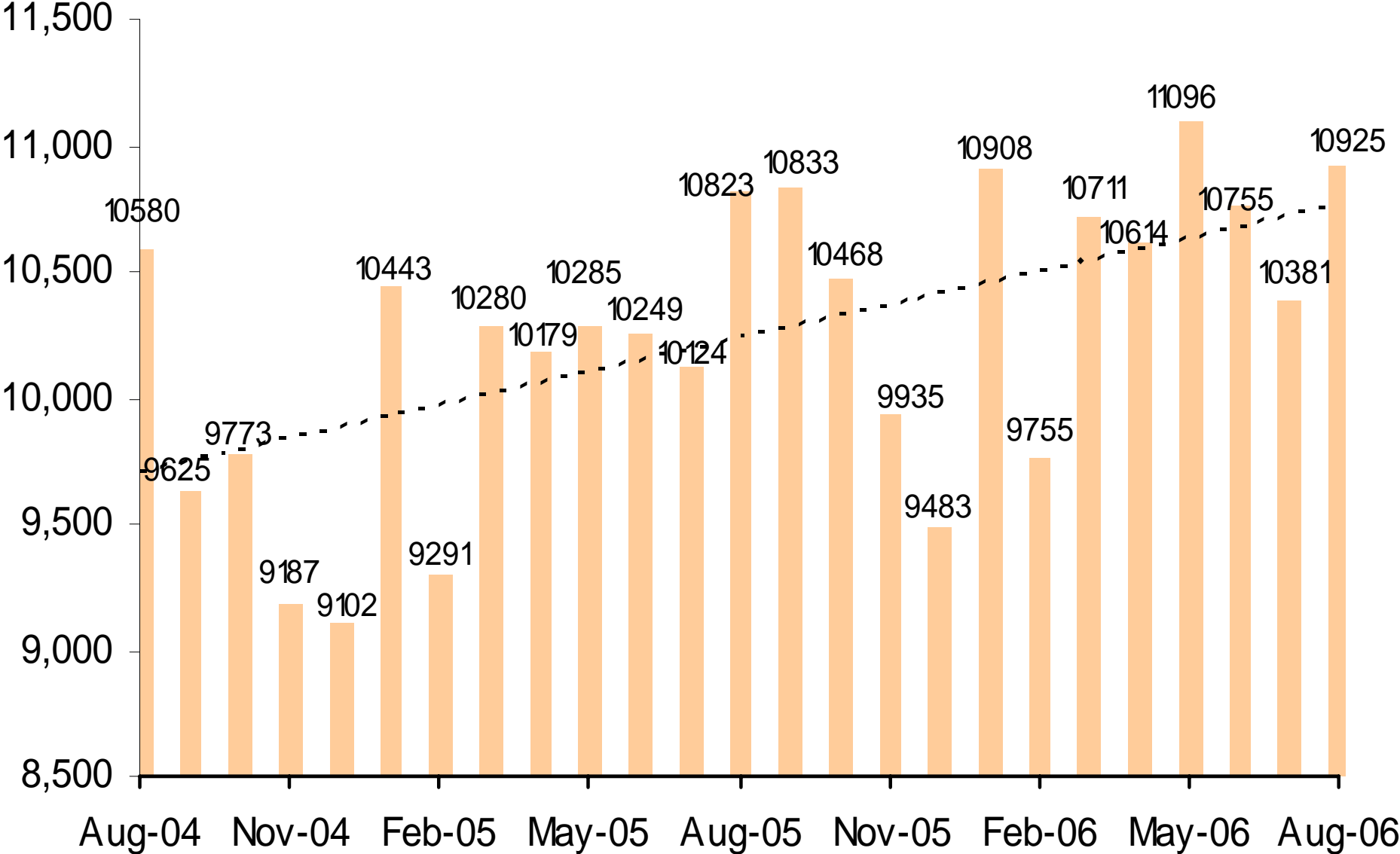
Levels of standard probation supervision increased from July to August, 29,474 to 29,791. This level continues to be the highest it has ever been. **Levels of intensive probation supervision decreased** from 1,315 to 1,258.

Juvenile Detention and Probation

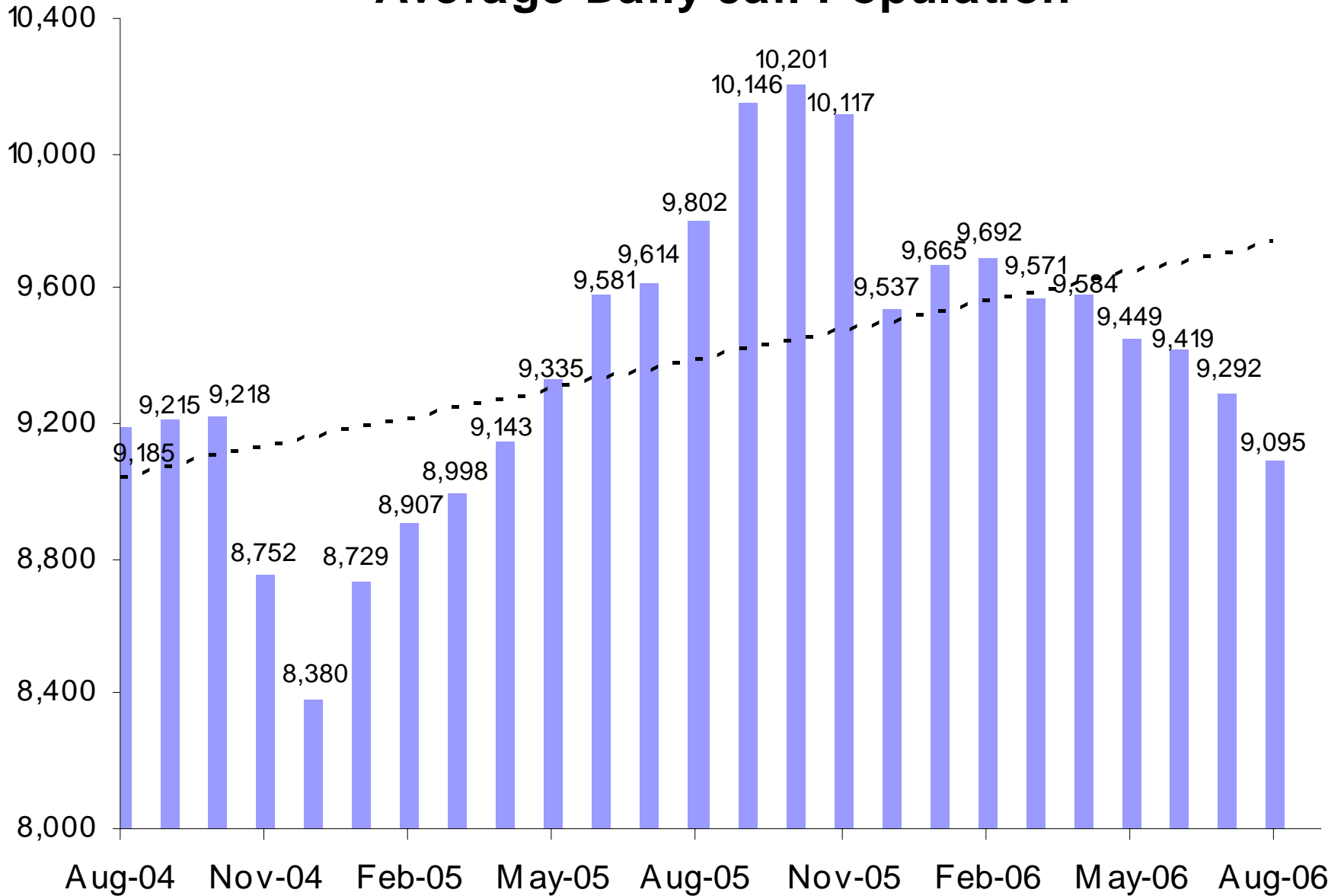
The **Average Daily Detention Population decreased** from 427 in July to 403 in August. This is the lowest population since September 2005 when it was also 403. **ALOS increased slightly** from 17.2 to 17.9 days. **August Electronic Monitoring was 136**, compared to July's 144. **Home detention decreased** from 239 to 228, the lowest since October 2005 (218).

Levels of juvenile standard and intensive probation increased slightly. Standard went from 4,179 to 4,352, while intensive went from 528 to 531.

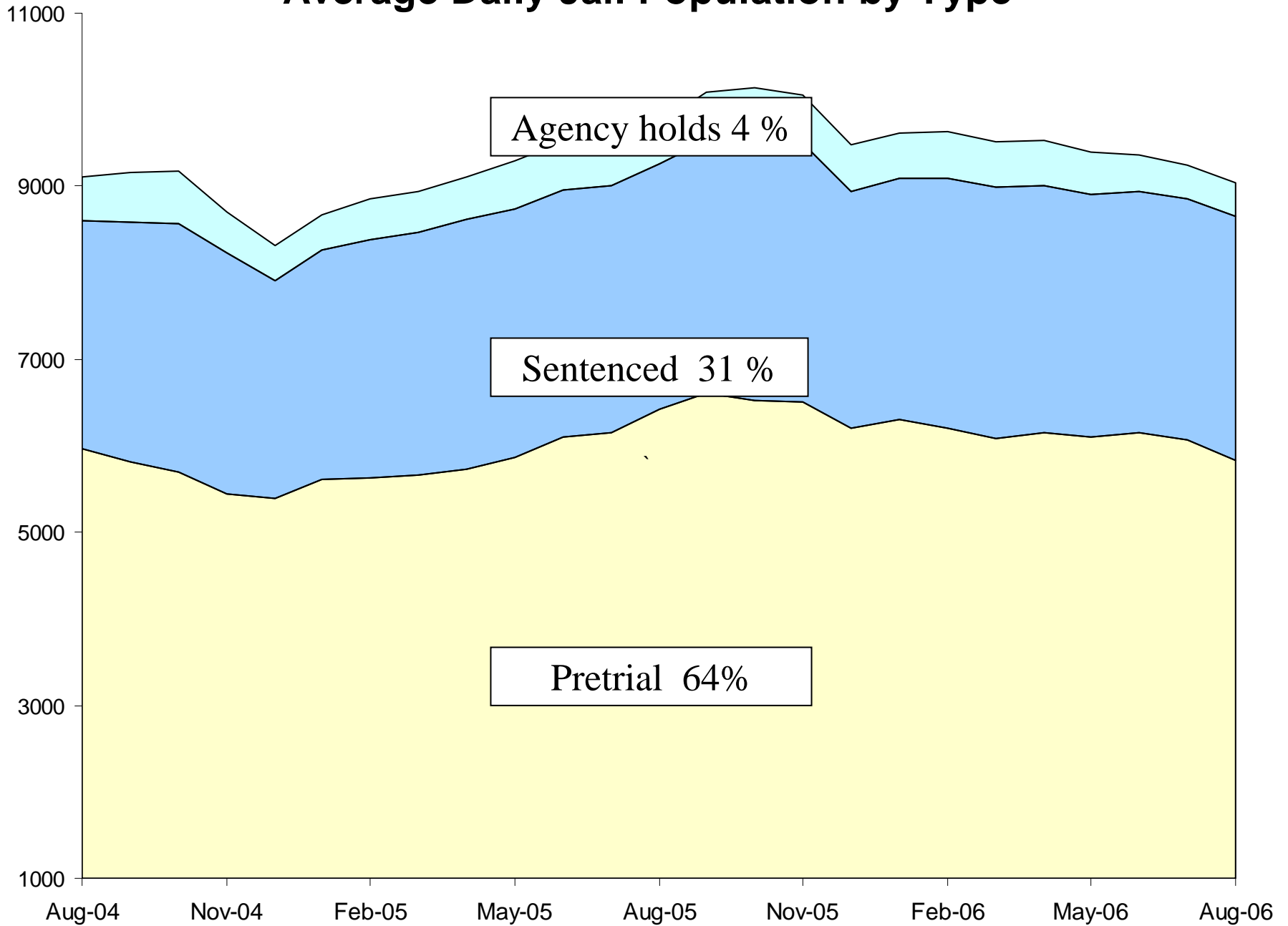
Jail Bookings



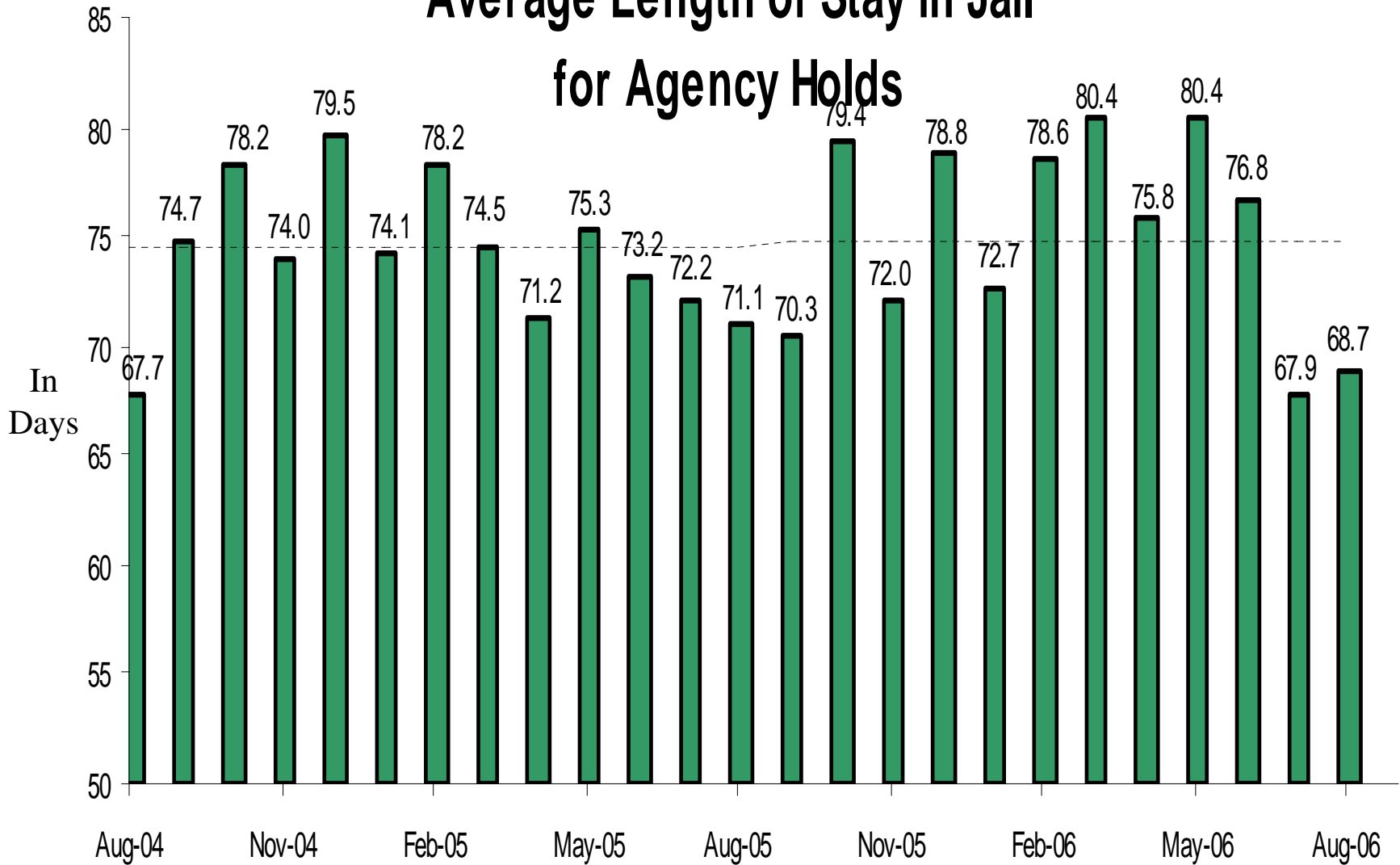
Average Daily Jail Population



Average Daily Jail Population by Type

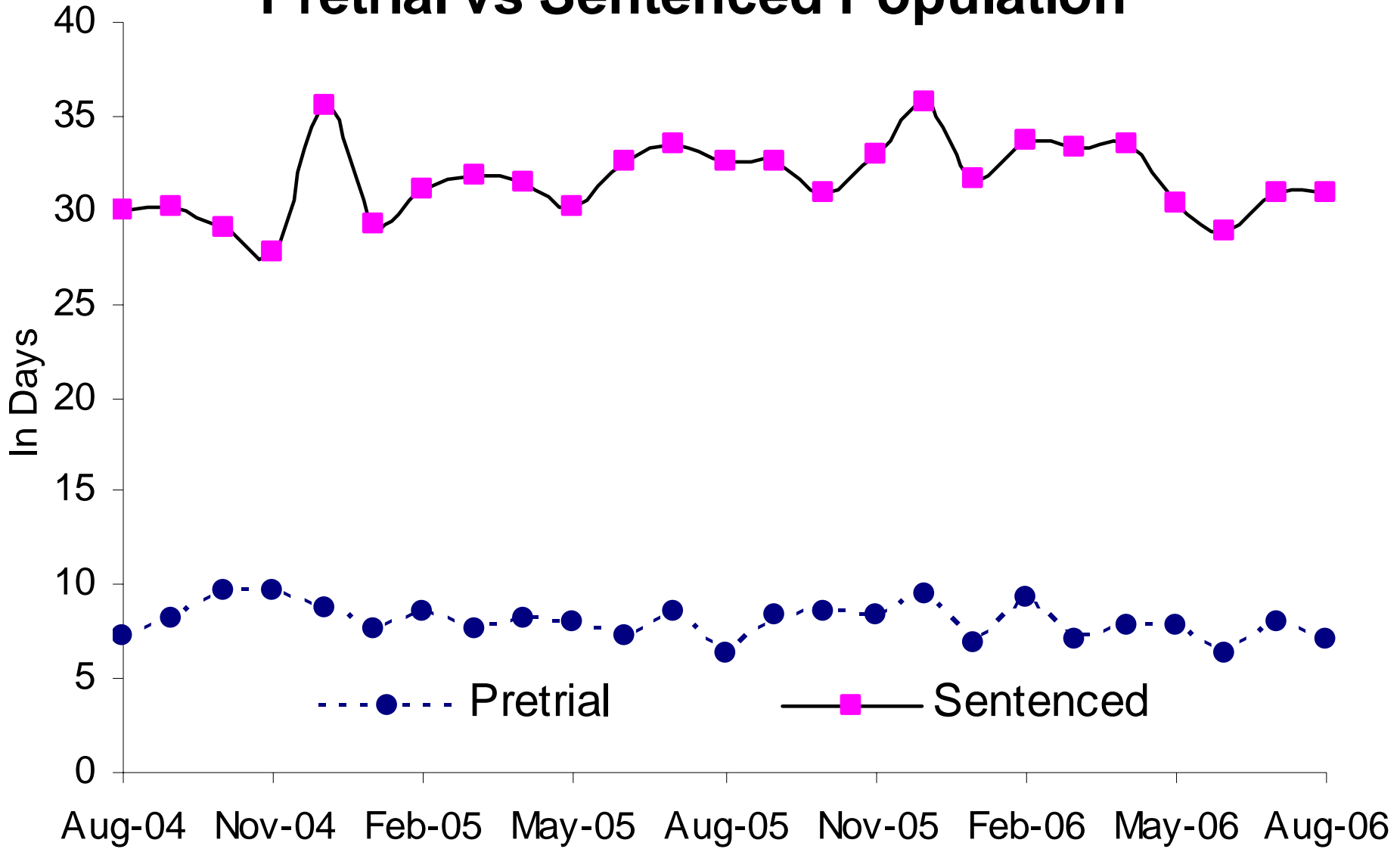


Average Length of Stay in Jail for Agency Holds

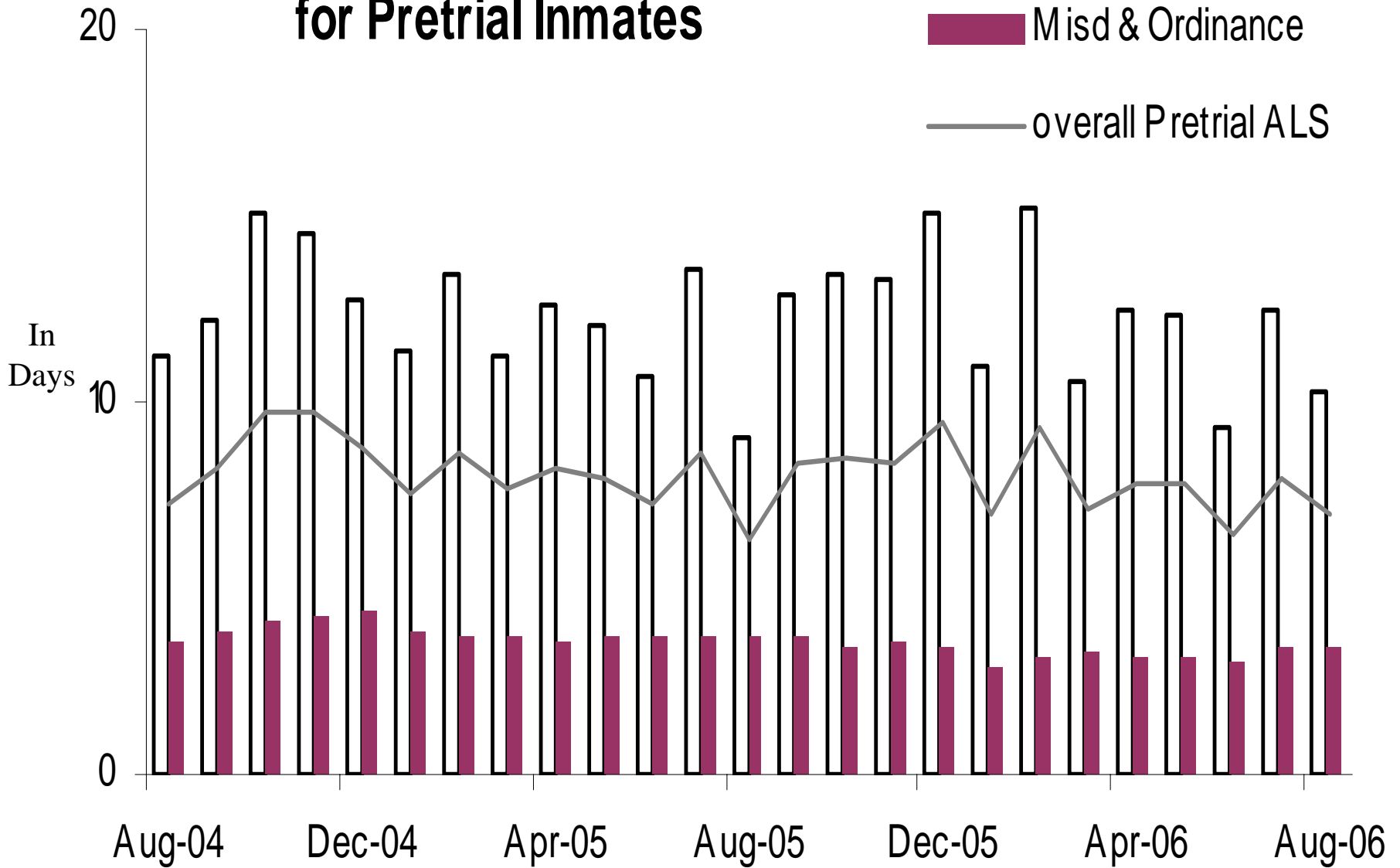

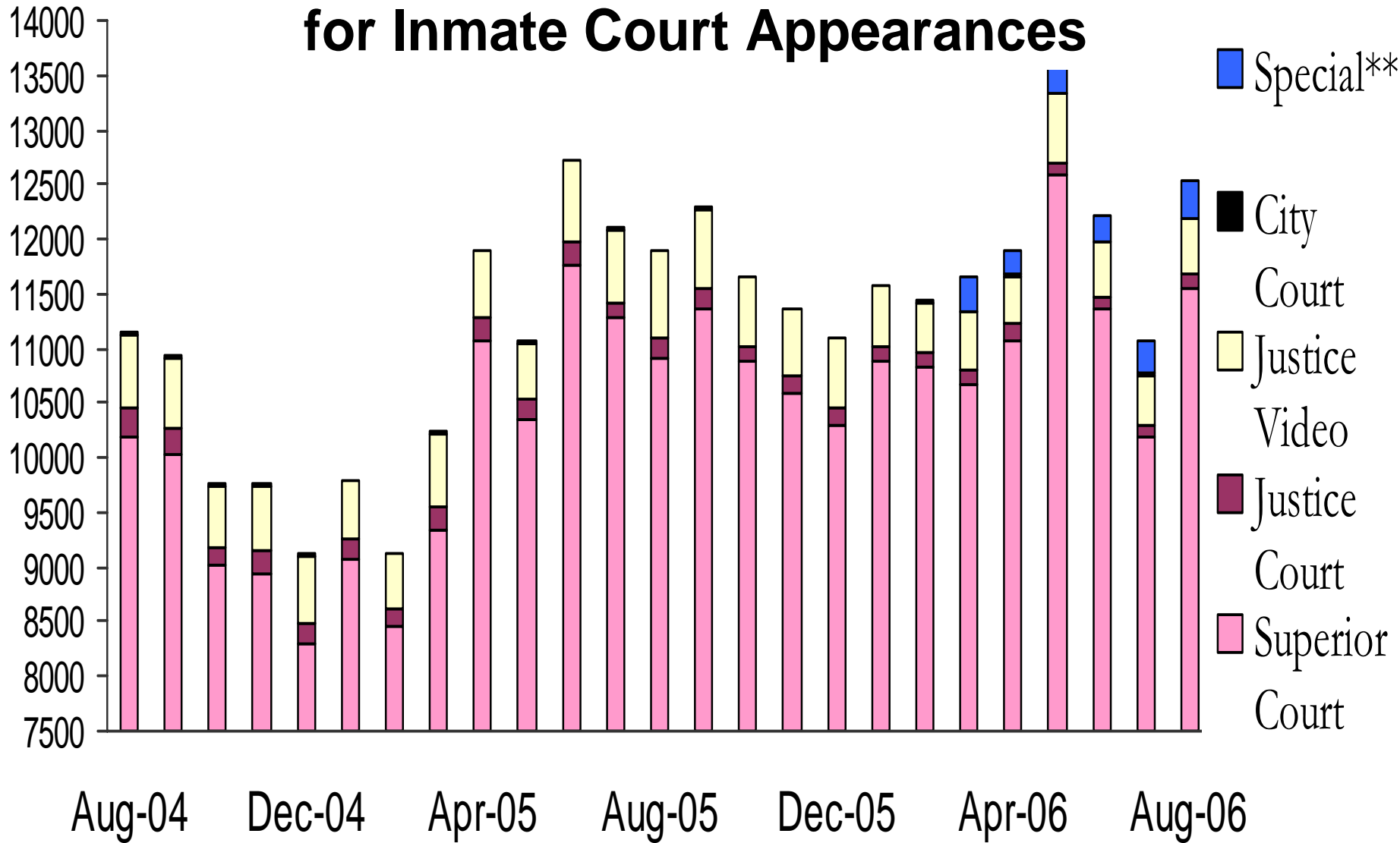
Average Length of Stay in Jail Pretrial vs Sentenced Population



Average Length of Stay in Jail for Pretrial Inmates



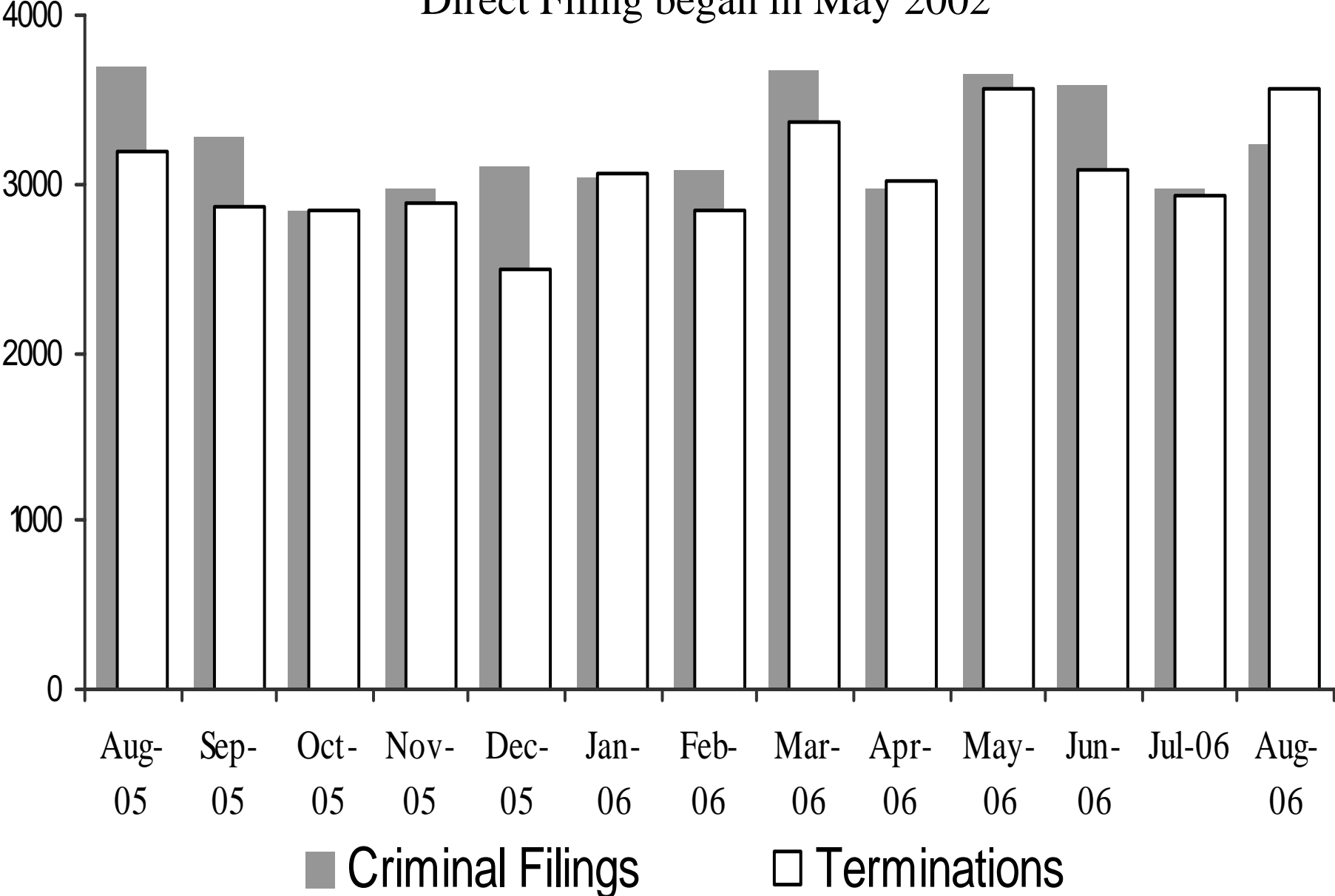
Sheriff's Office Transports for Inmate Court Appearances



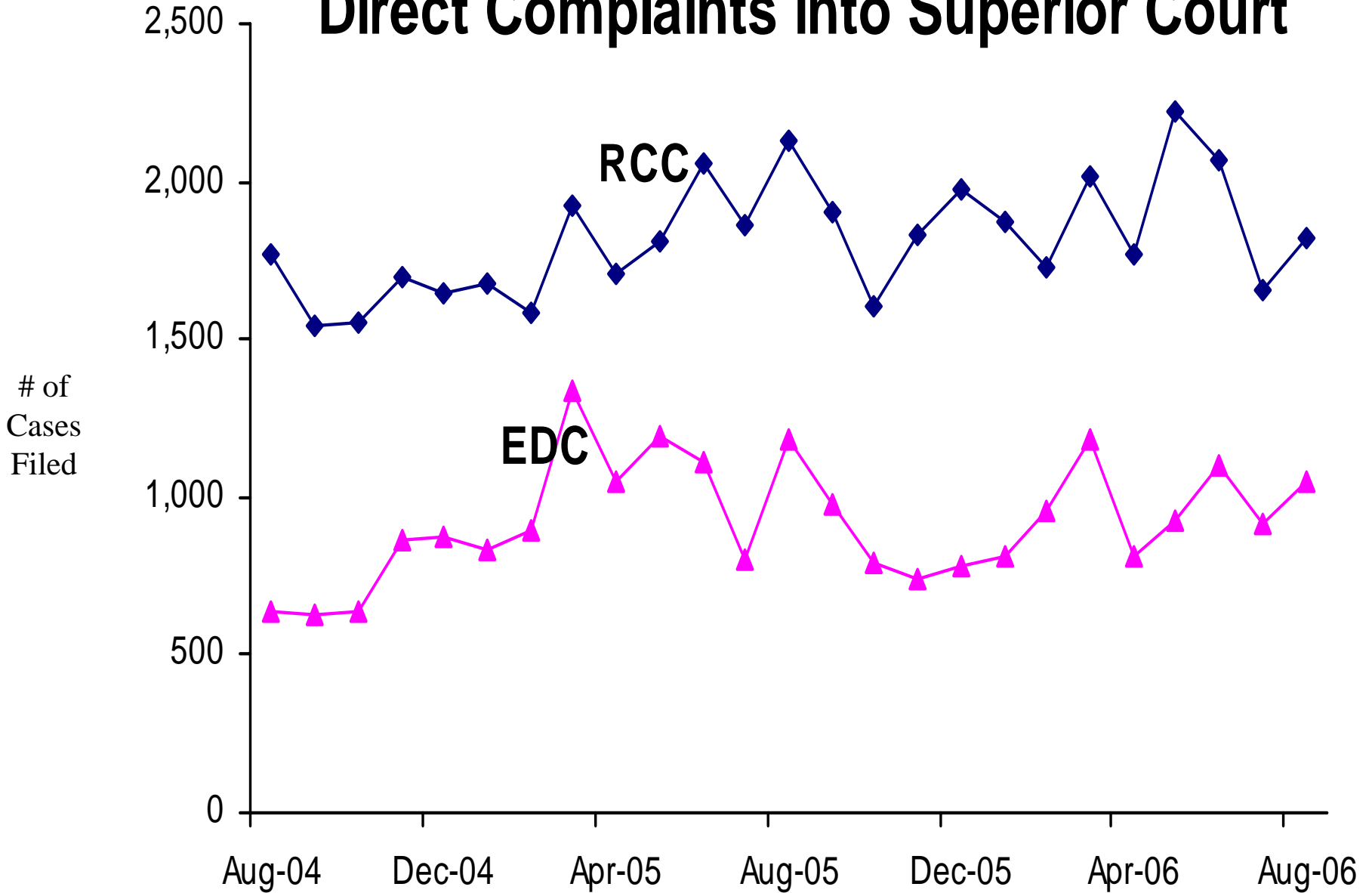

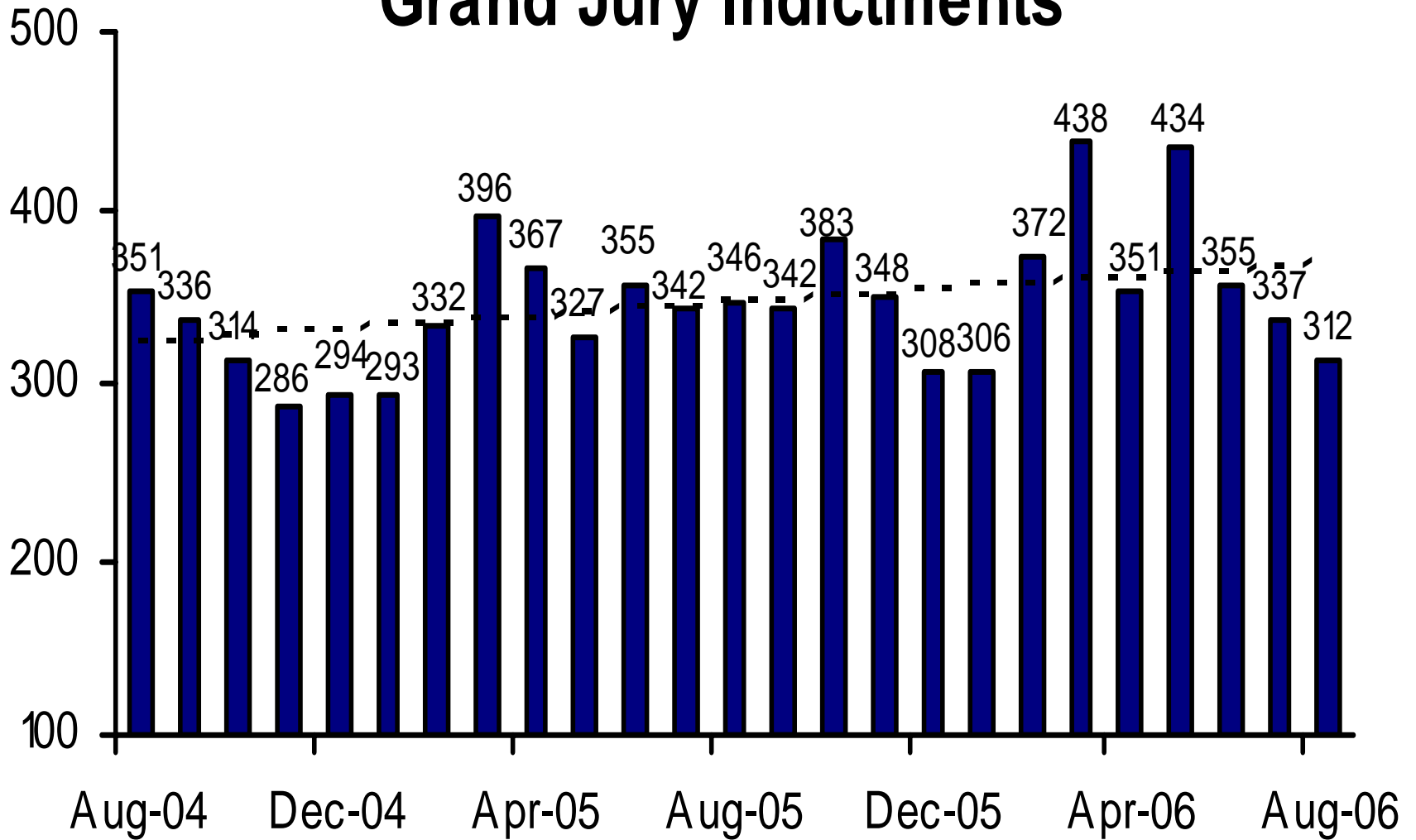
Direct Filing began in May 2002



Direct Complaints into Superior Court

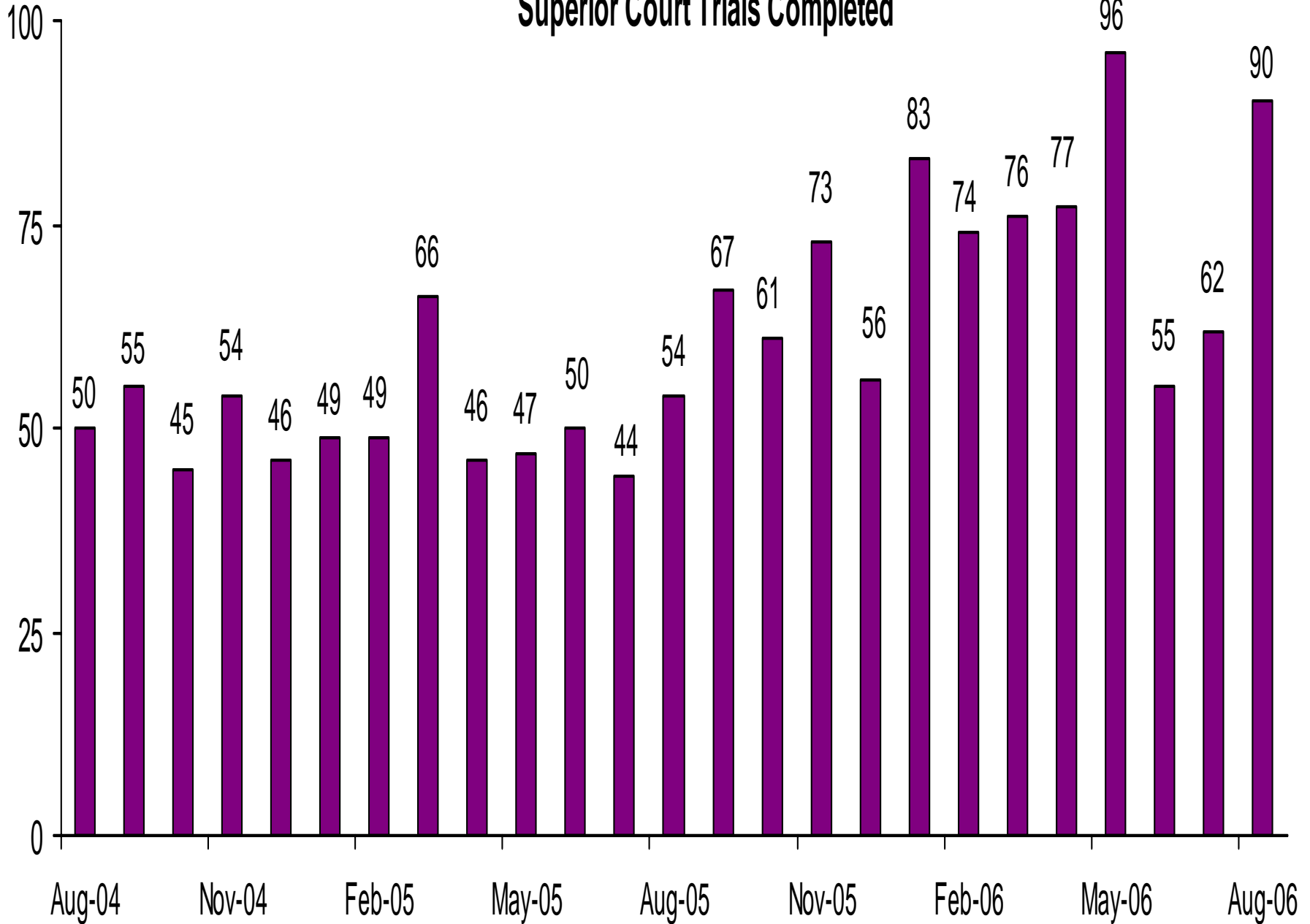


Grand Jury Indictments

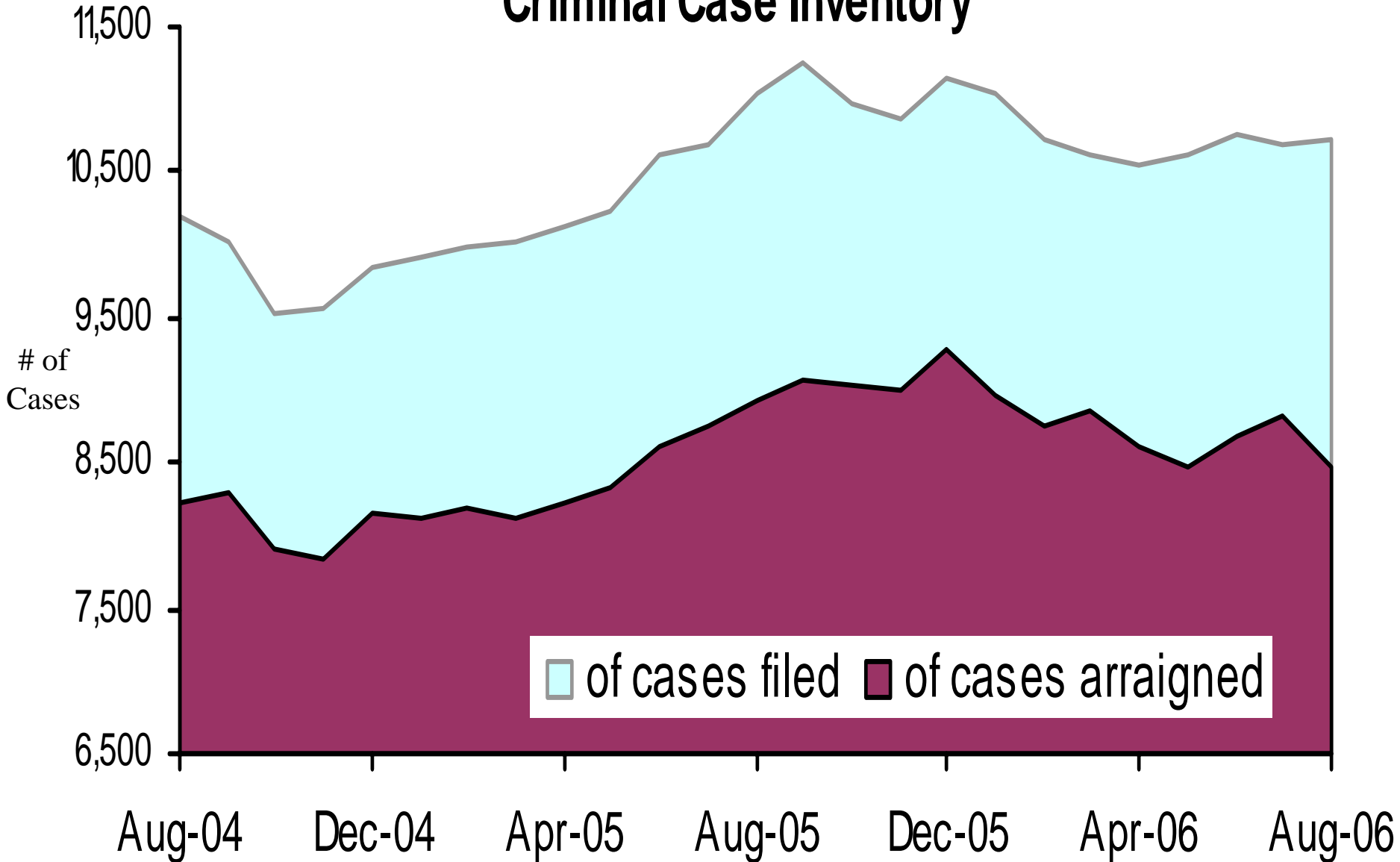

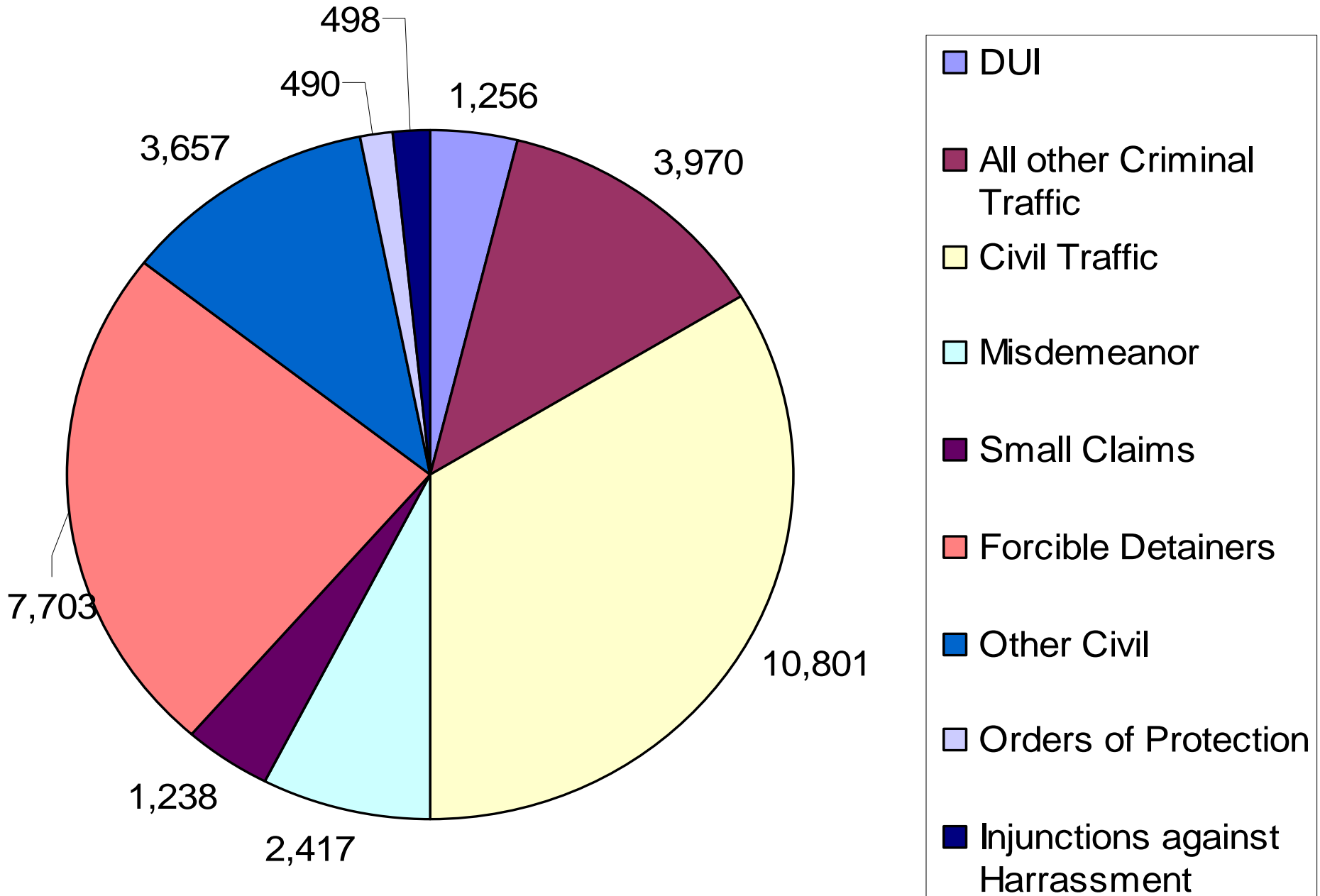
Superior Court Trials Completed

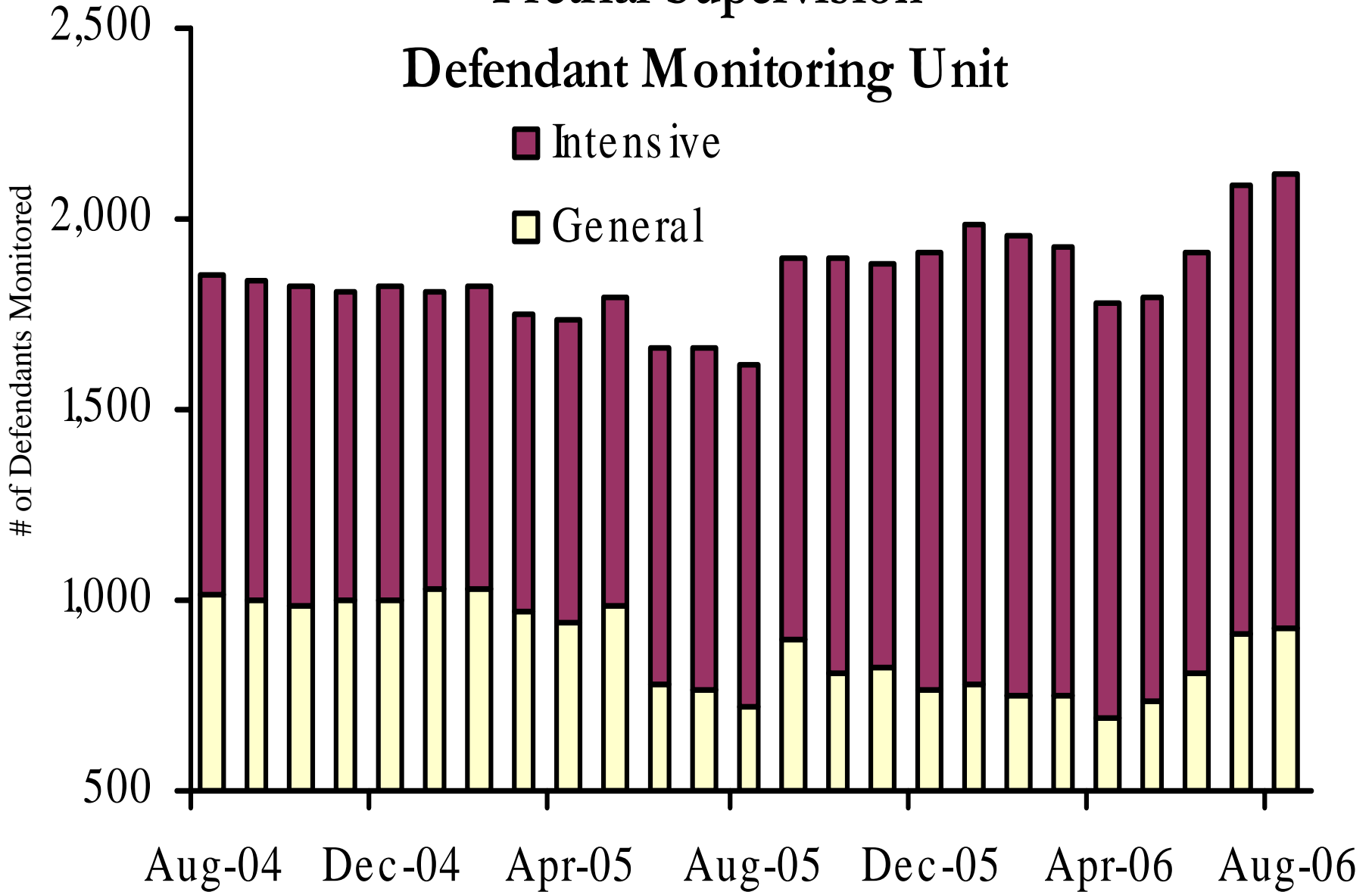

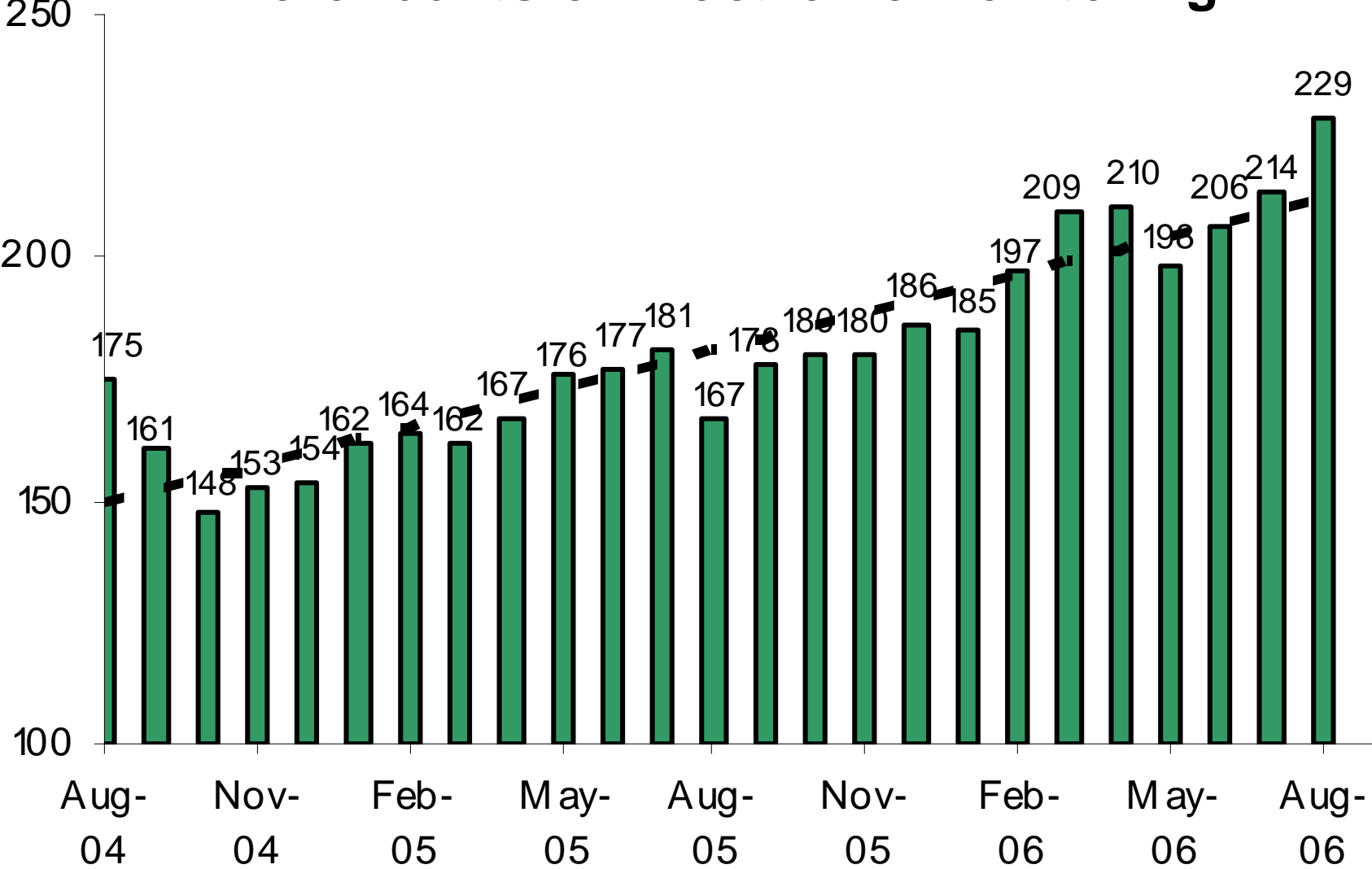

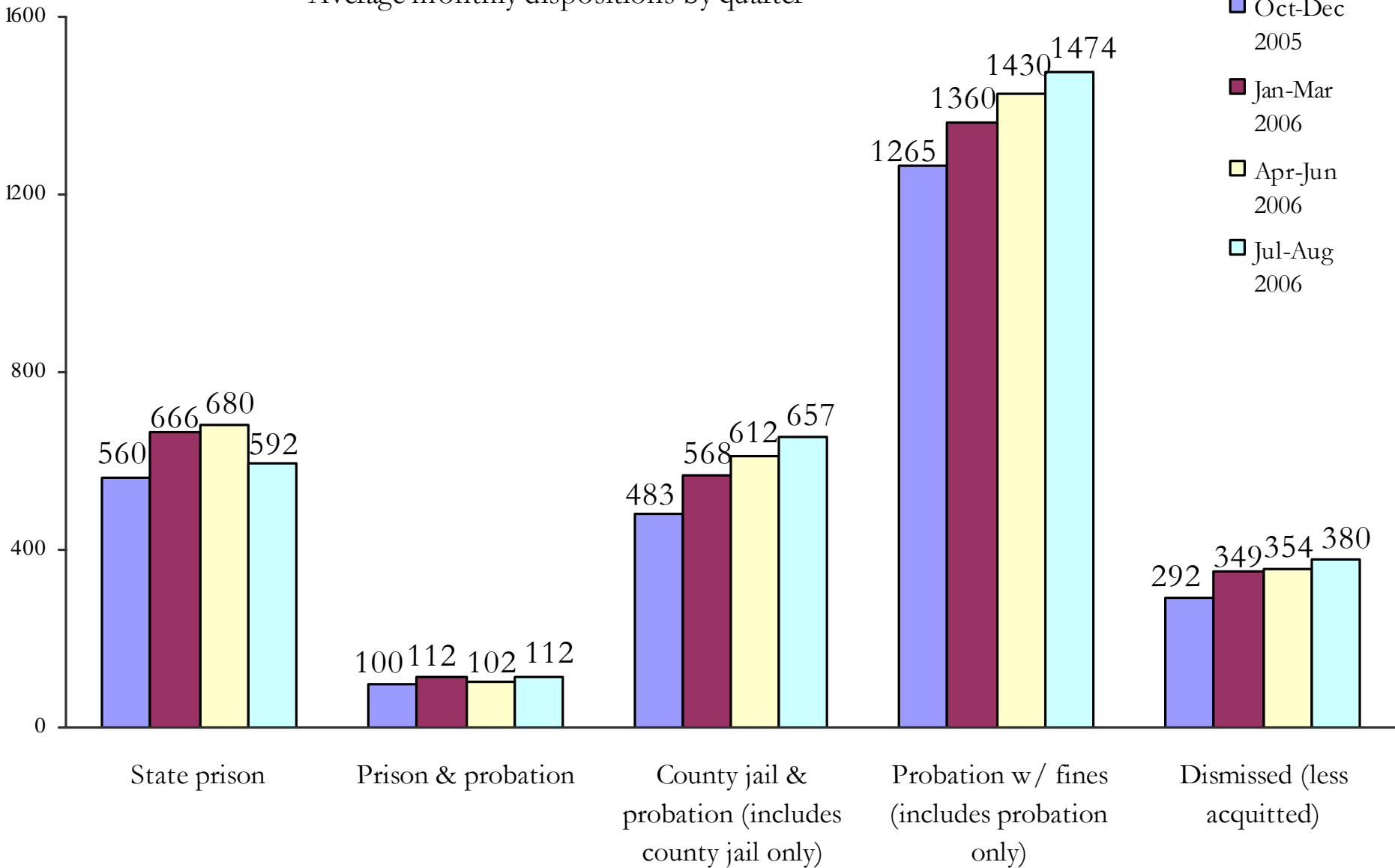
Pretrial Supervision Defendants on Electronic Monitoring



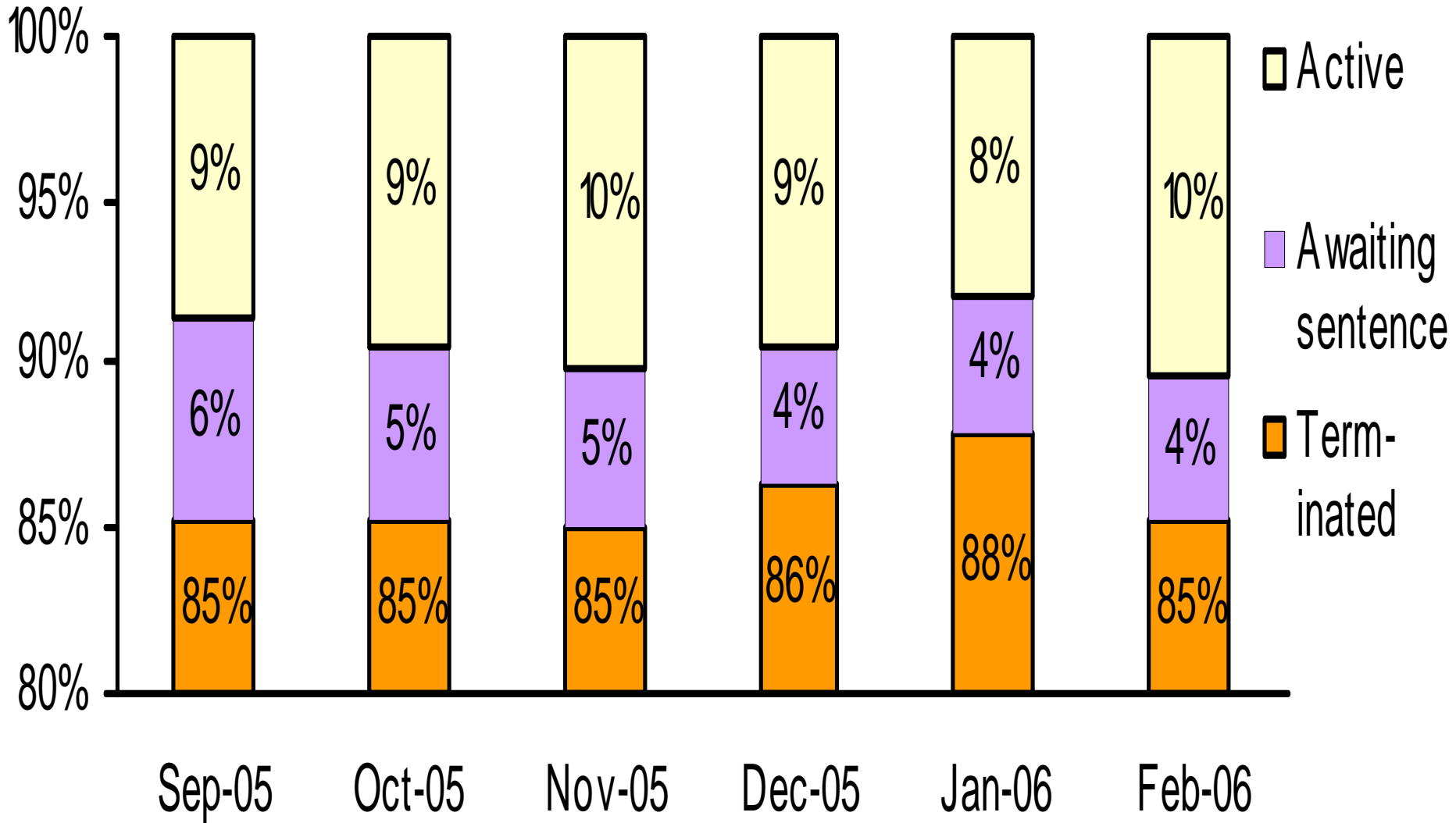
Disposition of Cases Terminated

Average monthly dispositions by quarter

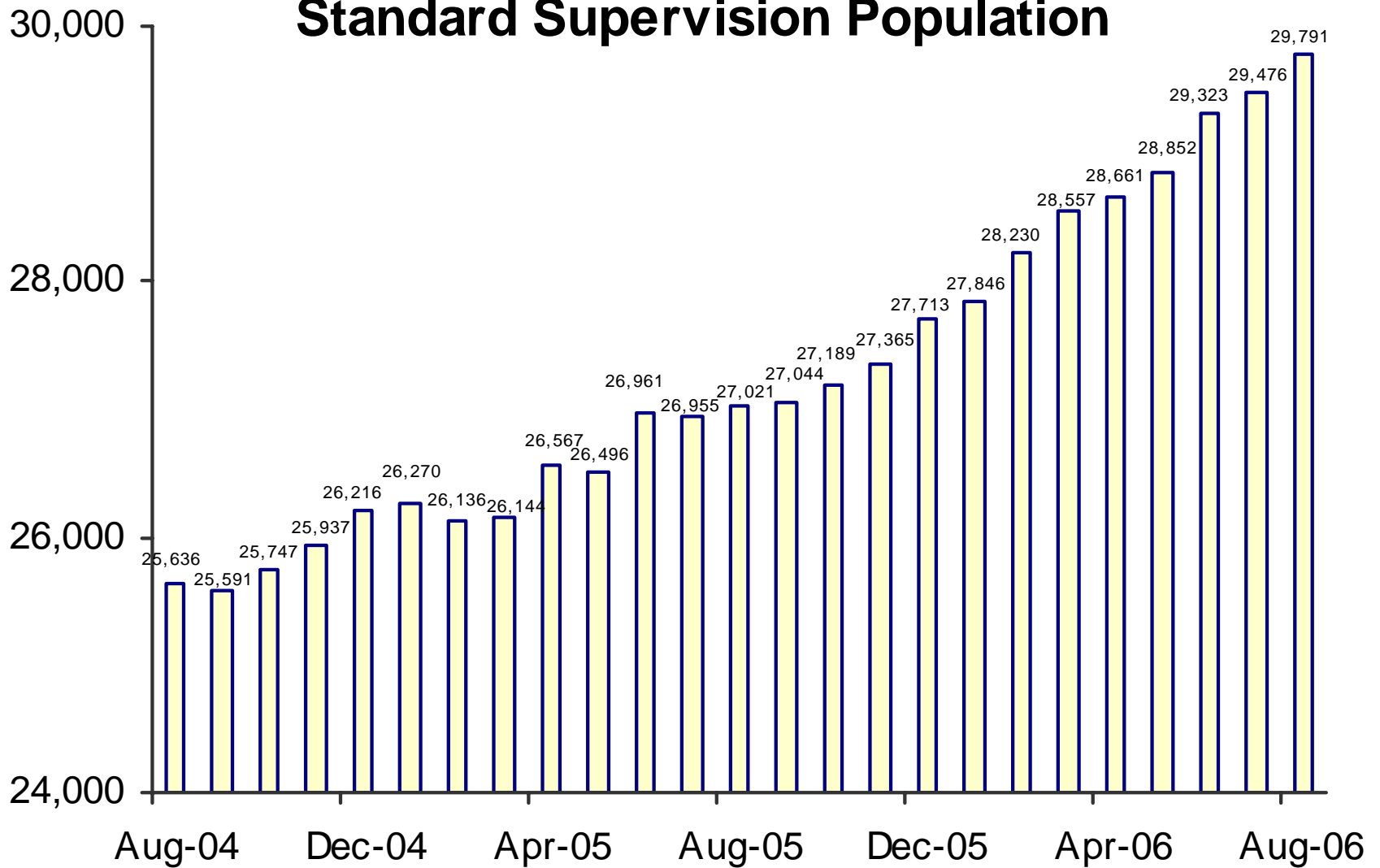

Status of Cases After 180 Days

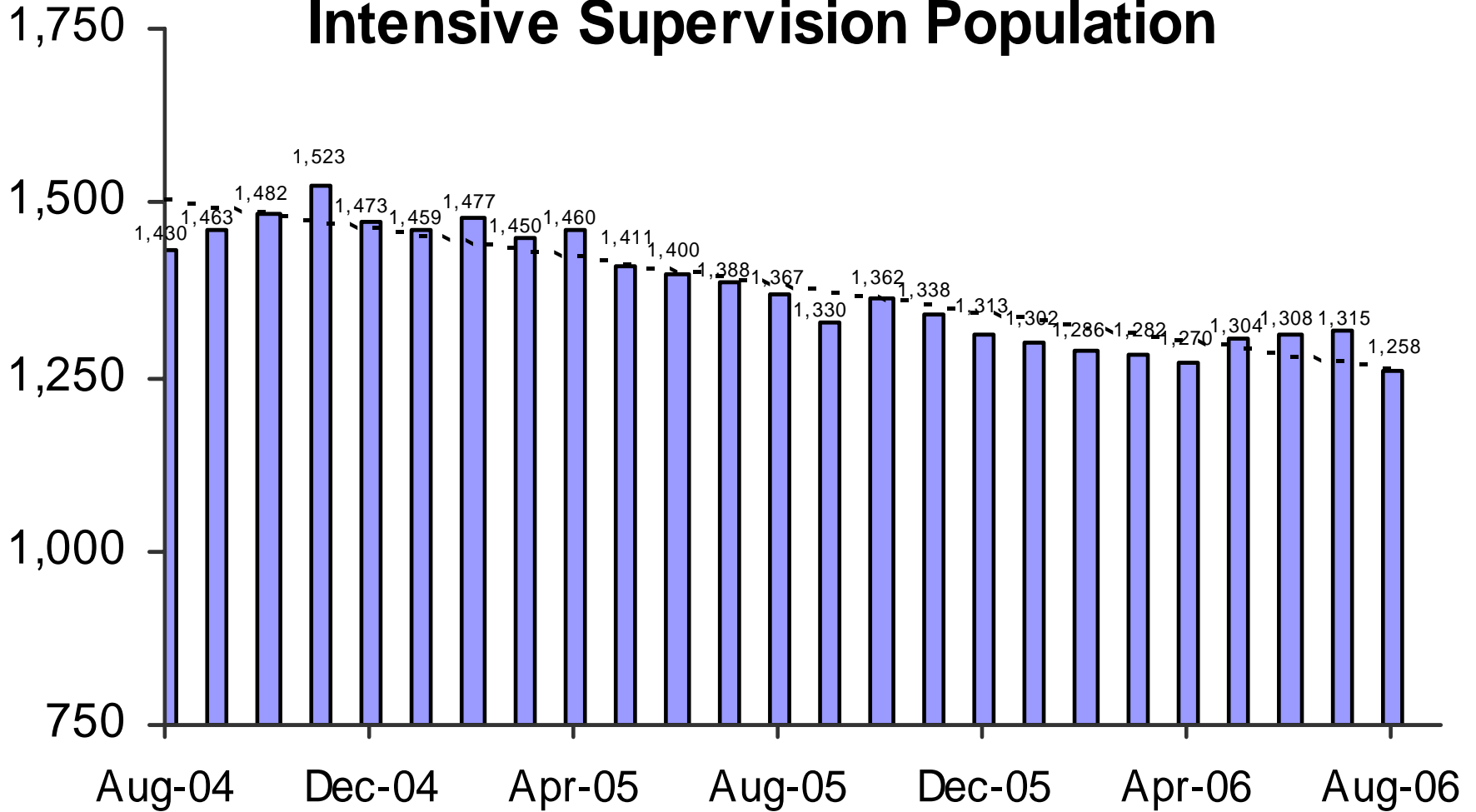


Adult Probation Standard Supervision Population

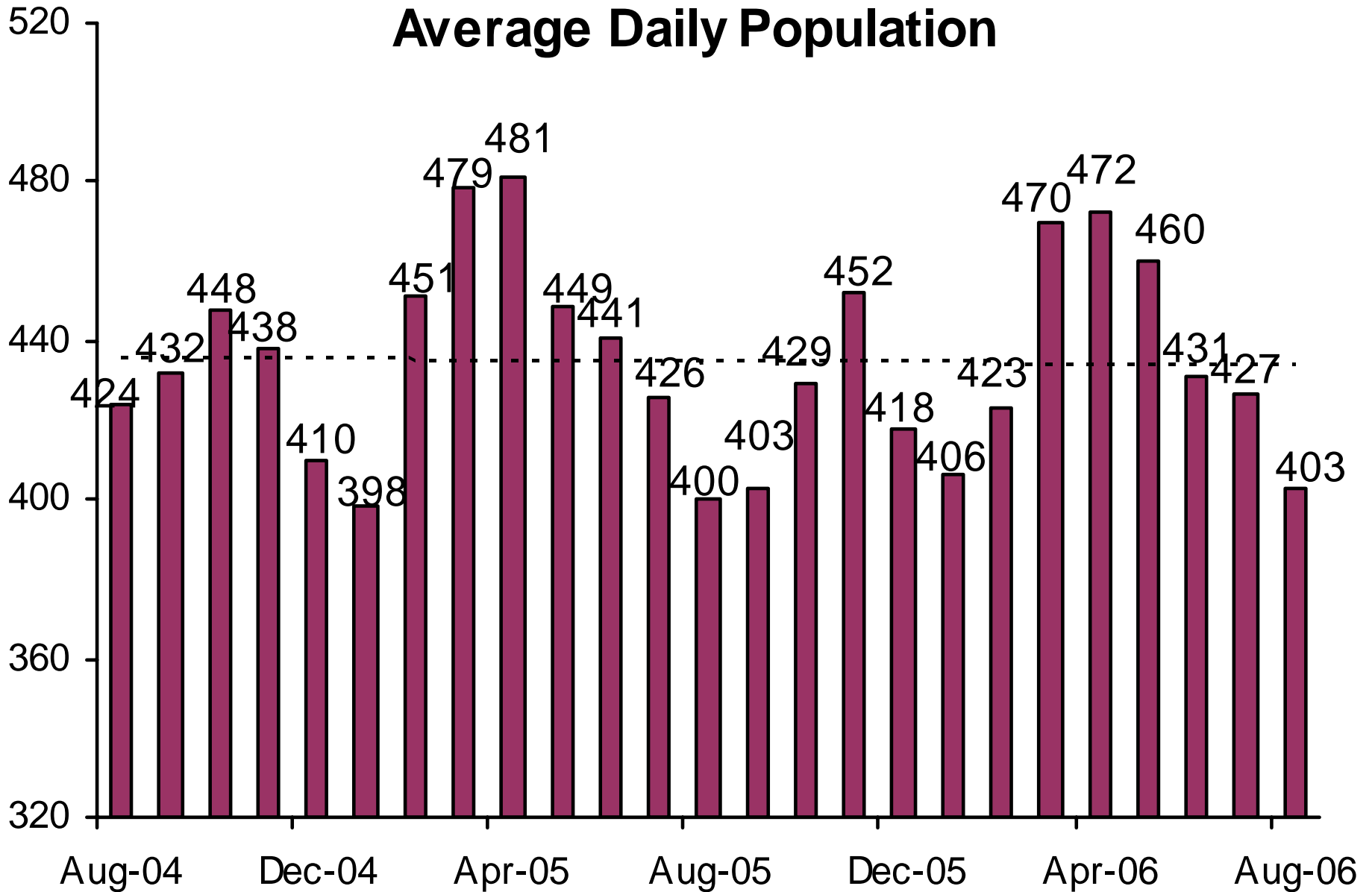

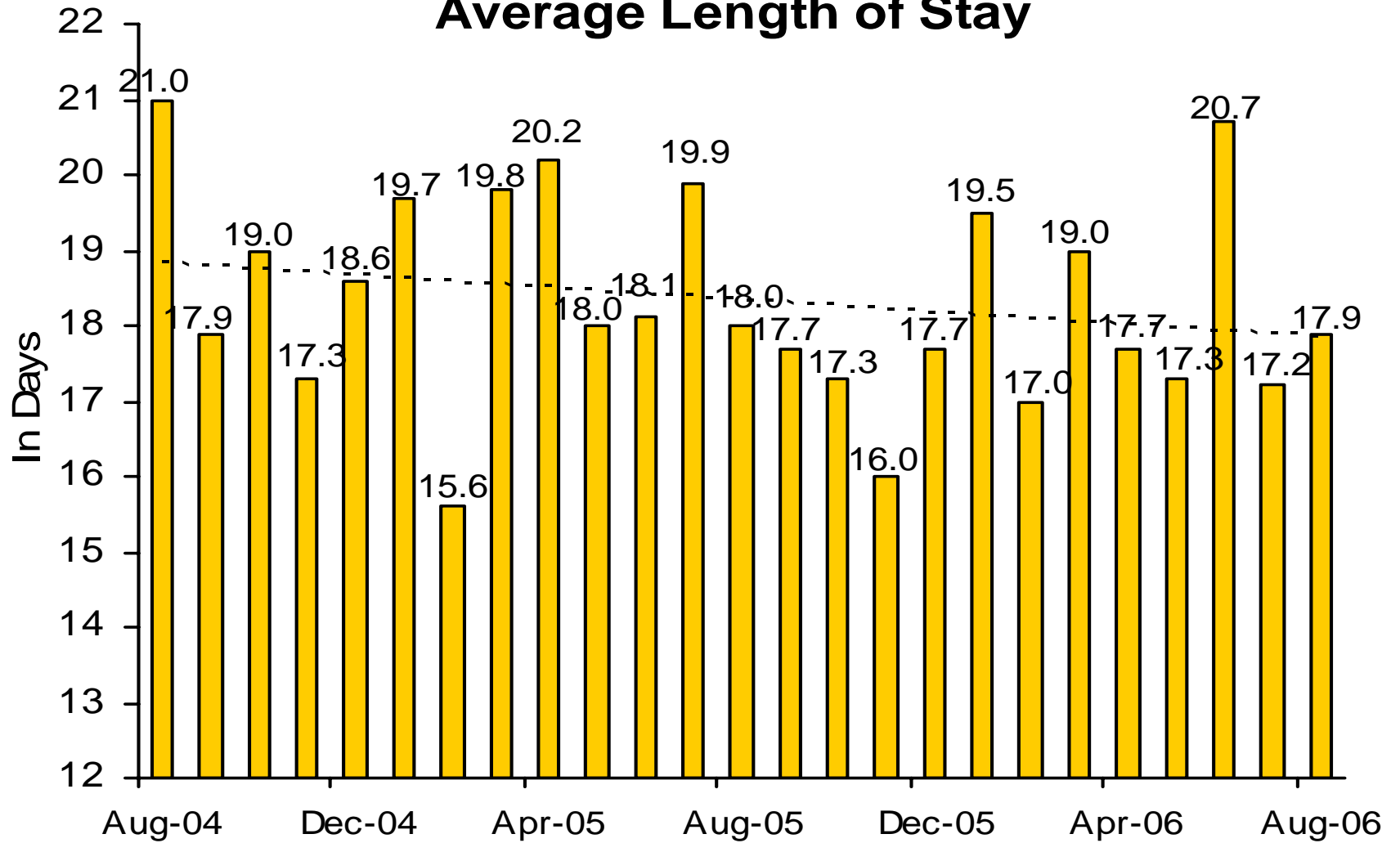
Adult Probation Intensive Supervision Population



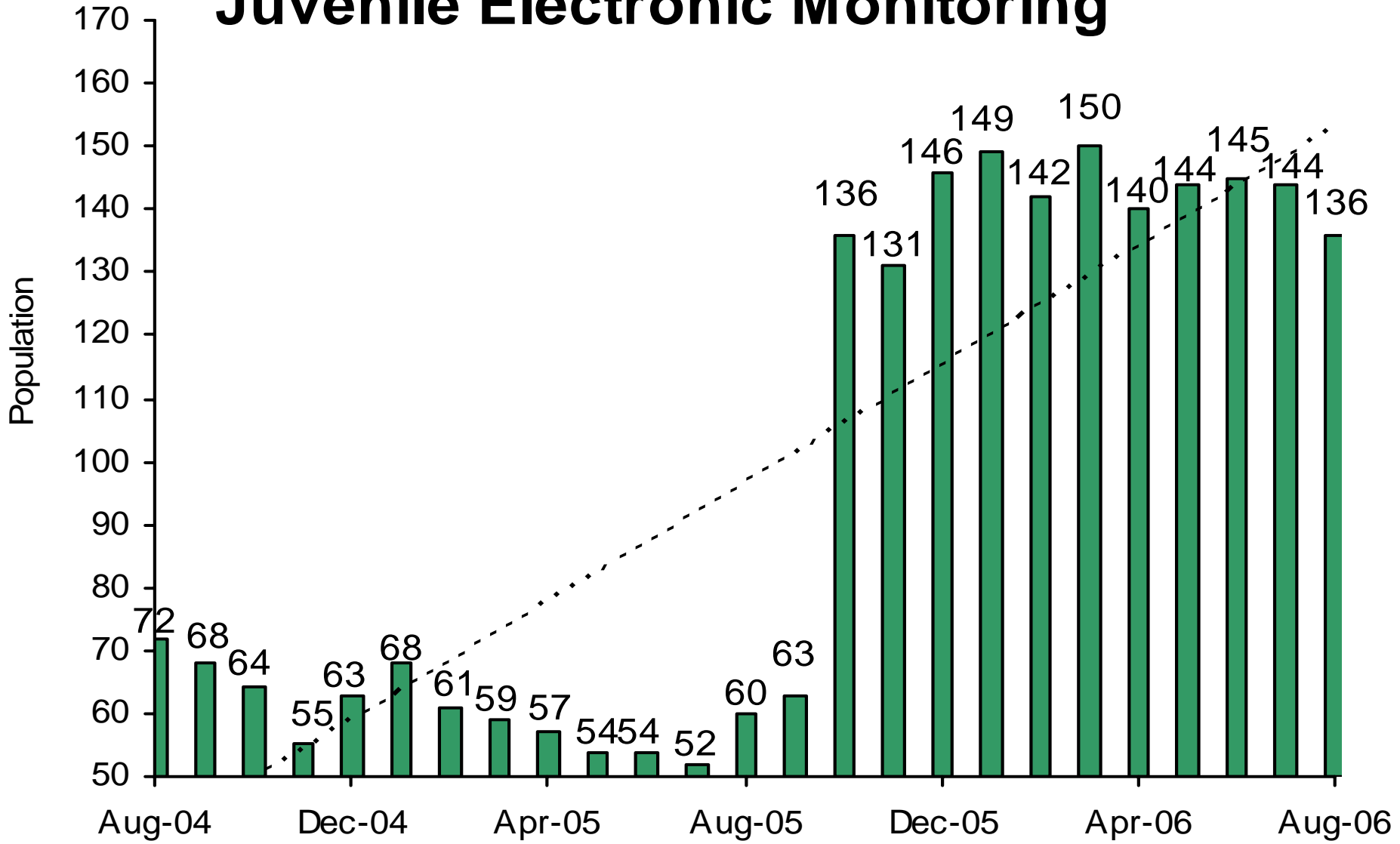
Juvenile Detention Average Daily Population



Juvenile Detention Average Length of Stay

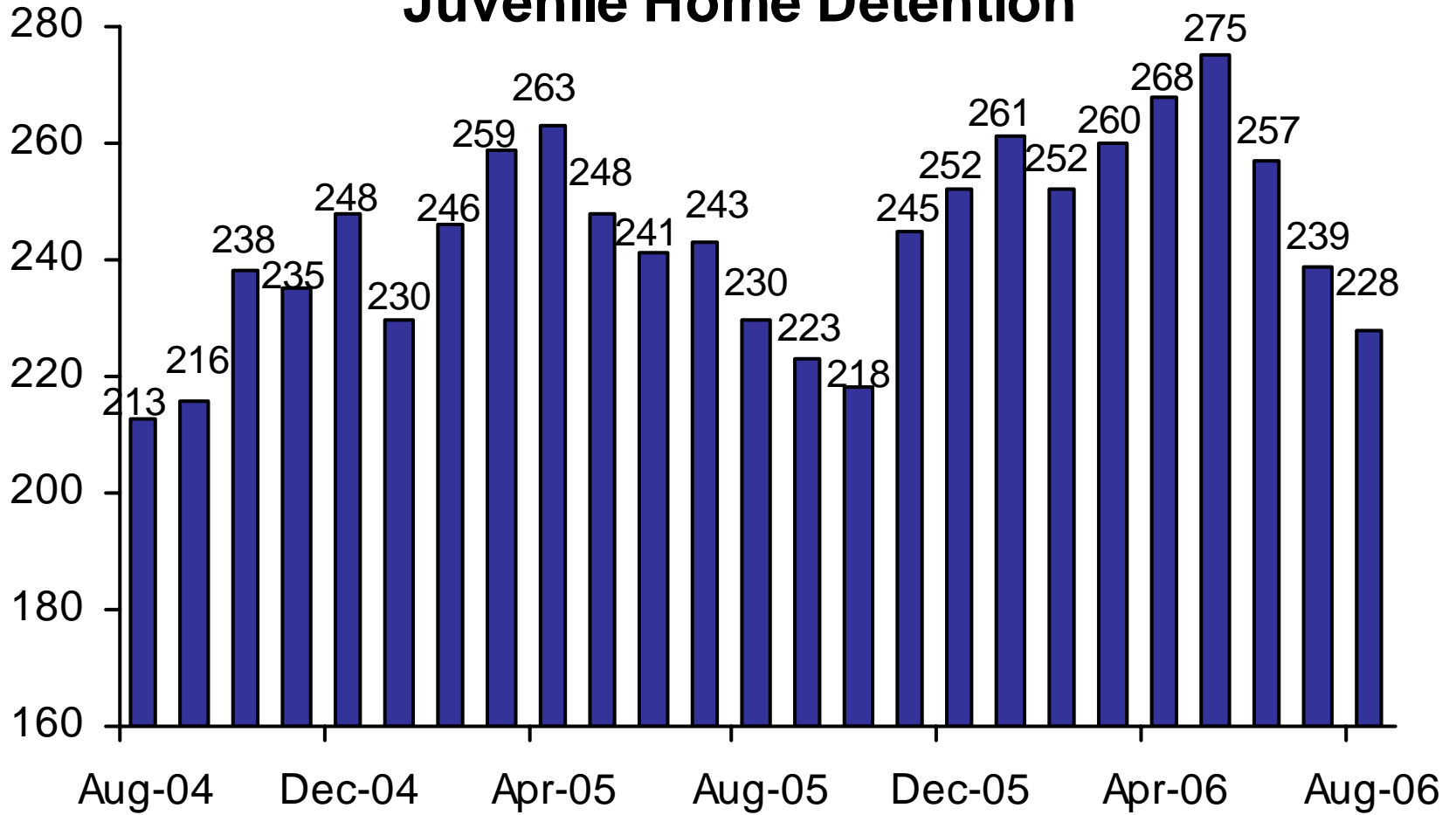


Juvenile Electronic Monitoring
