JUSTICE SYSTEM Monthly Changes – July 2016

Adult Jail Incarceration

- **Bookings decreased** from 7,969 in June to 7,801 in July.
- **Releases decreased** from 8,029 in June to 7,901 in July.
- The **Average Daily Population (ADP) decreased** from 7,363 in June to 7,359 in July.
- The **Pretrial ADP increased** from 5,455 in June to 5,495 in July.
- The **Sentenced ADP decreased** from 1,710 in June to 1,661 in July.
- The **Agency Hold ADP increased** from 156 in June to 165 in July.
- **Overall Average Length of Stay (ALOS) at release increased** from 26.7 in June to 28.8 in July.
- The **ALOS in days for Pretrial increased** from 7.6 in June to 11.2 in July.
- The **ALOS in days for Sentenced decreased** from 24.6 in June to 23.2 in July.
- The **ALOS in days for Agency Holds increased** from 76 in June to 81 in July.

Superior Court Filings & Case Processing

- **New Criminal Case Filings decreased** from 2,578 in June to 2,467 in July.
- **Case Terminations decreased** from 2,319 in June to 2,211 in July.
- The resulting **Clearance Rate** was 89.6%.
- The **Active Pending Case Inventory increased** from 10,493 in June to 10,558 in July.
- **Regional Court Center filings decreased** from 1,308 in June to 1,166 in July.
- **Early Disposition Court filings increased** from 954 in June to 984 in July.
- The **Number of Trials Completed increased** from 30 in June to 35 in July.
- The **Trial Rate** was 1.4%.

Justice Court Filings

- **DUI Filings increased** from 621 in June to 626 in July.
- **All other Criminal Traffic Filings decreased** from 3,328 in June to 3,237 in July.
- **Civil Traffic Filings decreased** from 10,229 in June to 9,679 in July.
- **Eviction Action Filings increased** from 5,290 in June to 5,701 in July.
- **Total Filings decreased** from 26,323 in June to 25,854 in July.

Adult Probation

- **Adult Standard Probation Supervision increased** from 24,117 in June to 24,307 in July.
- **Adult Intensive Probation Supervision increased** from 1,001 in June to 1,021 in July.
- **Adult Unsupervised Probation Supervision increased** from 3,913 in June to 4,092 in July.
- **Pretrial General Supervision** was at 2,194 in July.
- **Pretrial Electronic Monitoring** was at 772 in July.

Juvenile Detention and Probation

- The **Average Daily Detention Population decreased** from 165 in June to 147 in July.
- The **ALOS in Juvenile Detention increased** from 19.4 in June to 20.9 in July.
- **Juvenile Standard Probation decreased** from 1,670 in June to 1,611 in July.
- **Juvenile Intensive Probation decreased** from 191 in June to 189 in July.
- **Monthly commitments to Arizona Department of Juvenile Corrections increased** from 10 in June to 18 in July.

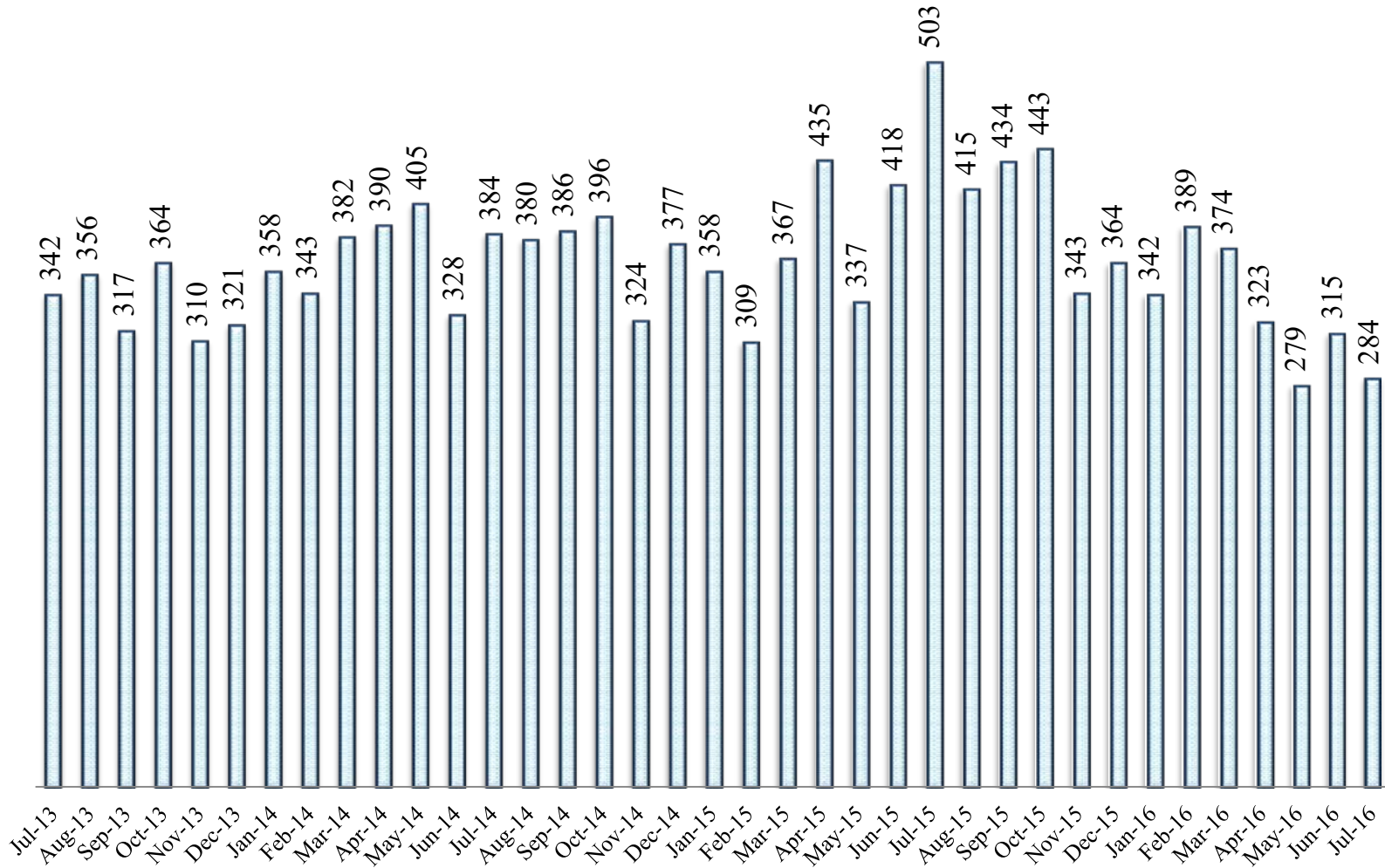

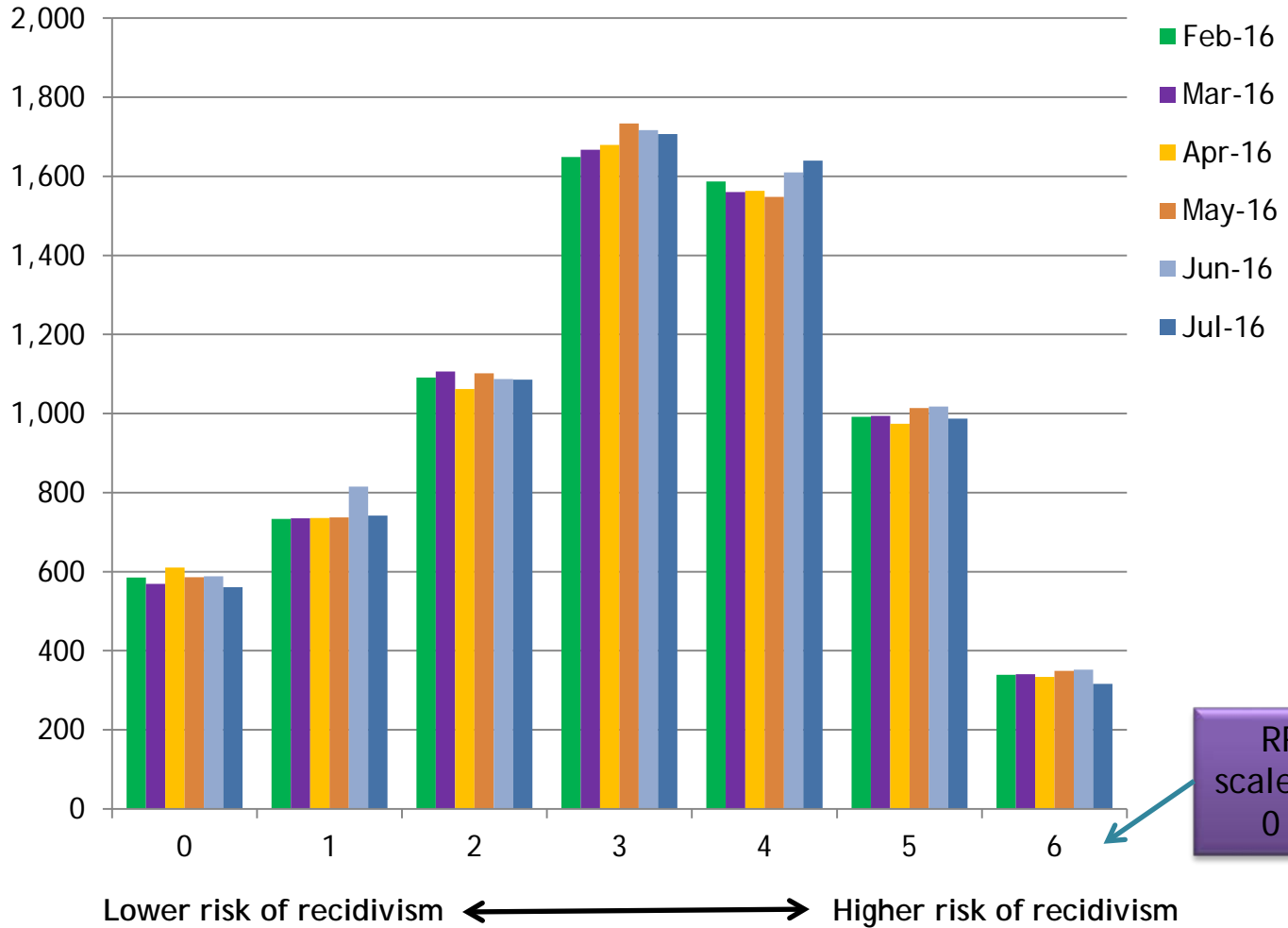

Number of Dependency Petitions Filed Juvenile Court



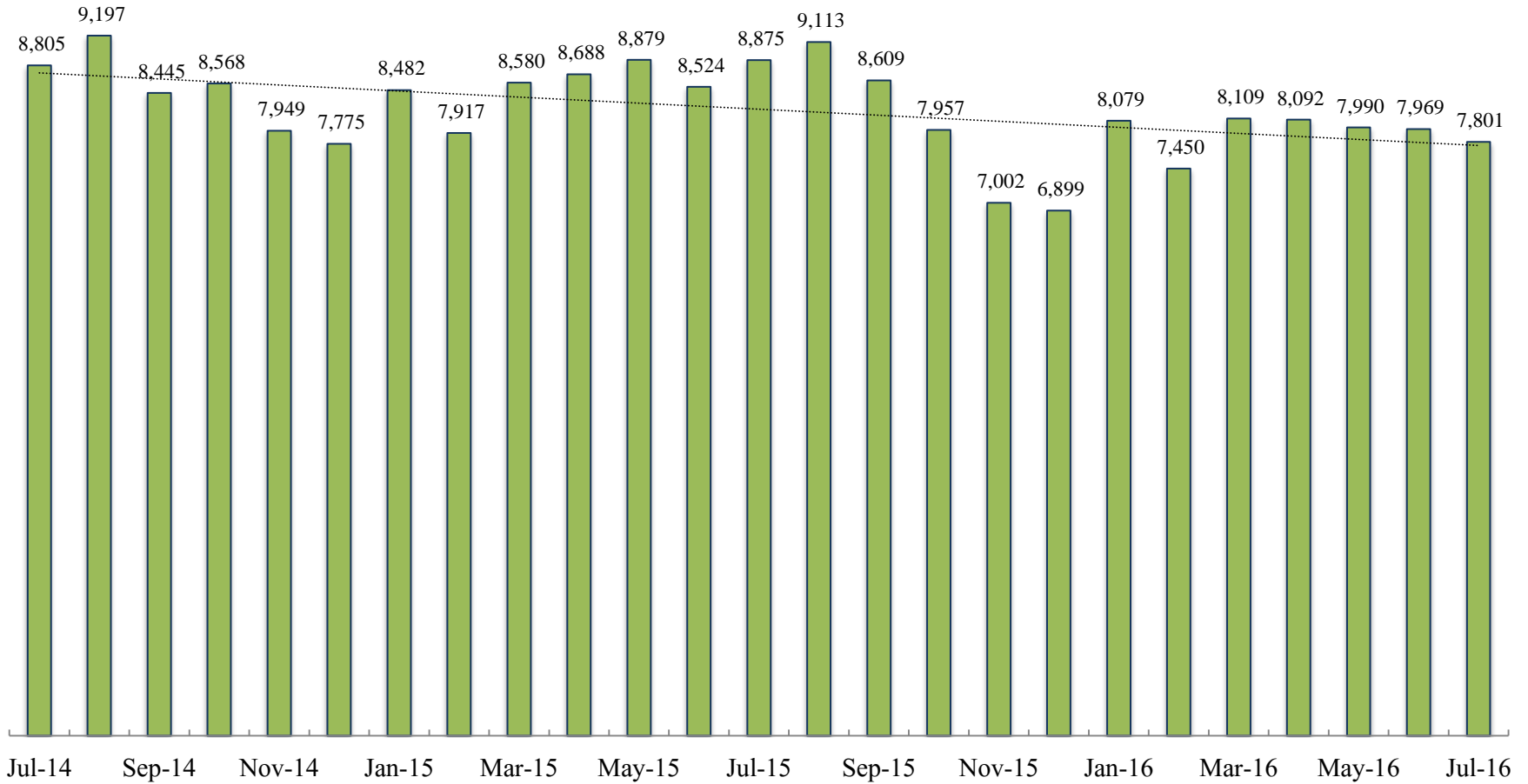

Recidivism Risk Score (RRS / "Proxy") Distribution Among Current Jail Population:

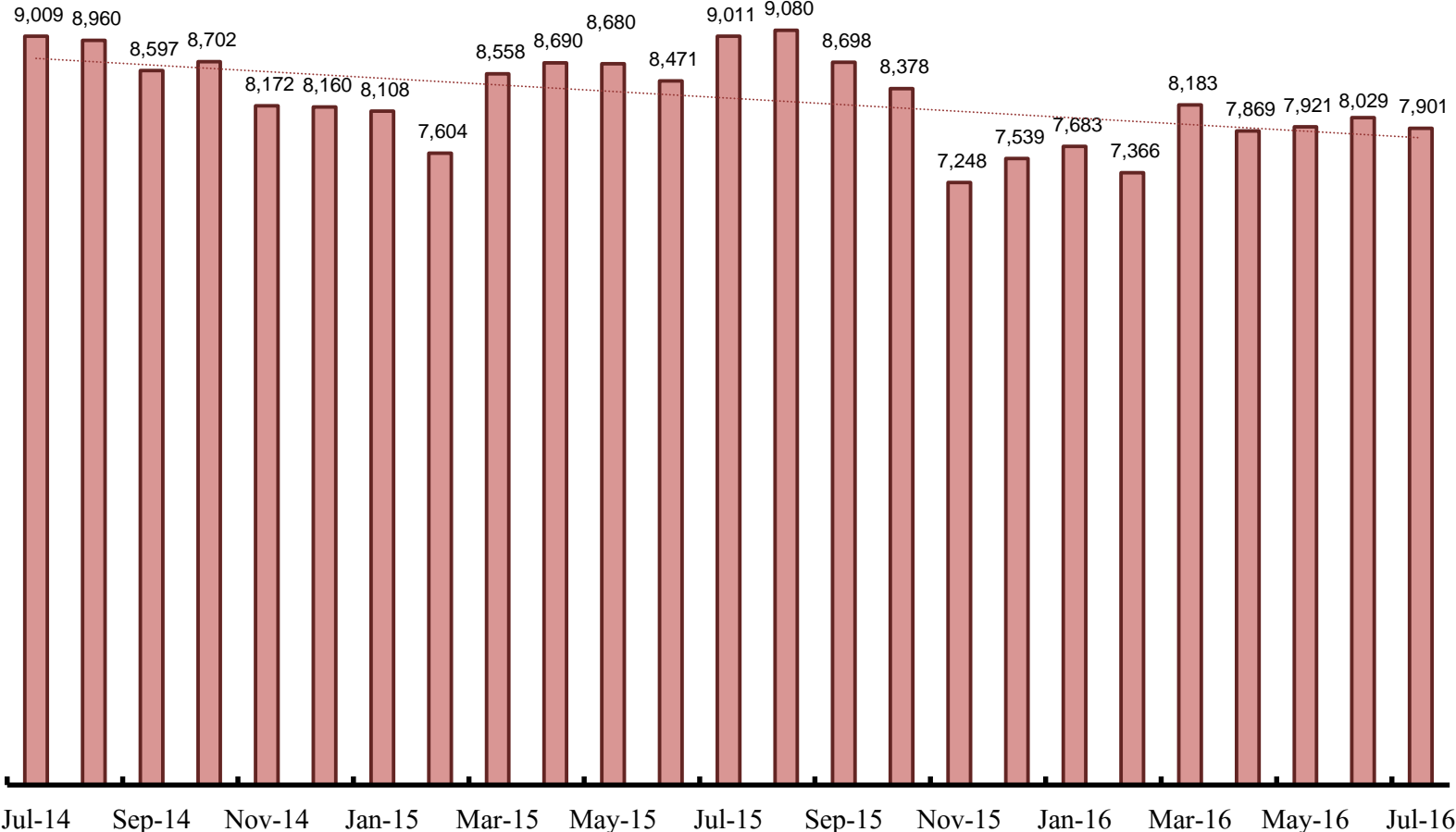

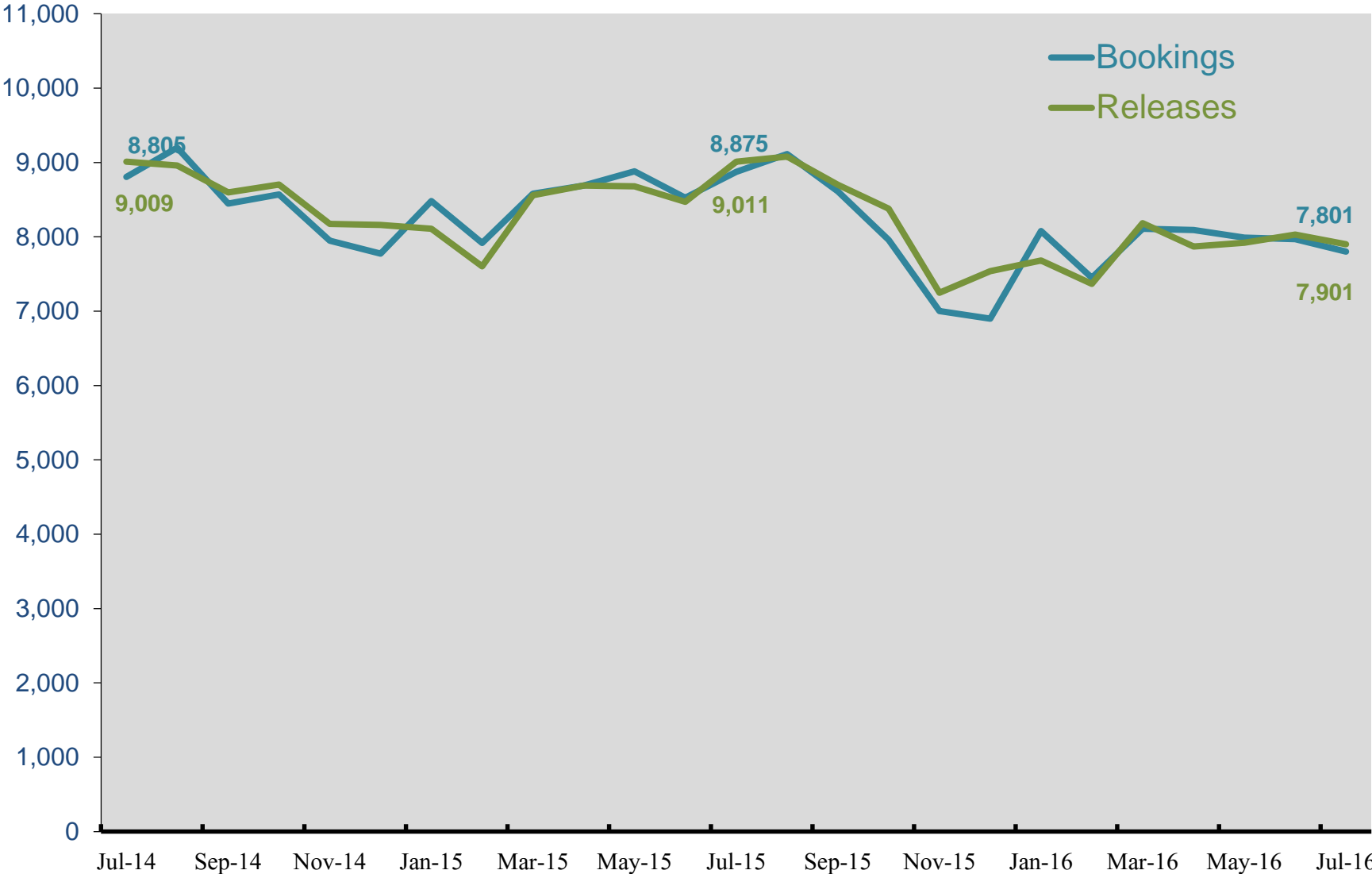

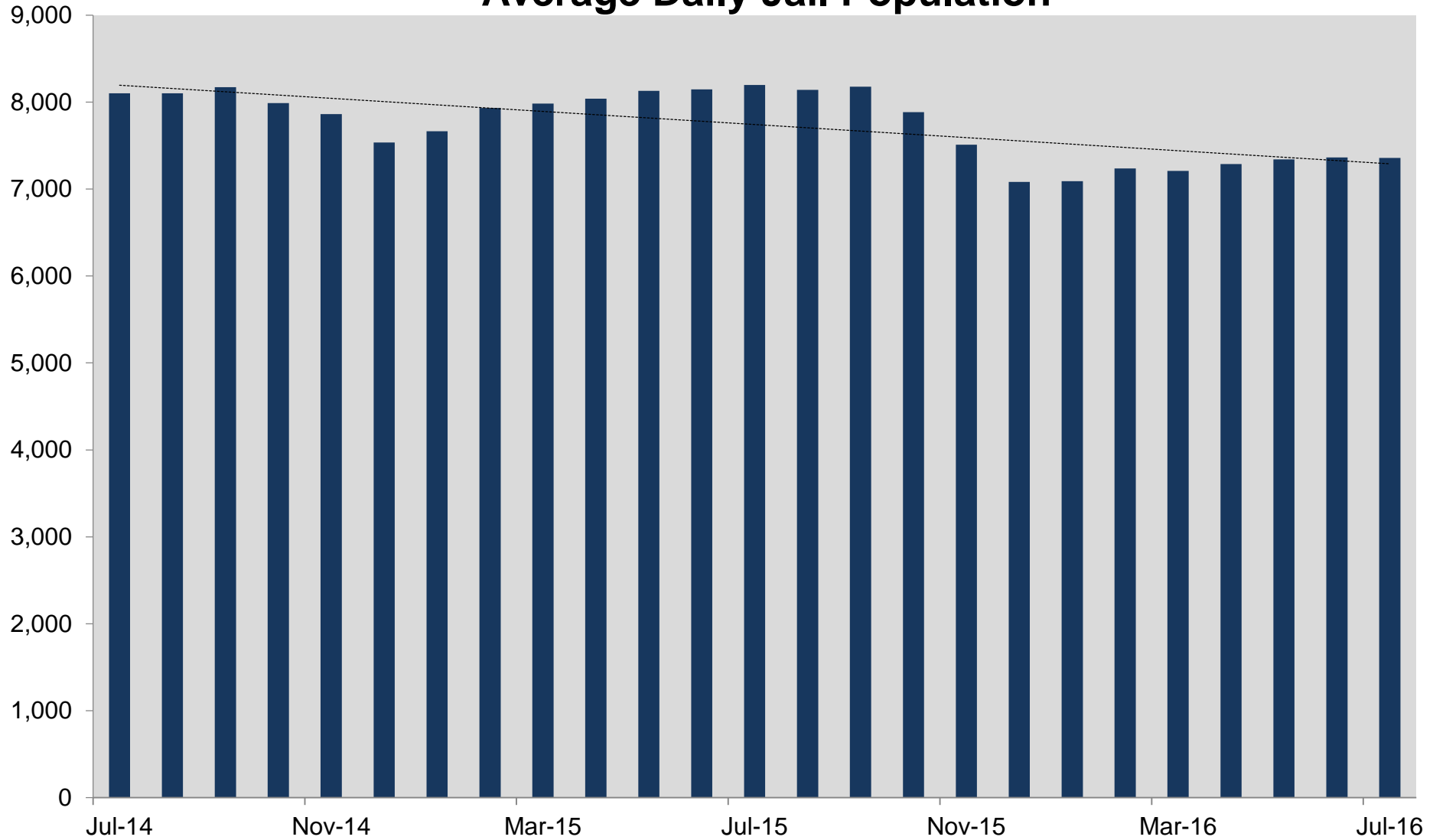
Jail Releases

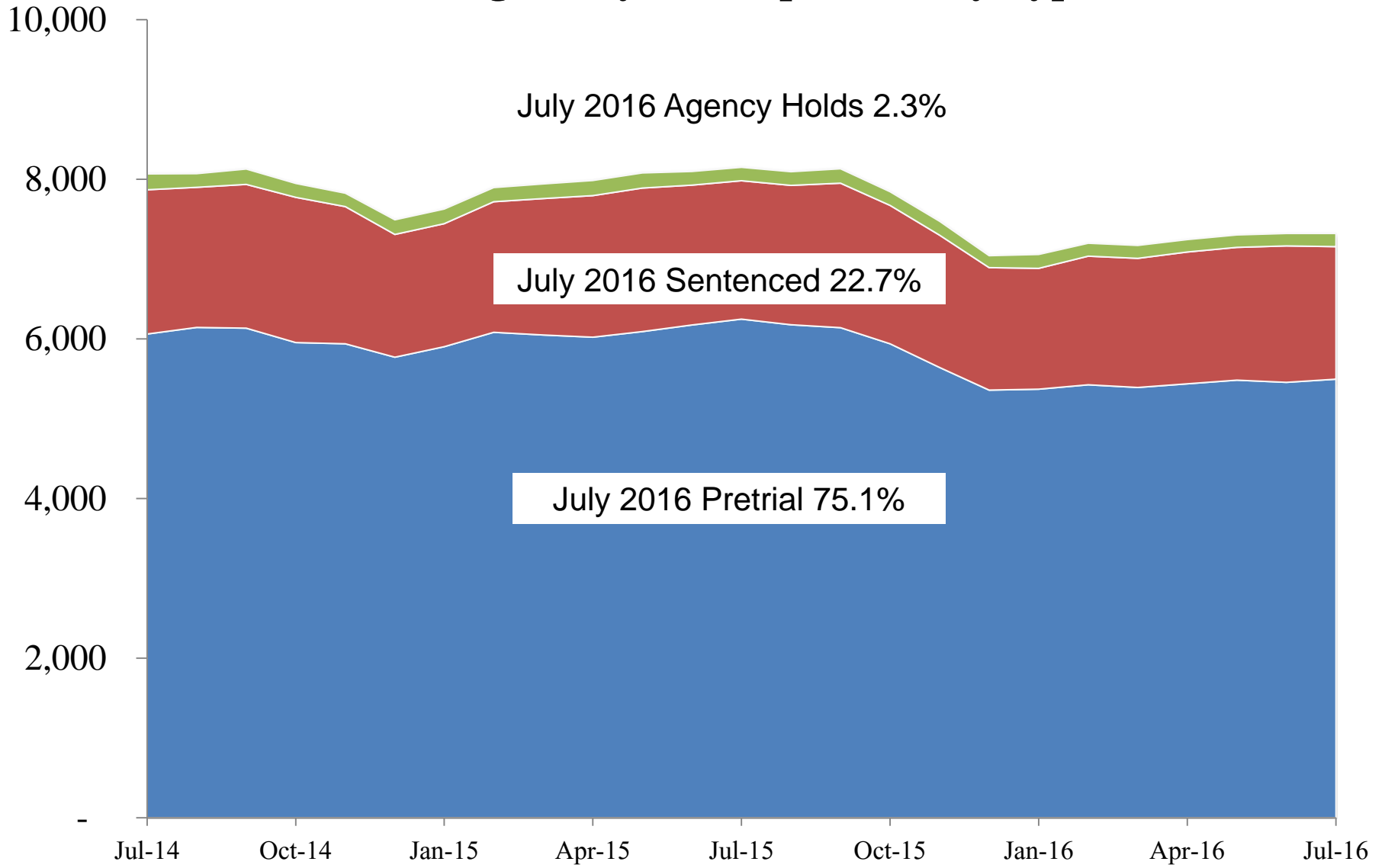


Average Daily Jail Population

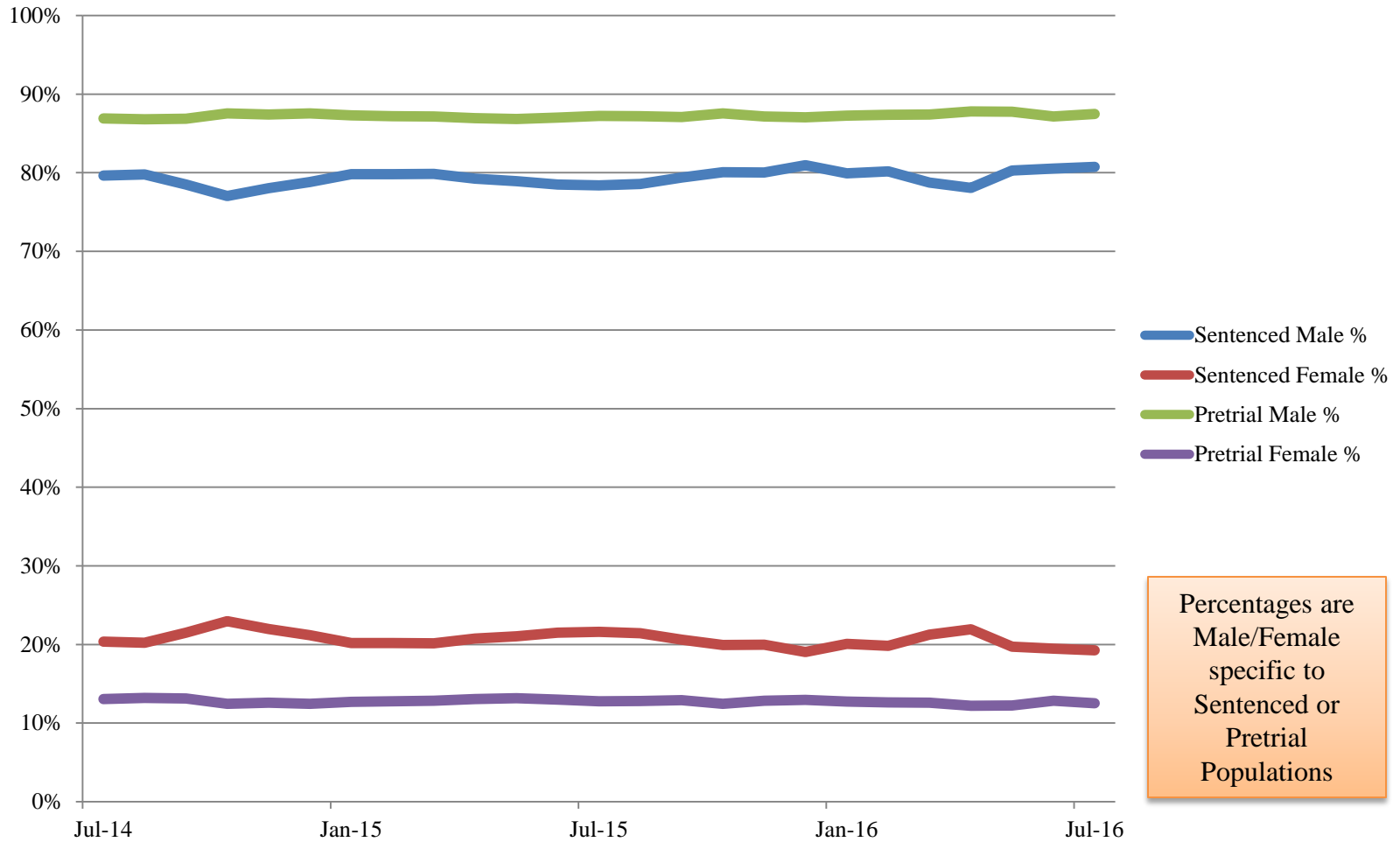

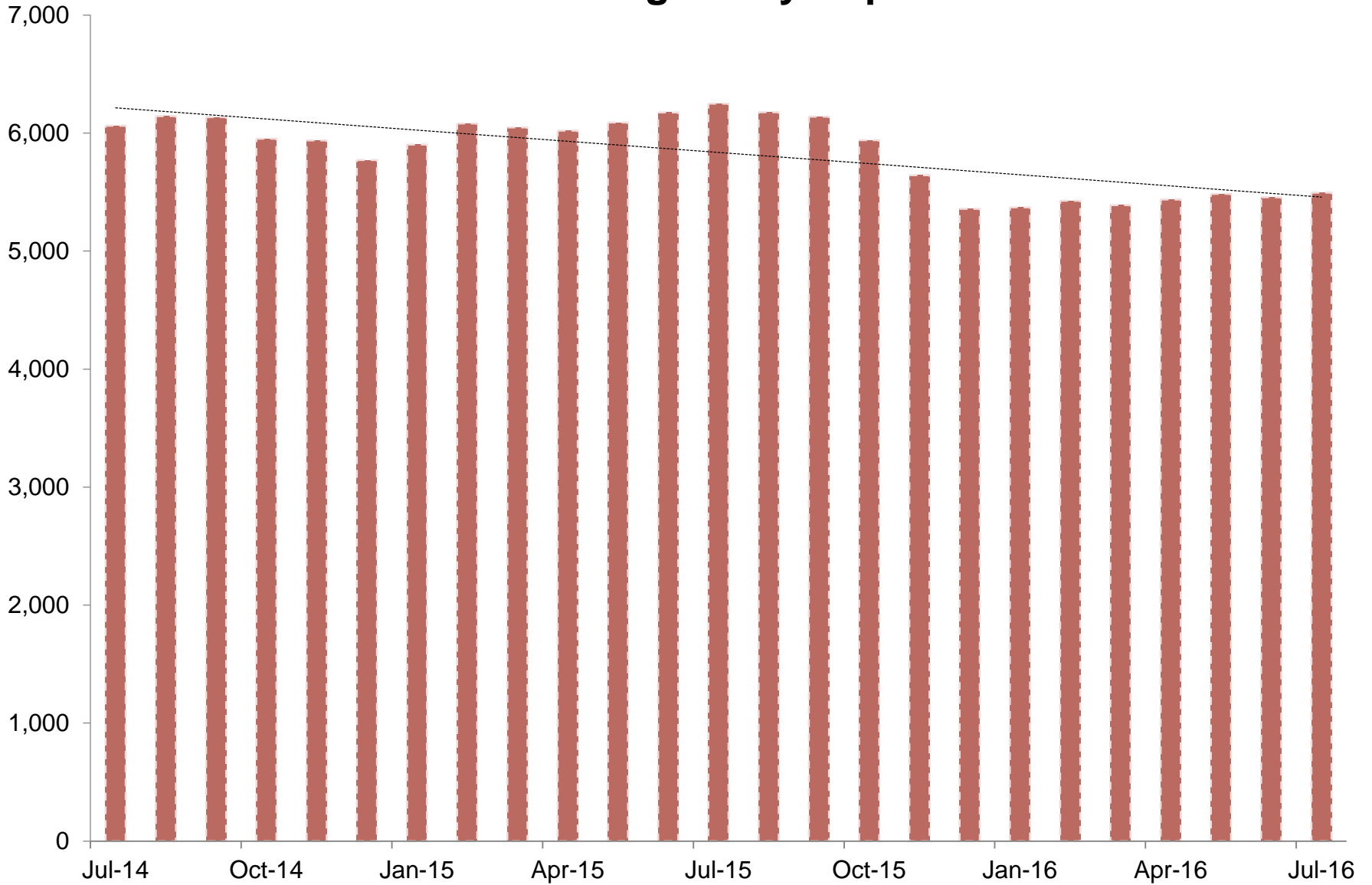
Average Daily Jail Population by Type



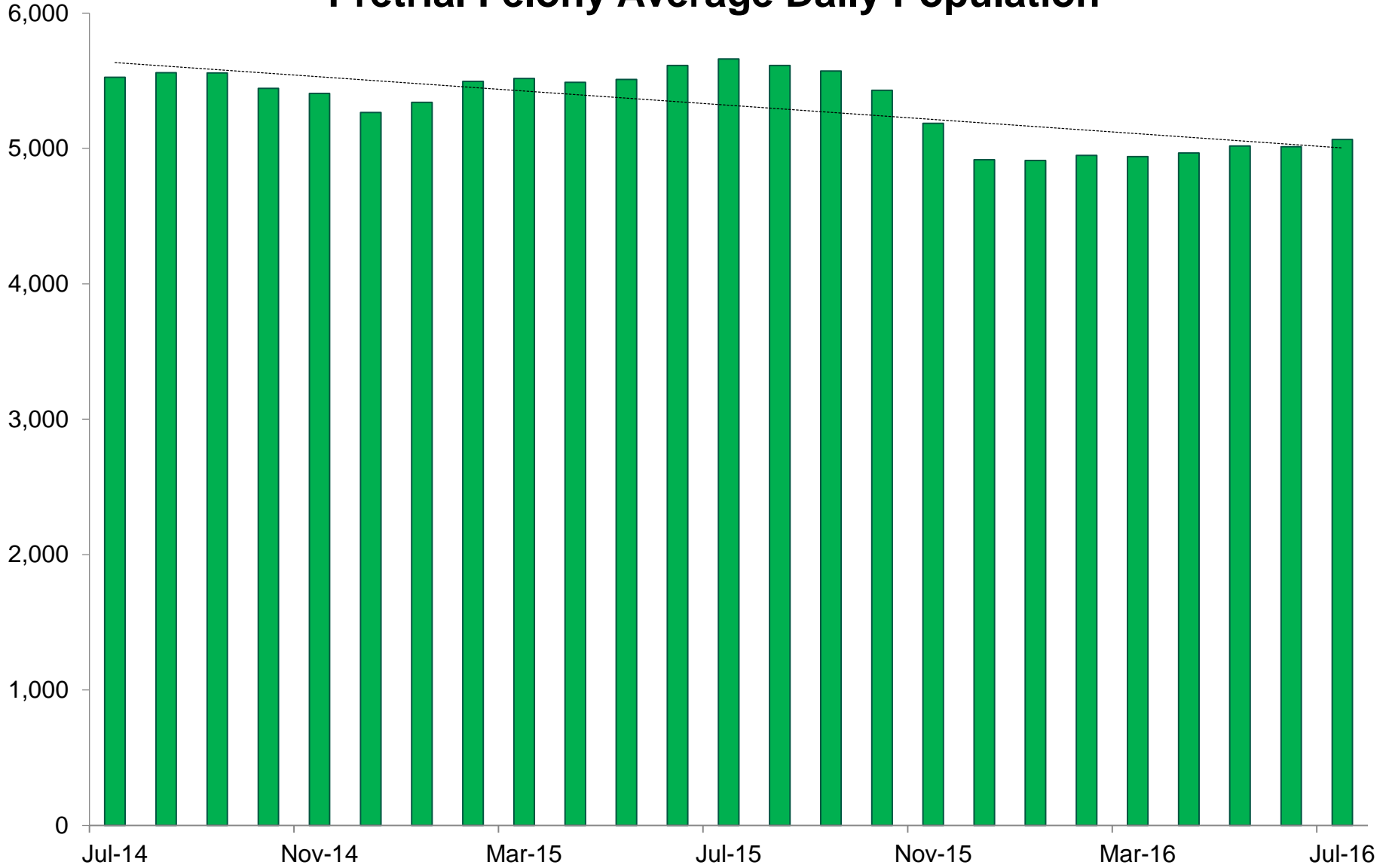
Average Daily Jail Population by Gender



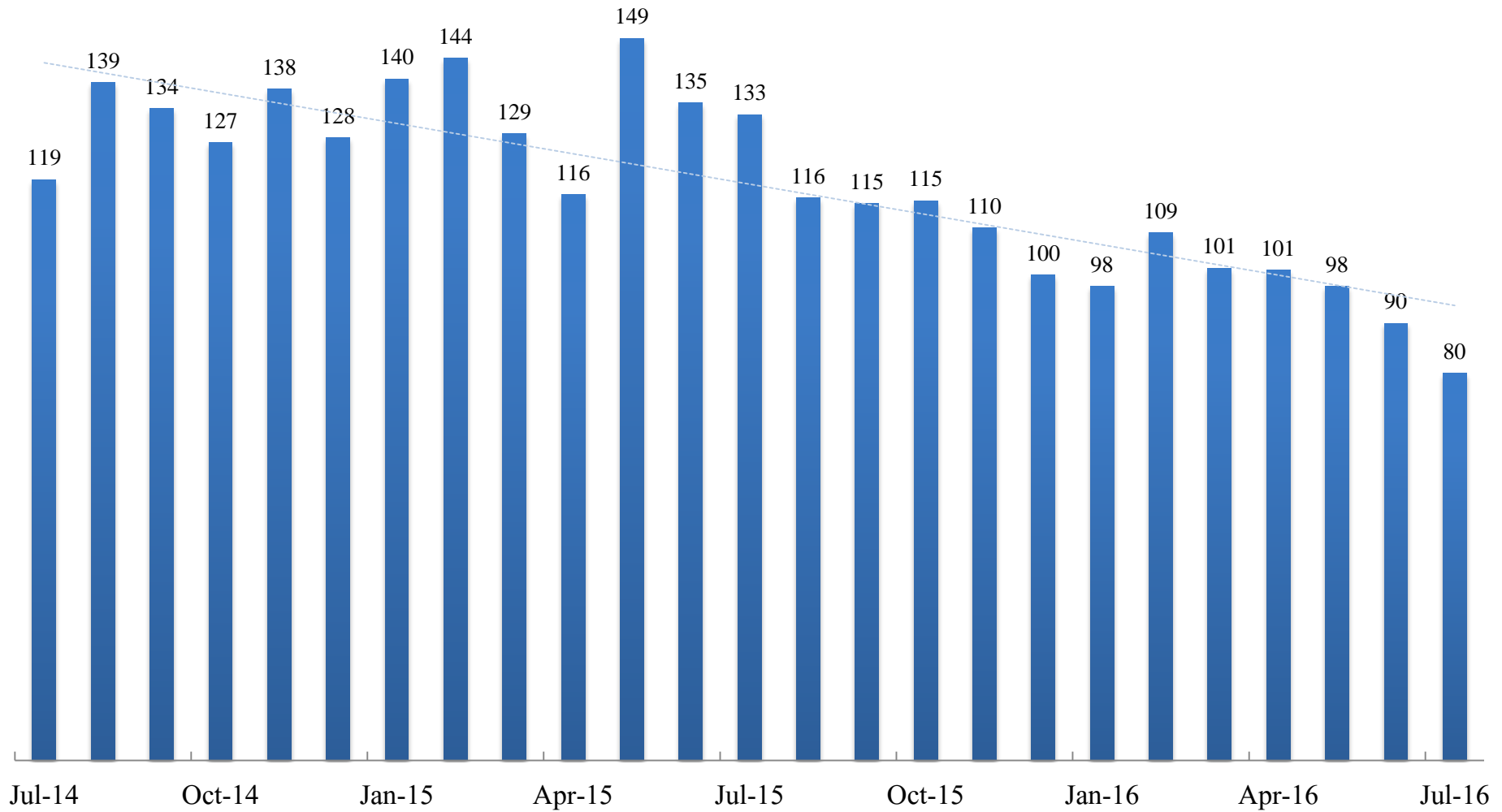
Pretrial Average Daily Population



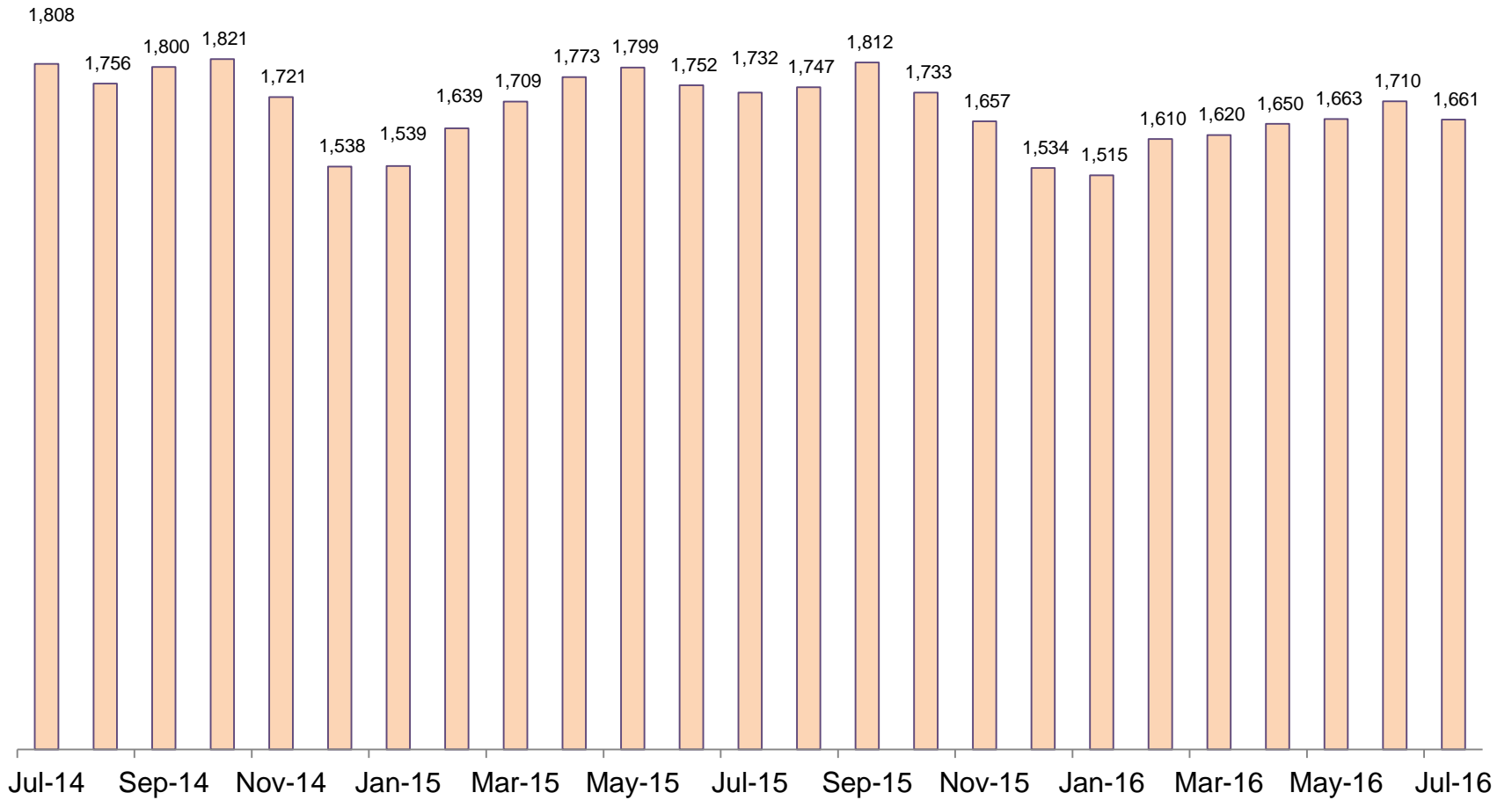
Pretrial Felony Average Daily Population



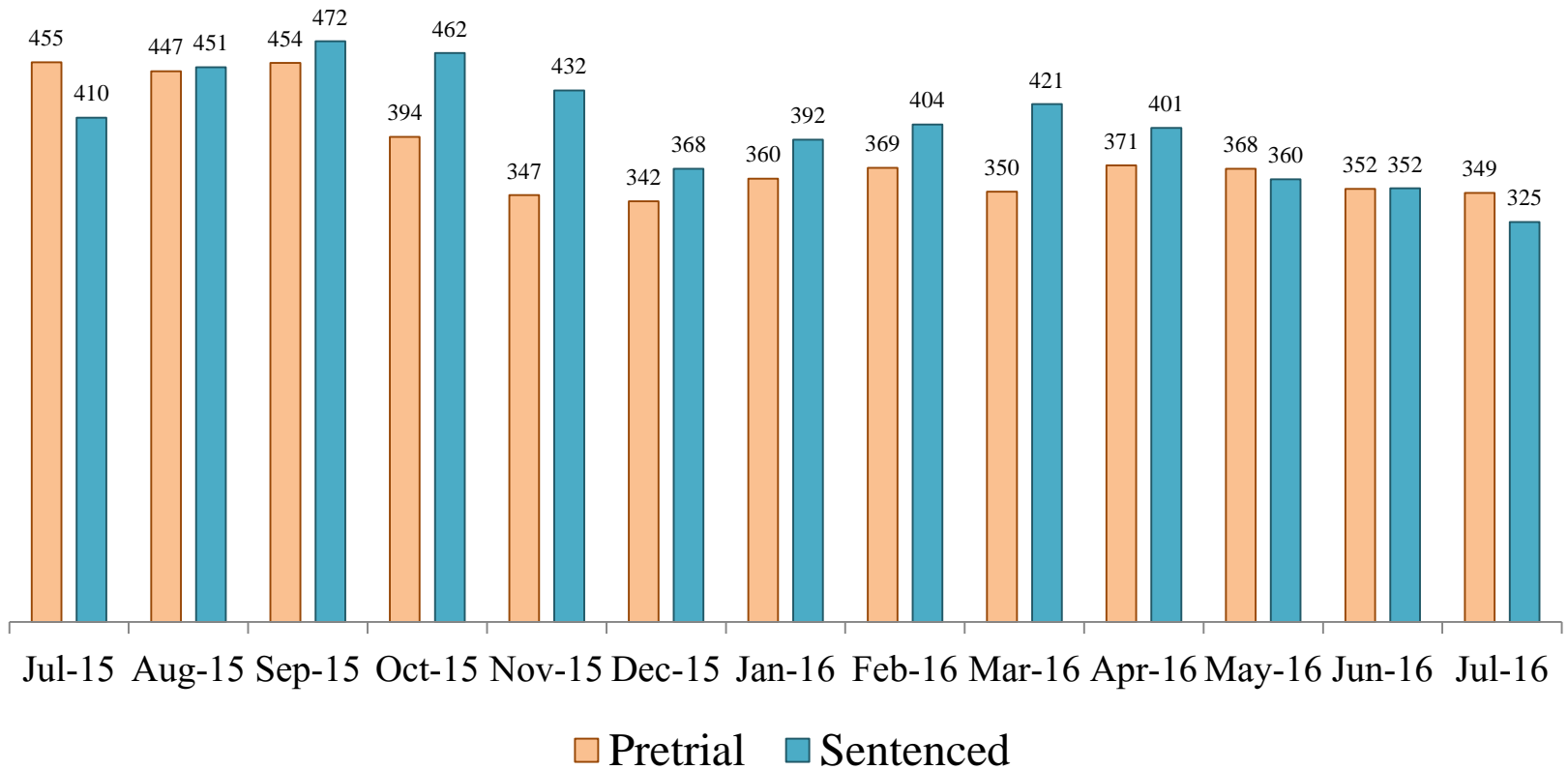
Pretrial Misdemeanor Average Daily Population



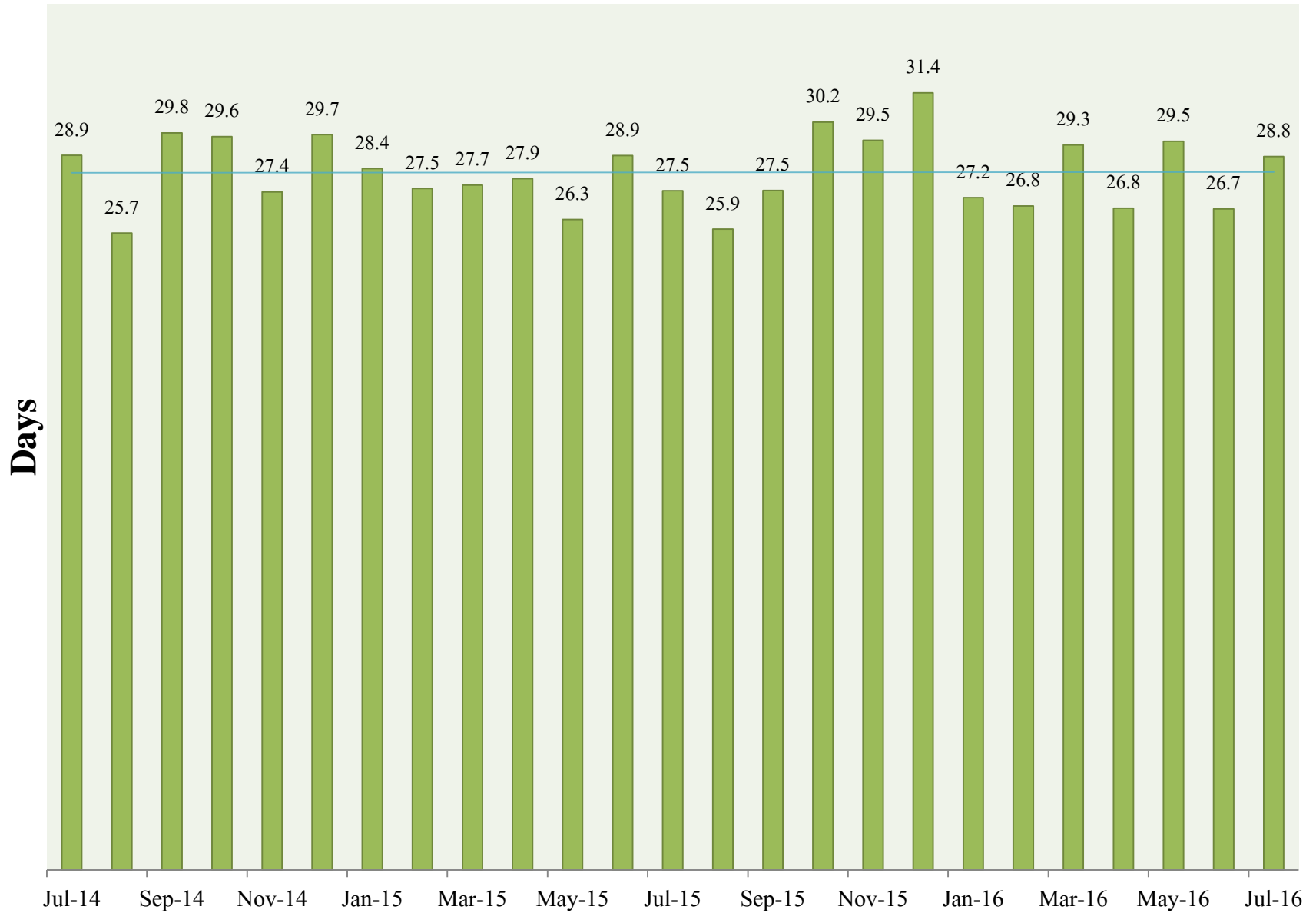
Sentenced Average Daily Population



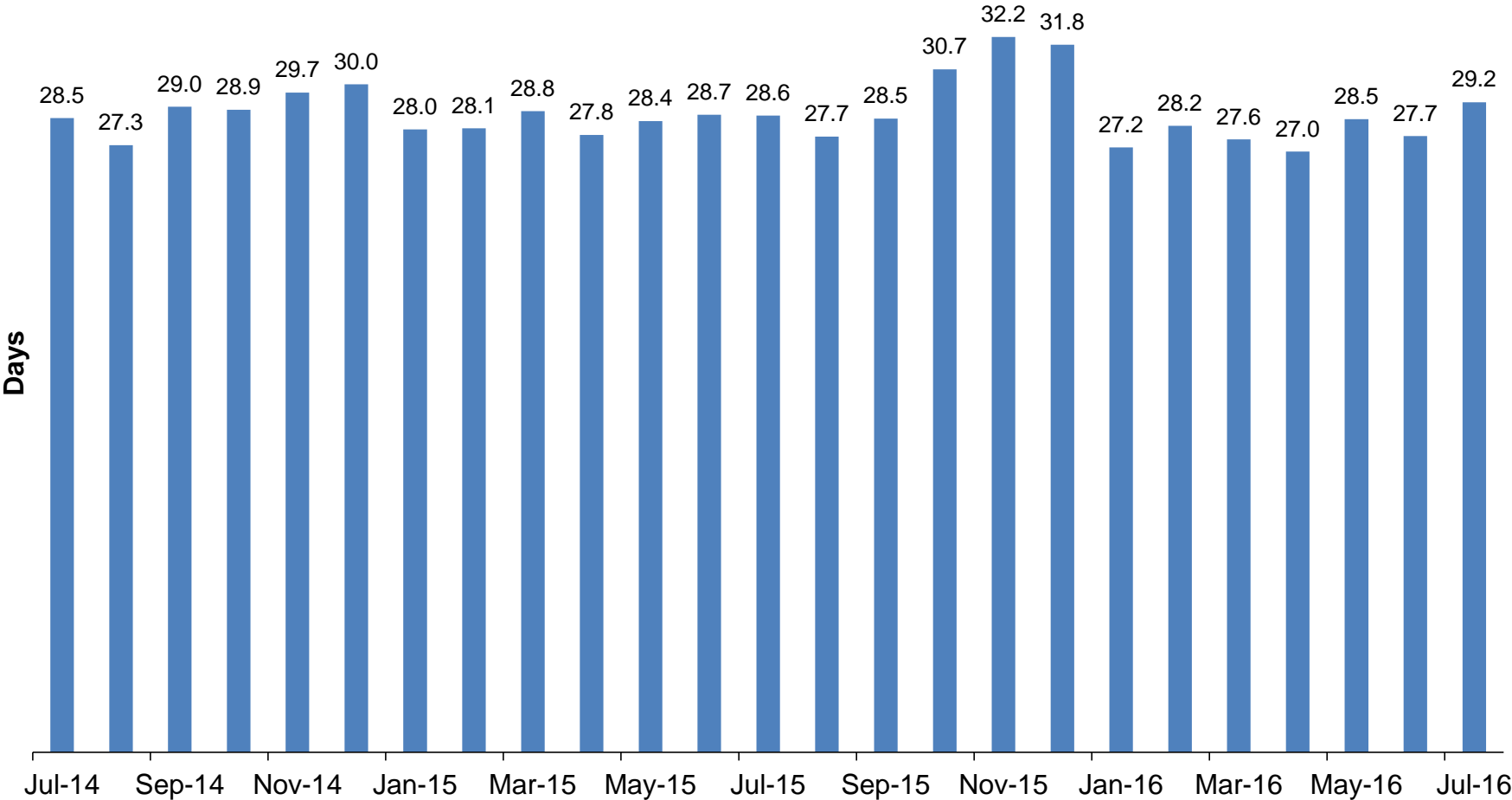
Average Daily Jail Population of City Offenders



Overall Average Length of Stay in Jail at Release

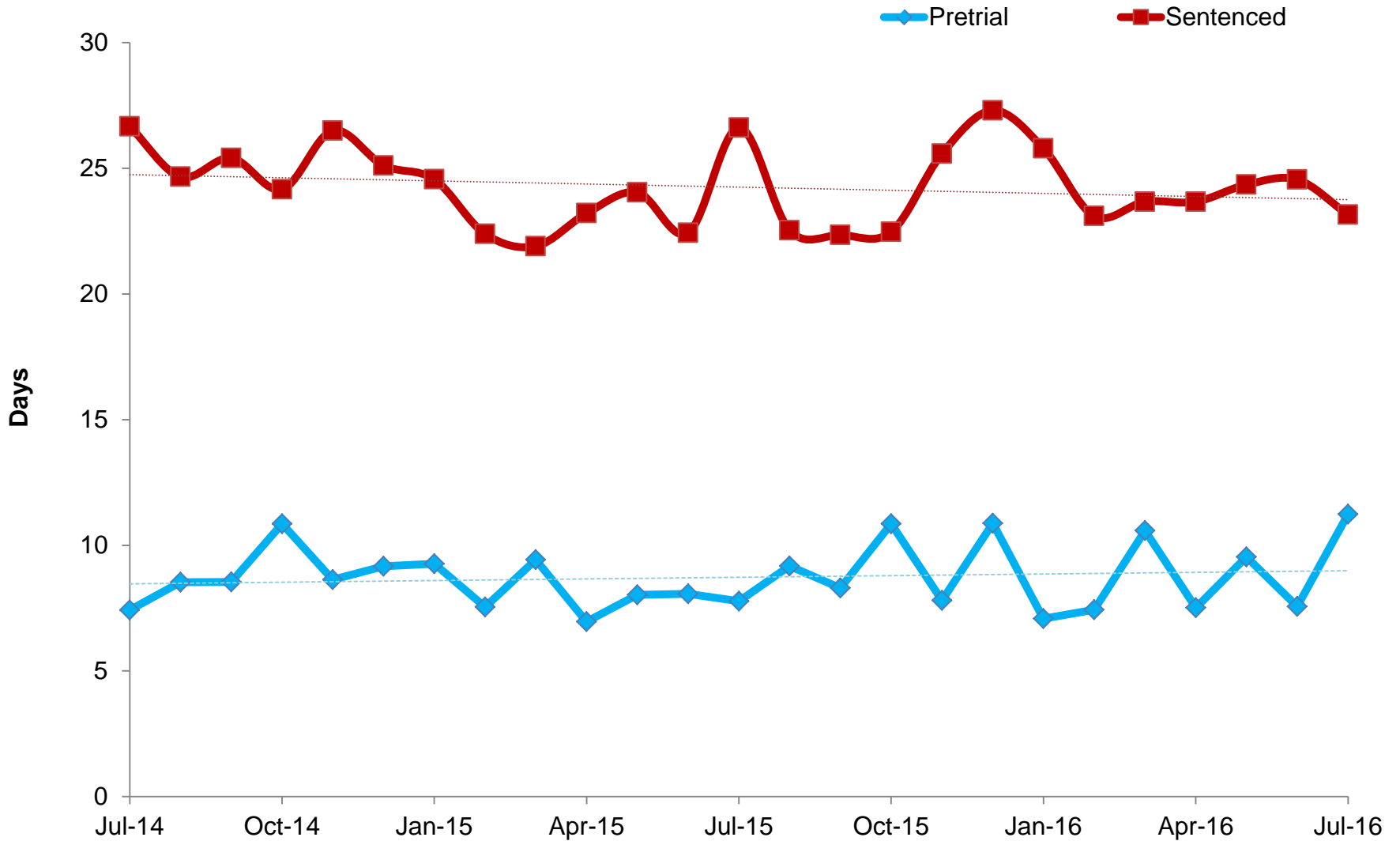


Overall Average Length of Stay in Jail In Custody*

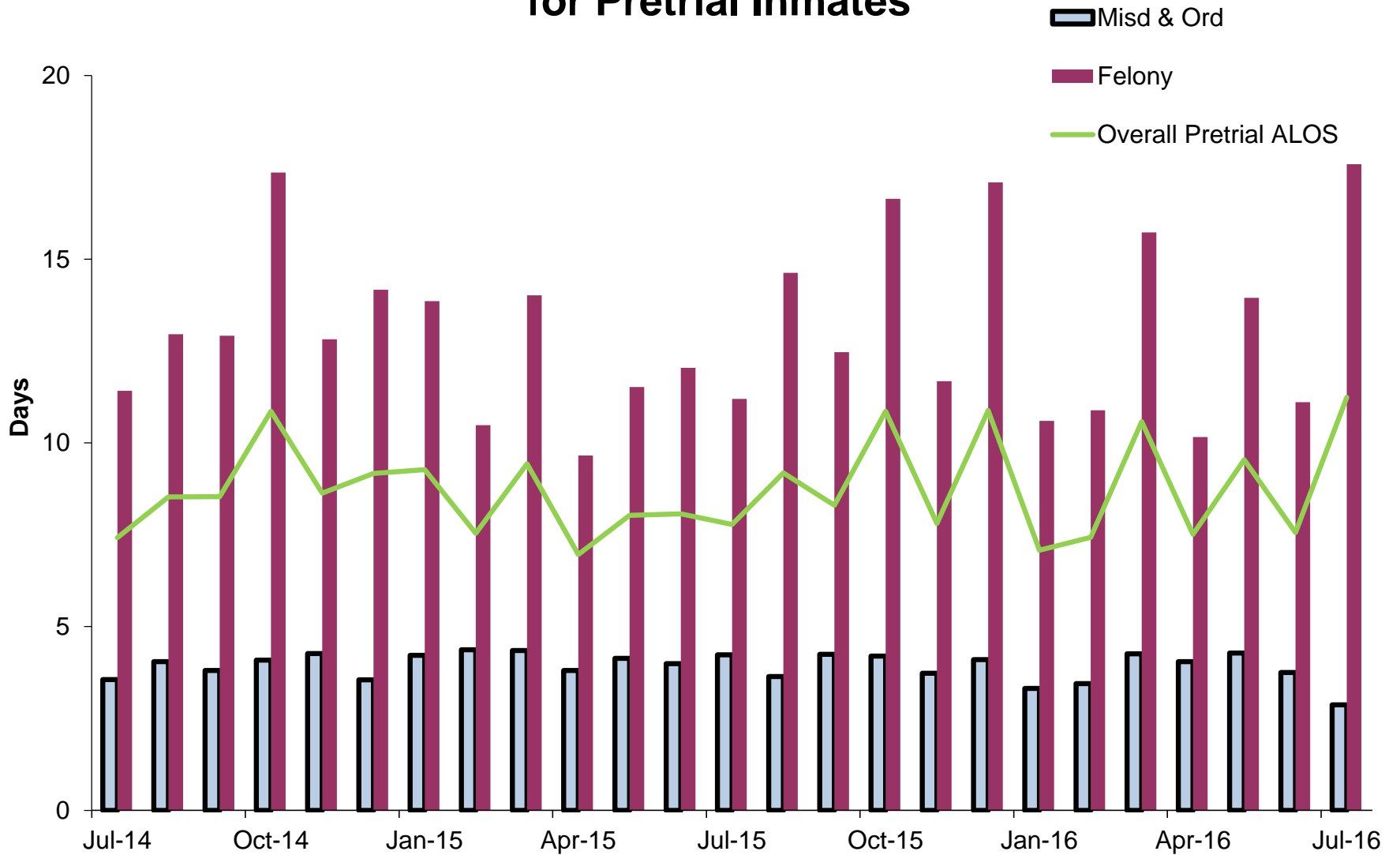

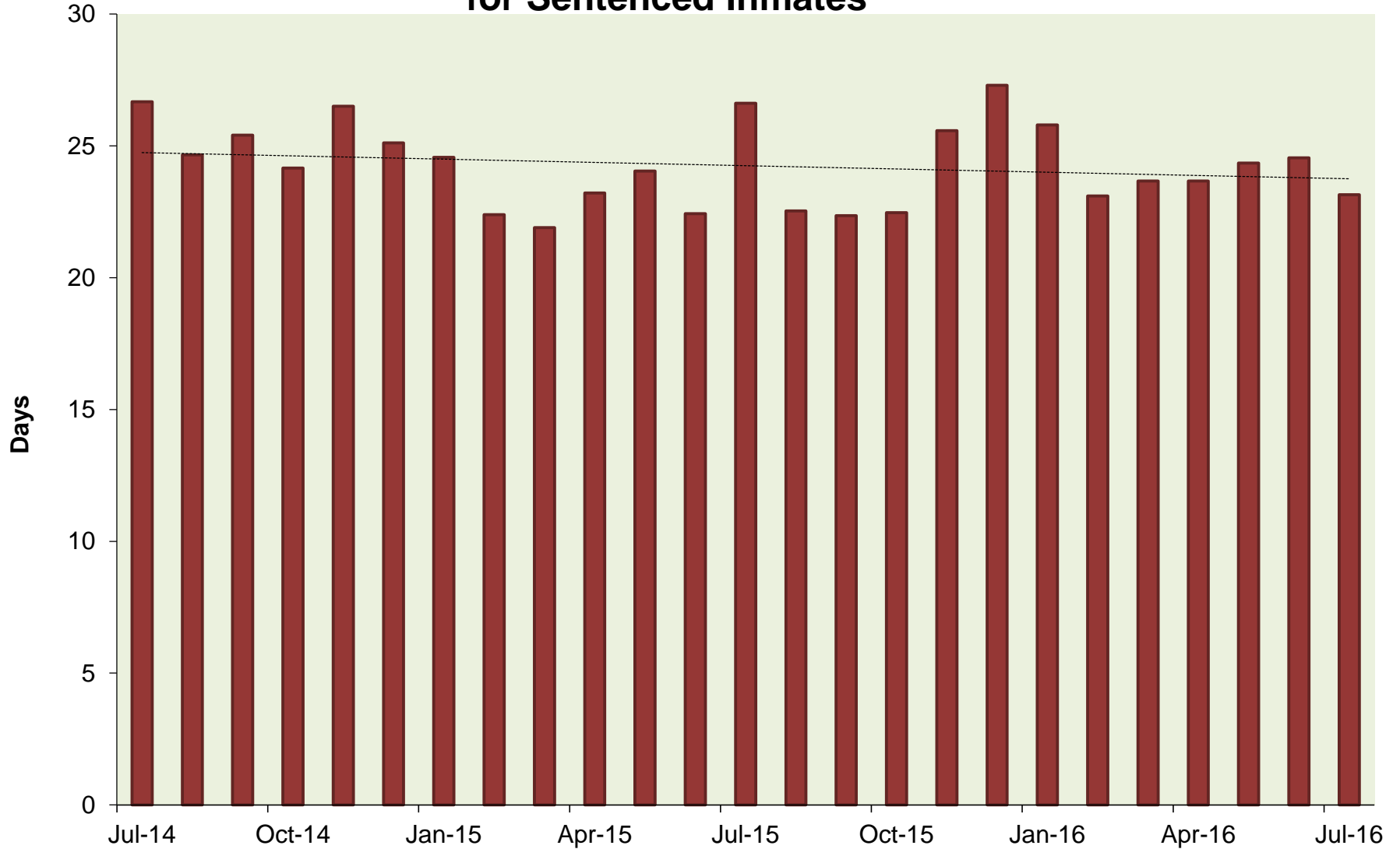
Average Length of Stay in Jail Pretrial and Sentenced Inmates



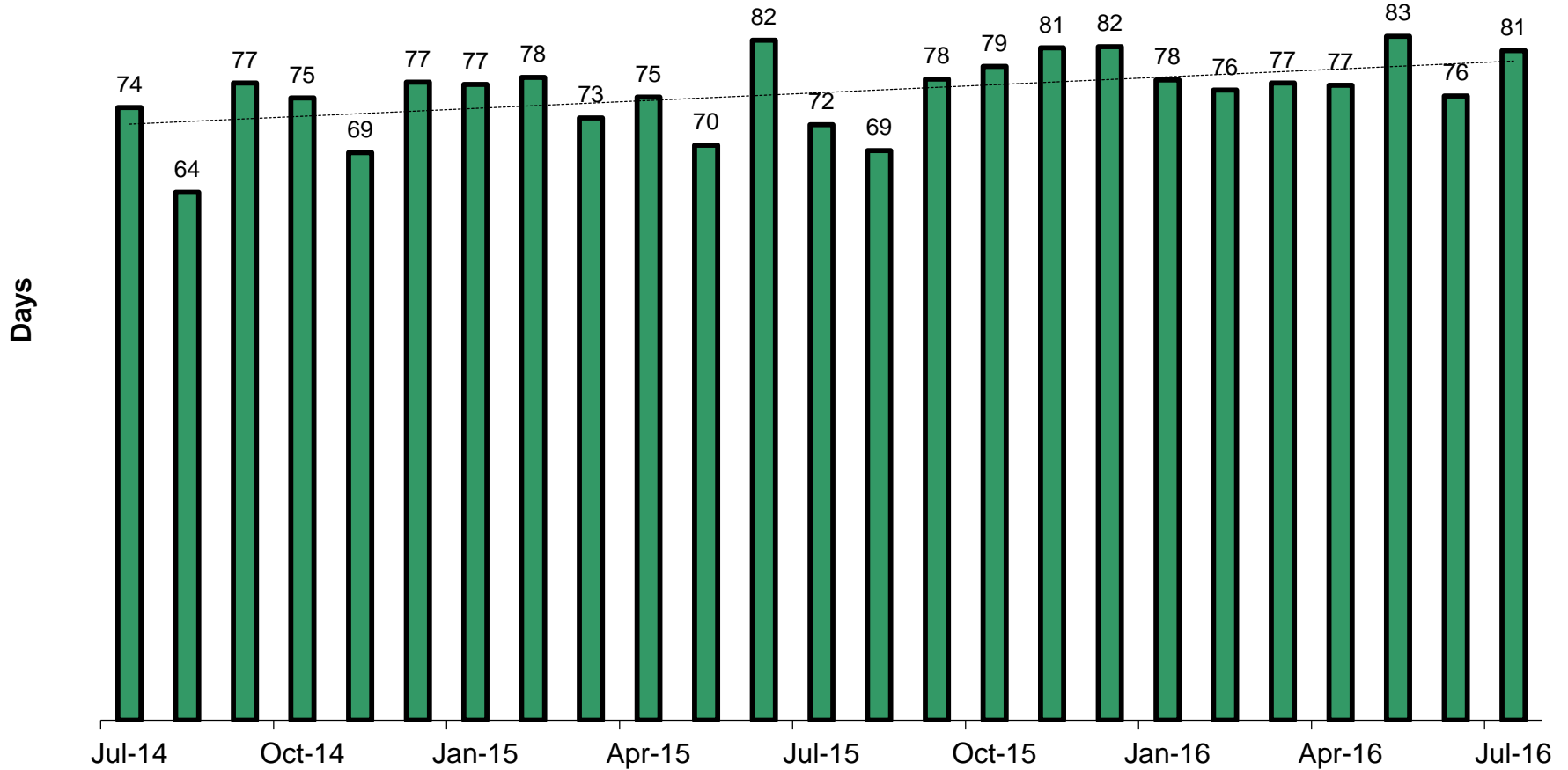
Average Length of Stay in Jail for Pretrial Inmates



Average Length of Stay in Jail for Sentenced Inmates

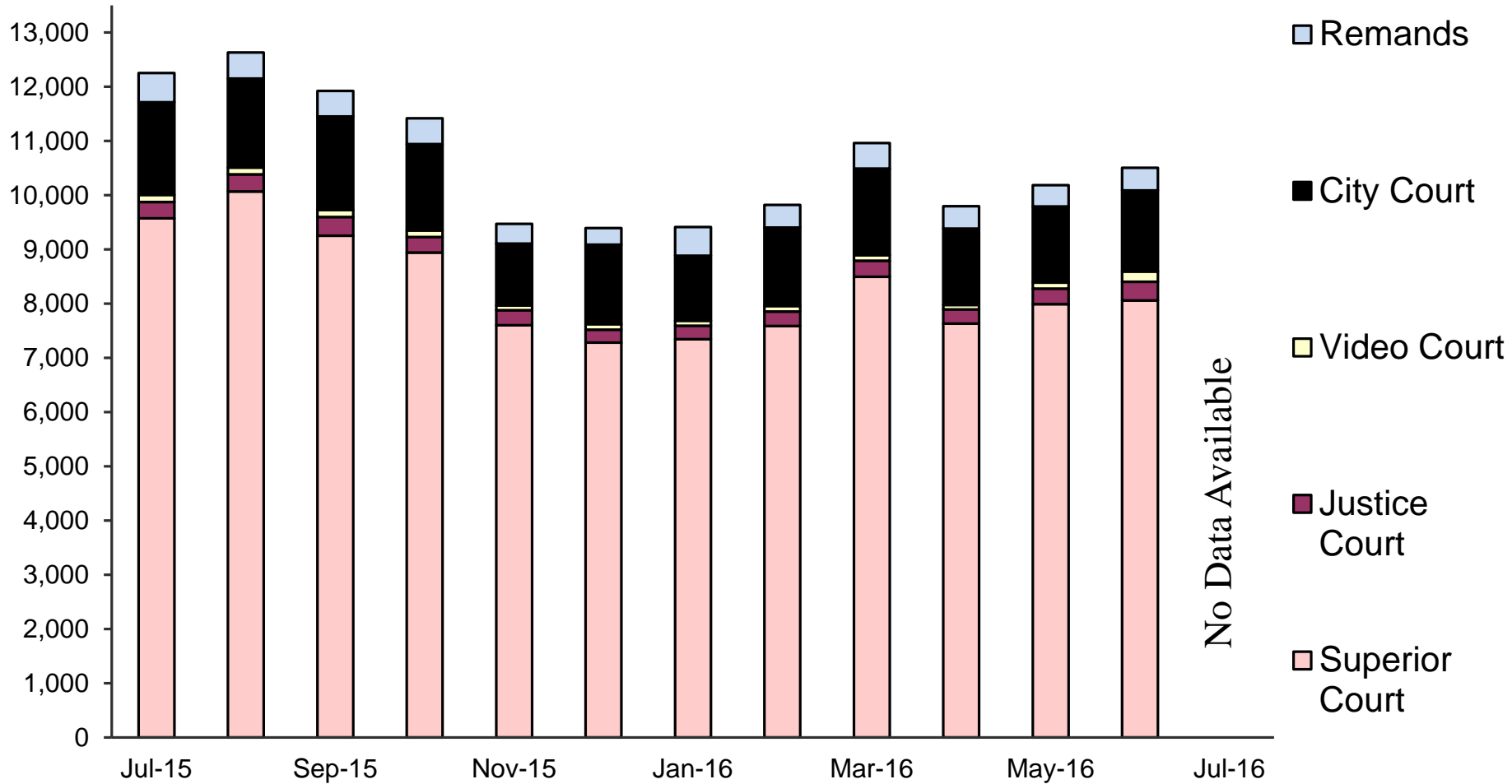


Average Length of Stay in Jail Agency Holds



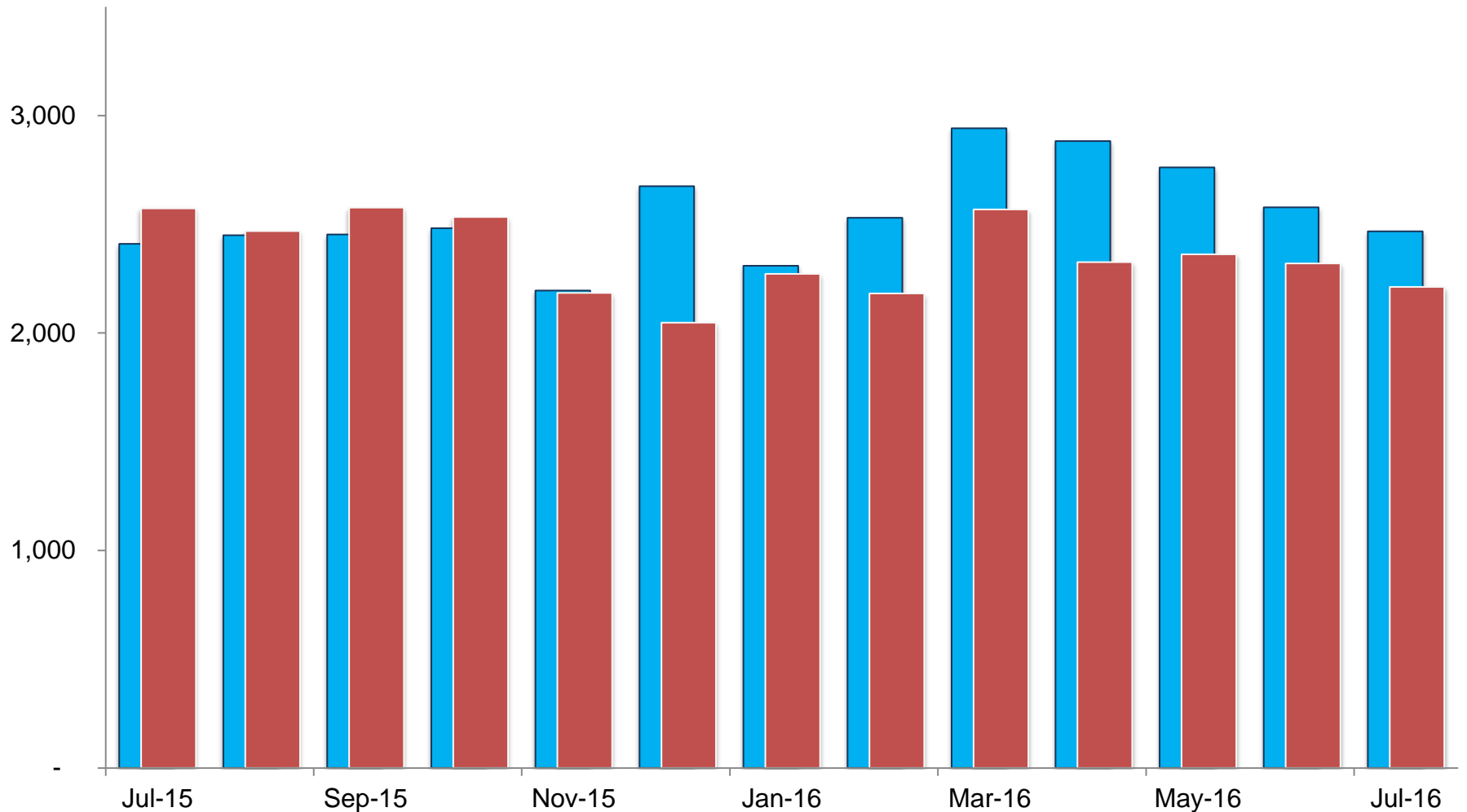

Sheriff's Office Transports for Inmate Court Appearances



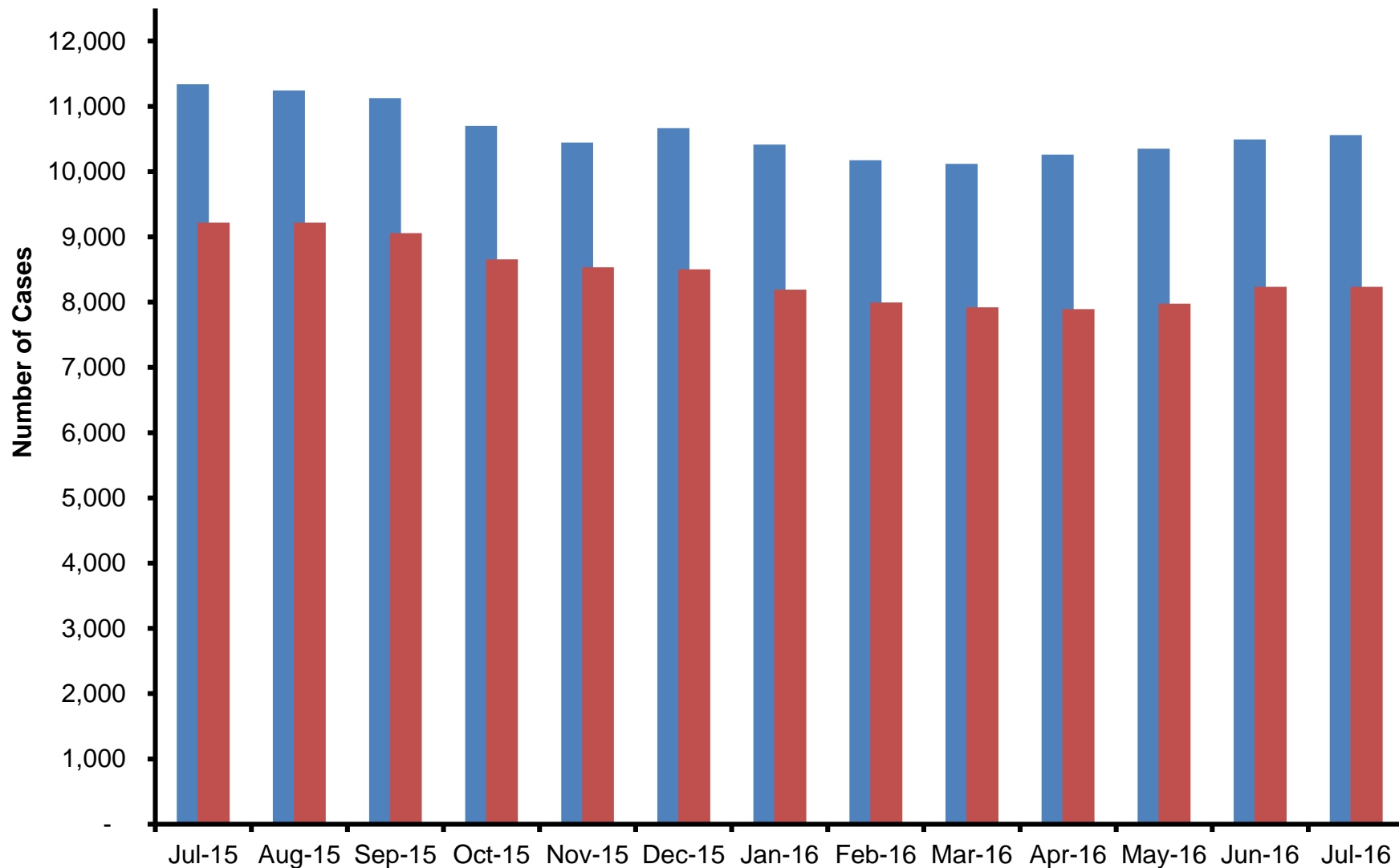

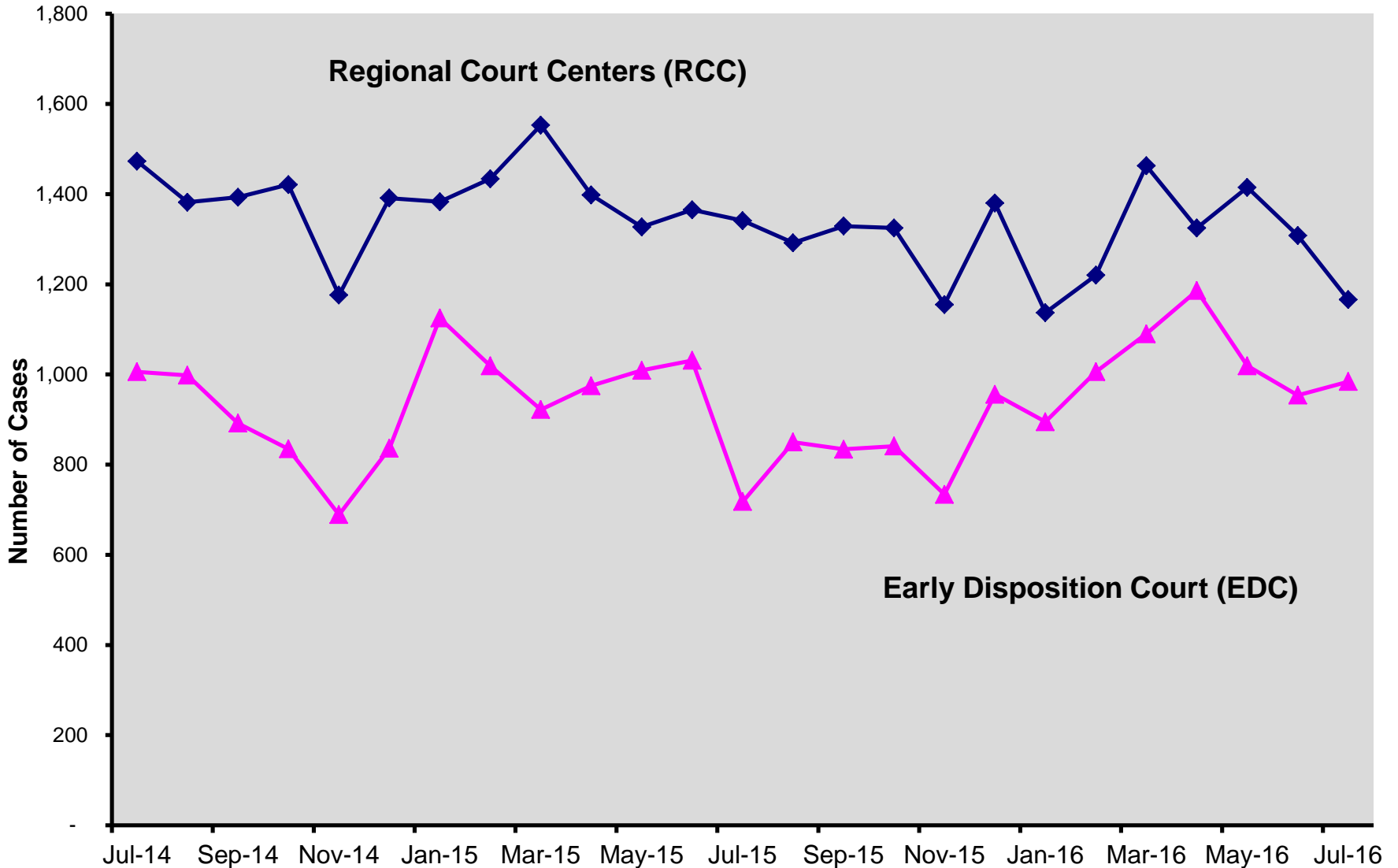


Active Pending Criminal Case Inventory

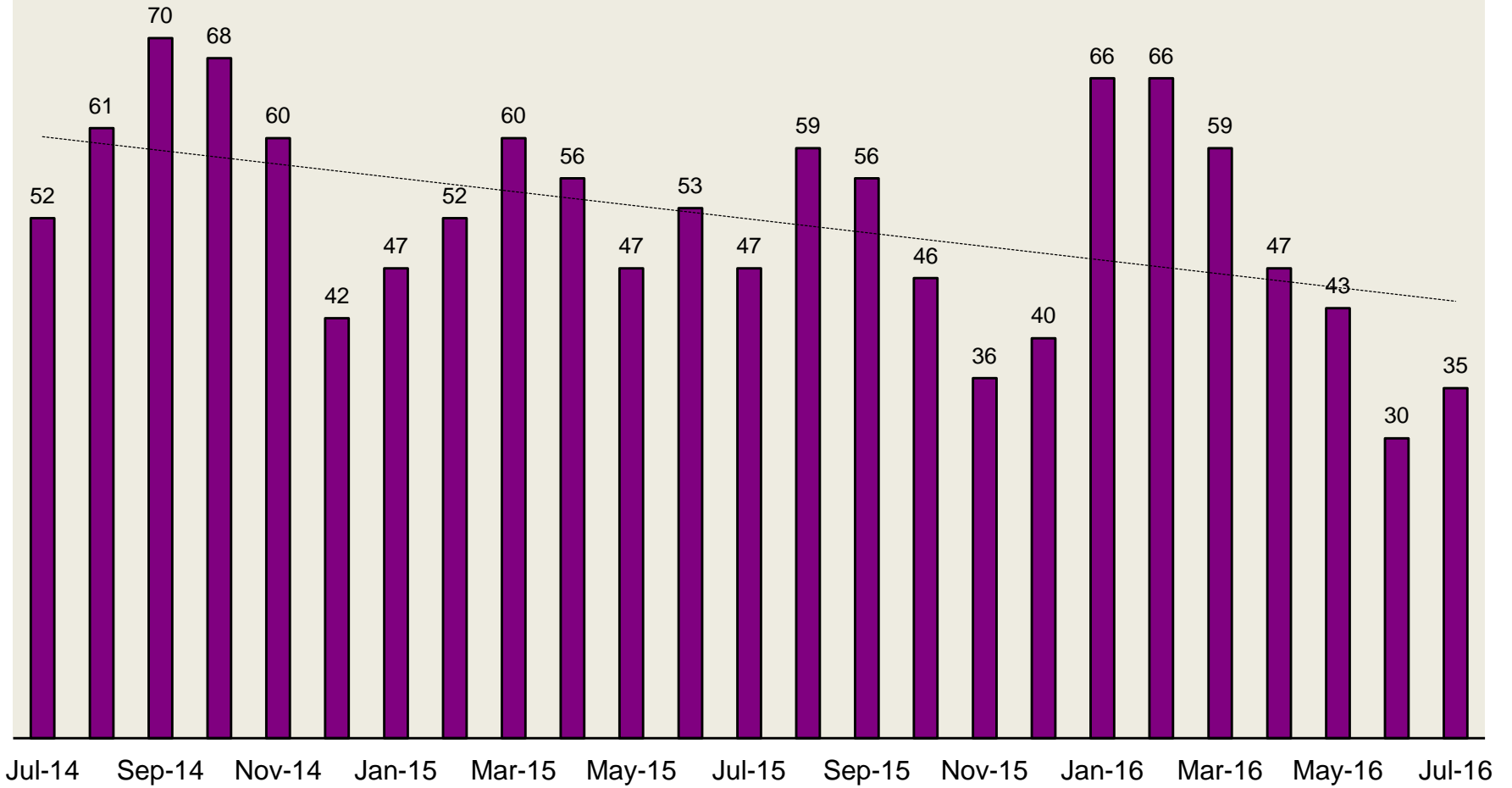

Superior Court Trials Completed

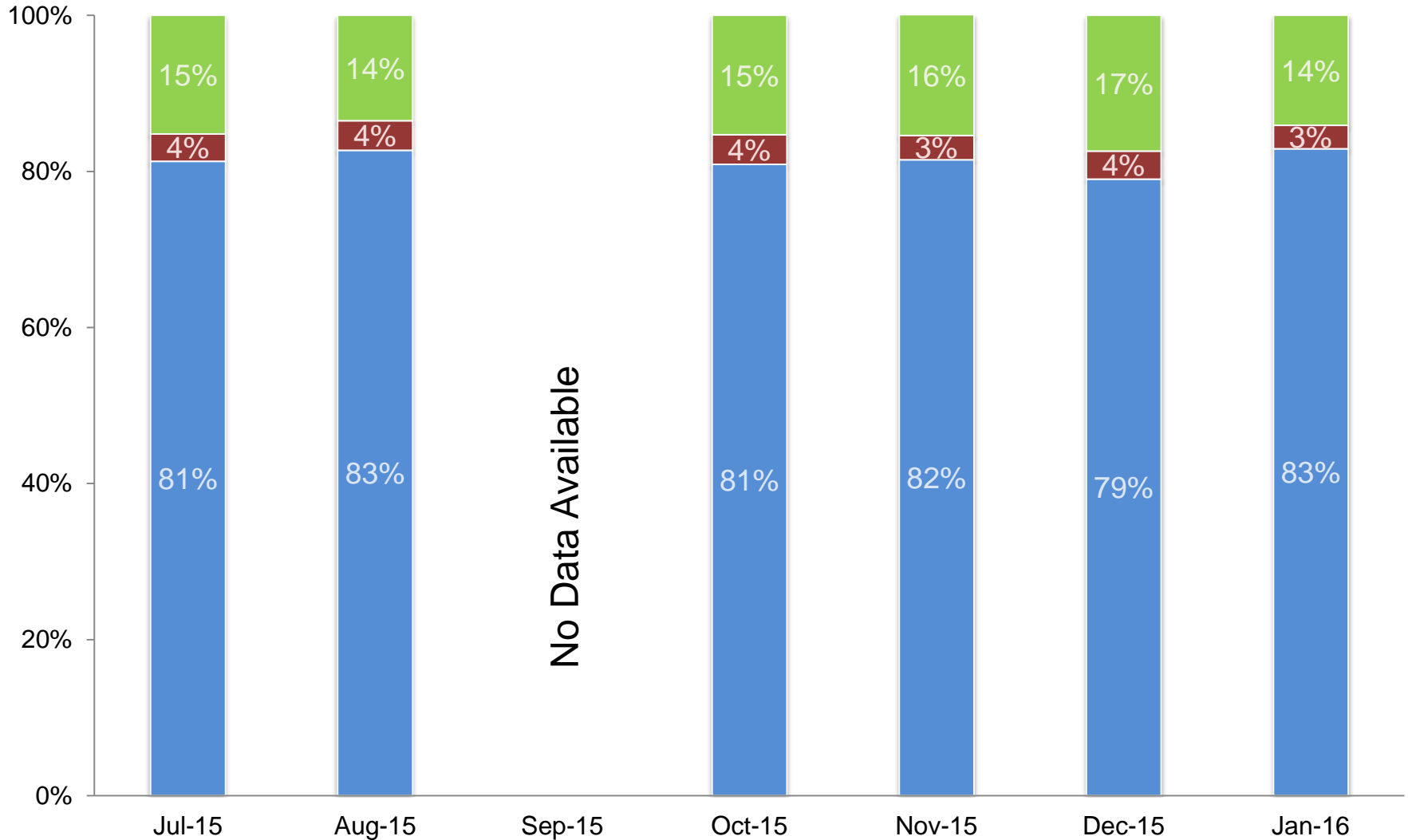


Status of Cases After 180 Days

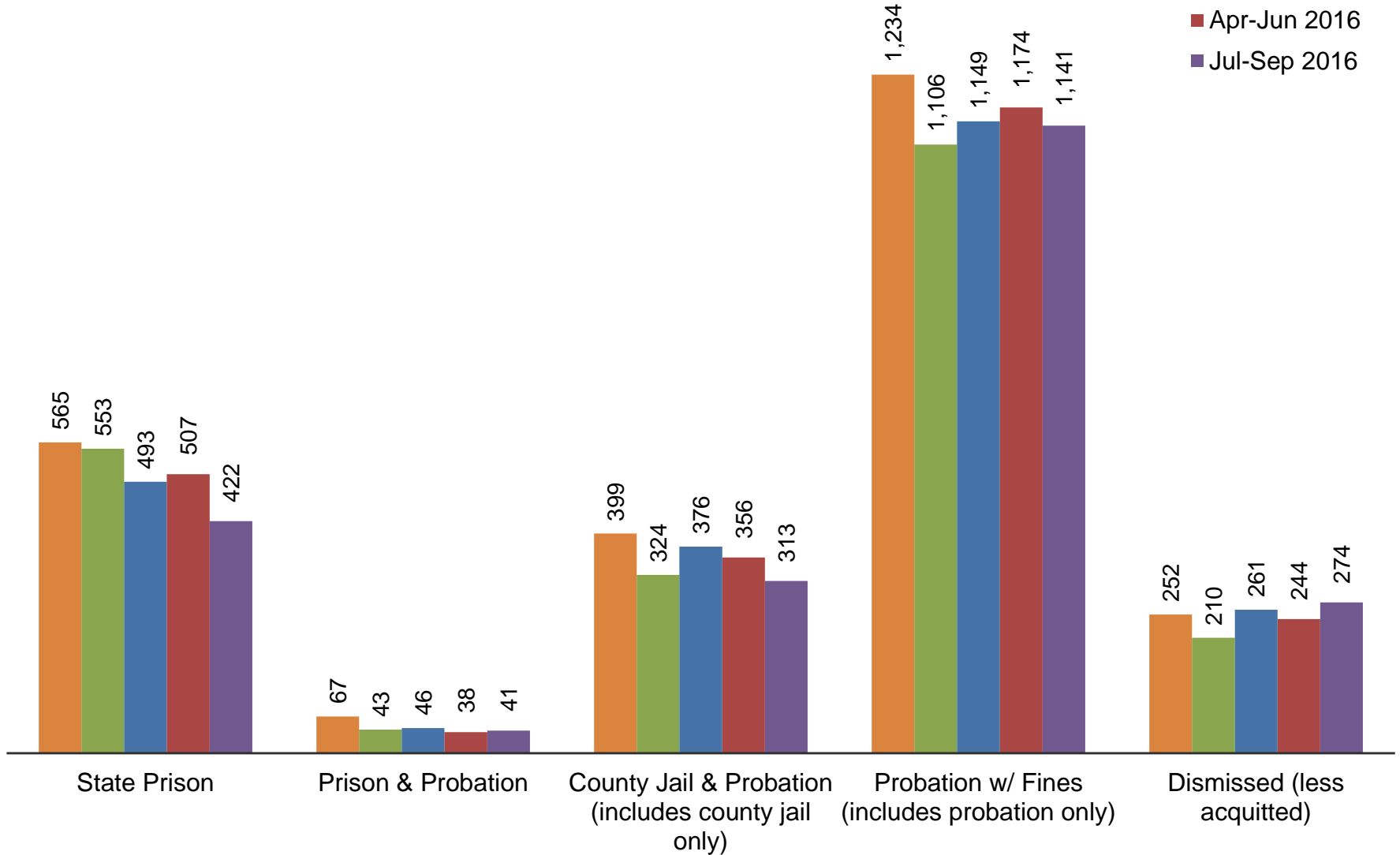

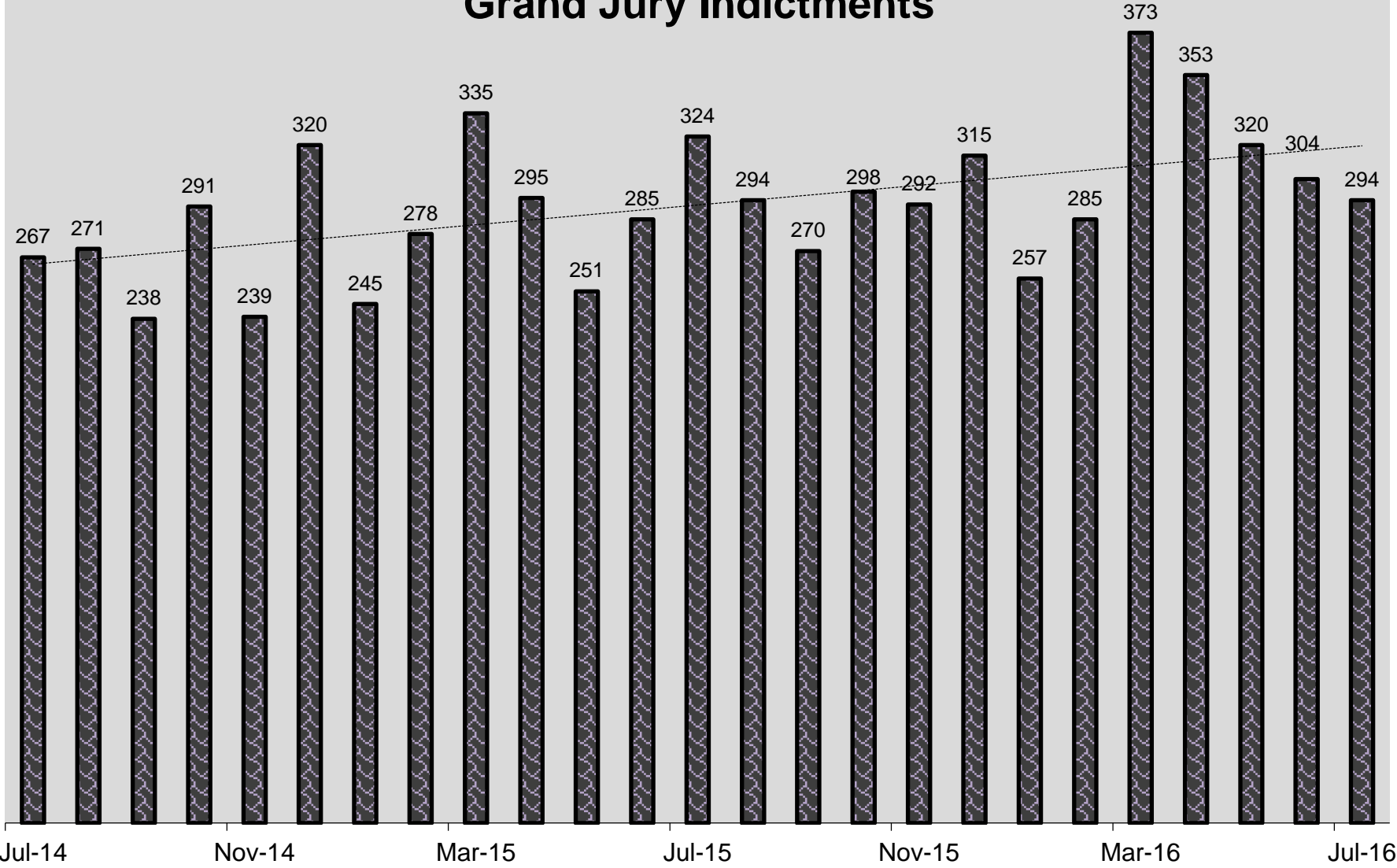
Disposition of Cases Terminated

Average Monthly Dispositions by Quarter

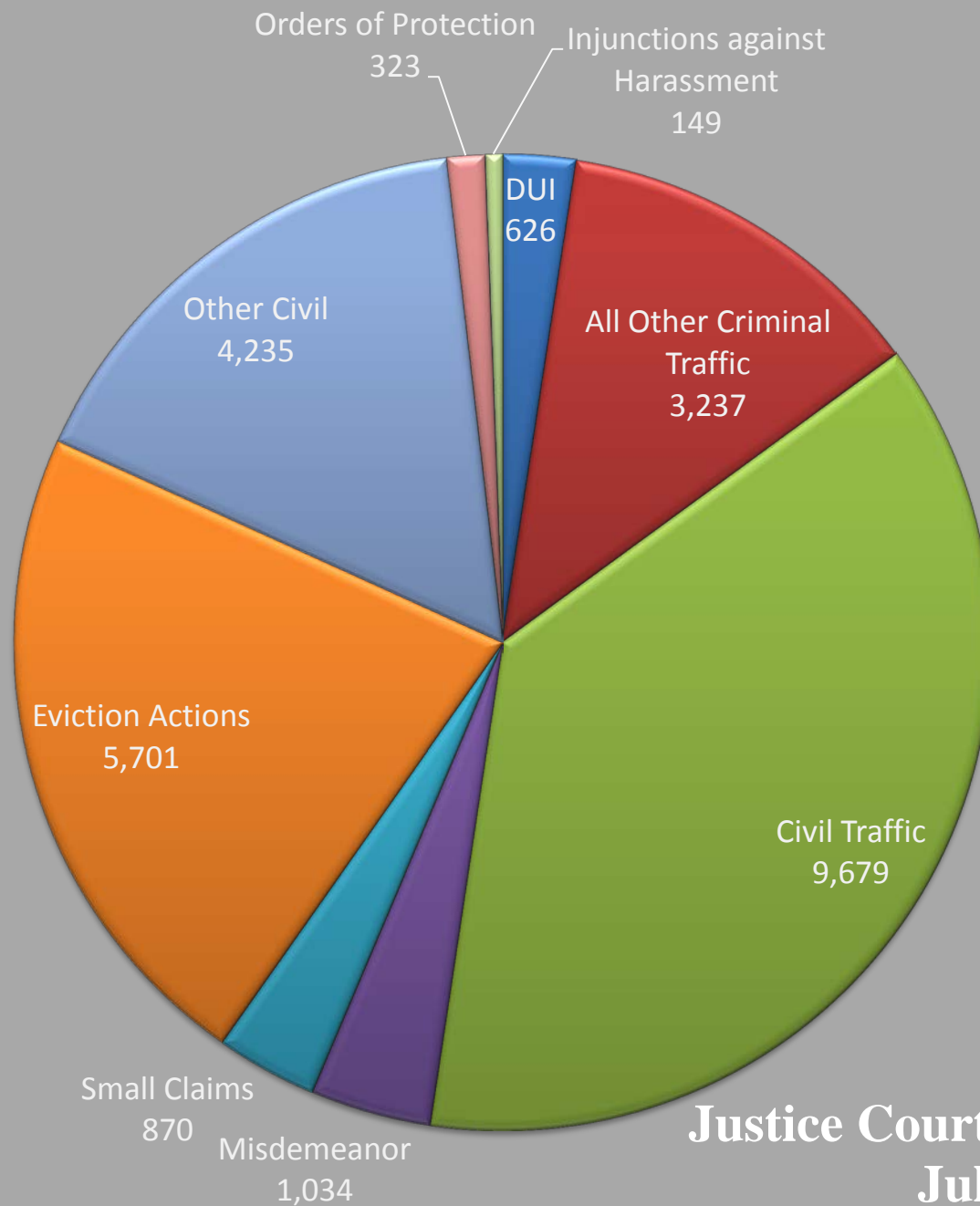

Grand Jury Indictments

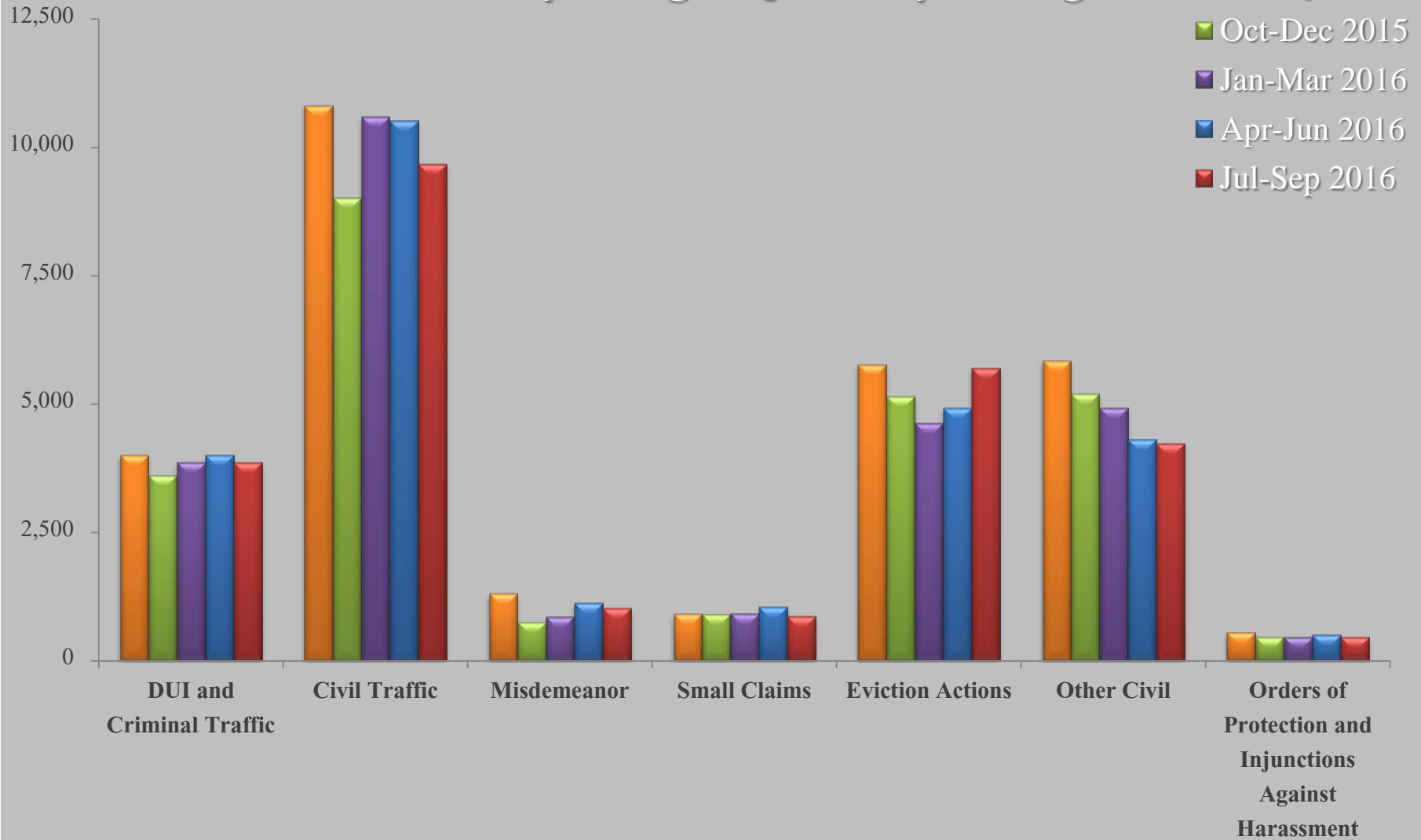

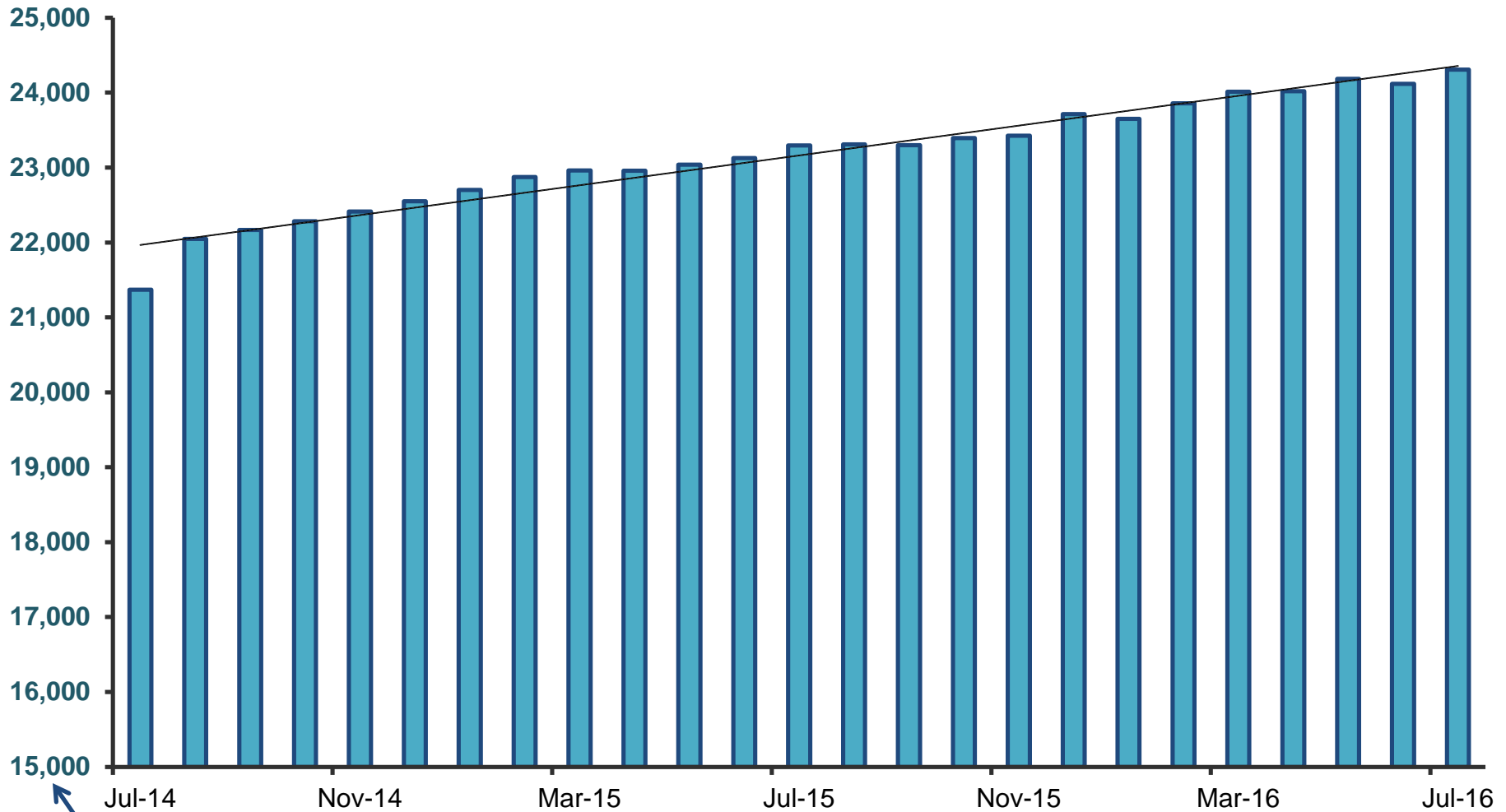

Justice Court Monthly Filings - Quarterly Average

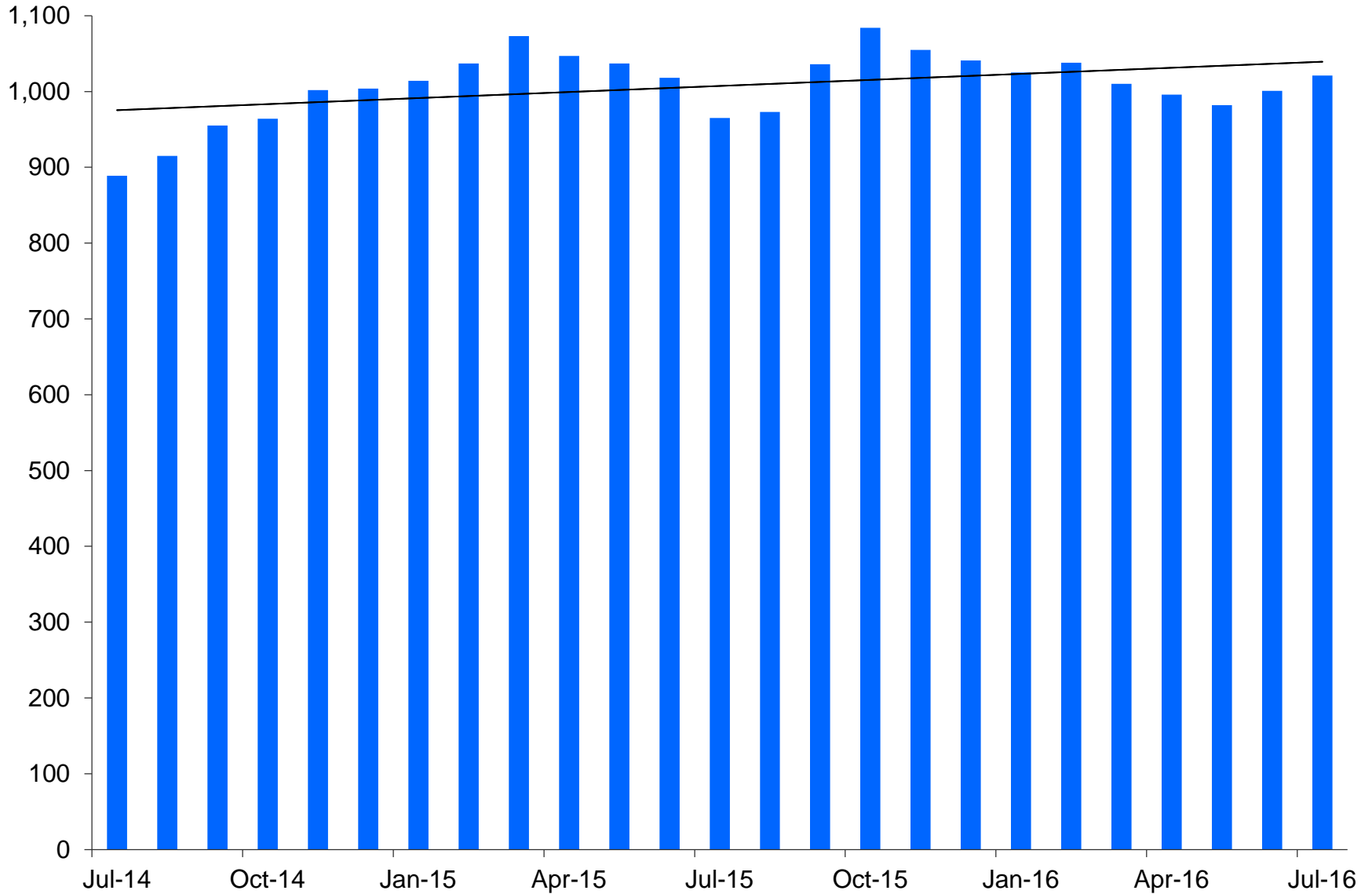


Adult Probation Department Standard Supervision

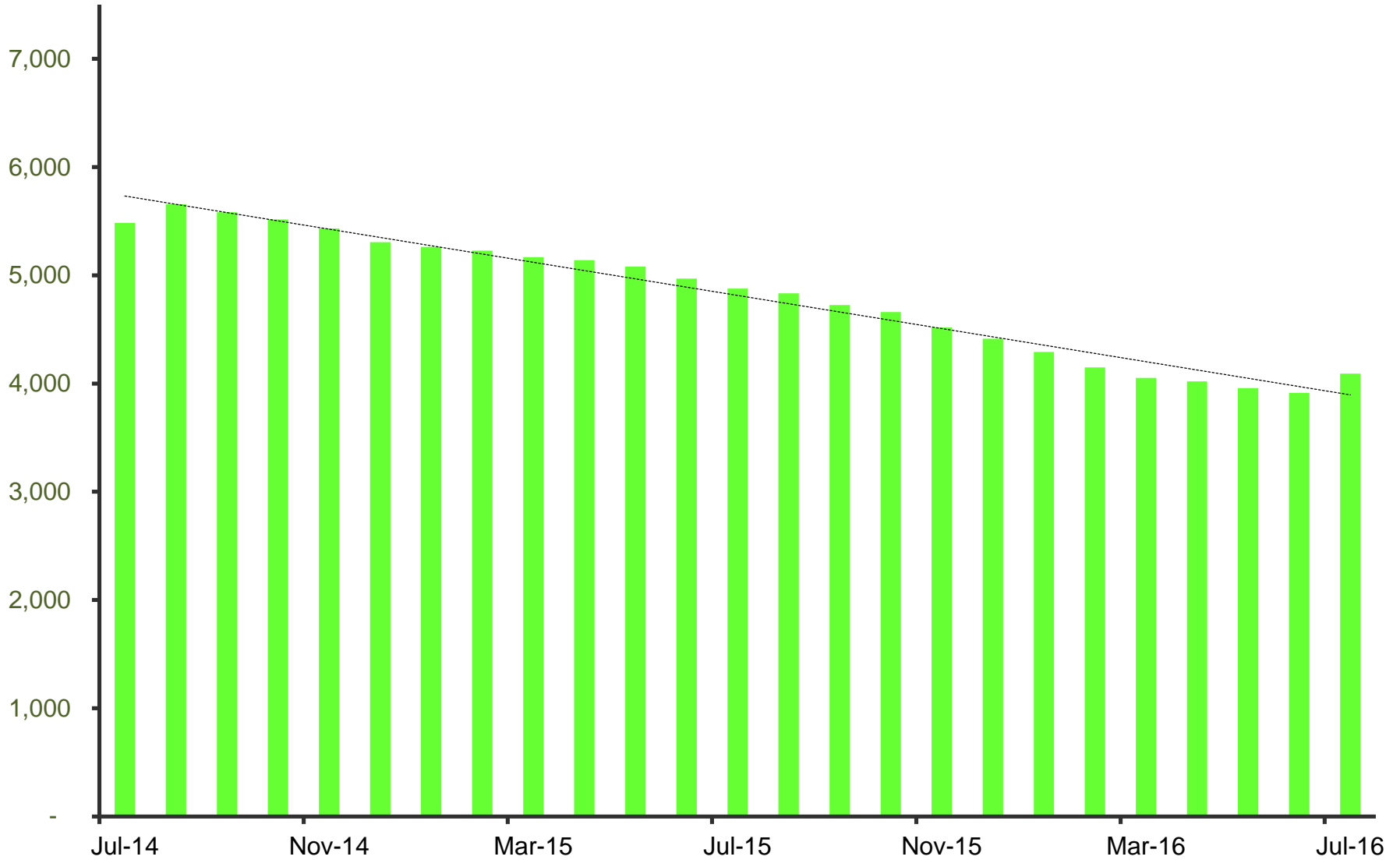

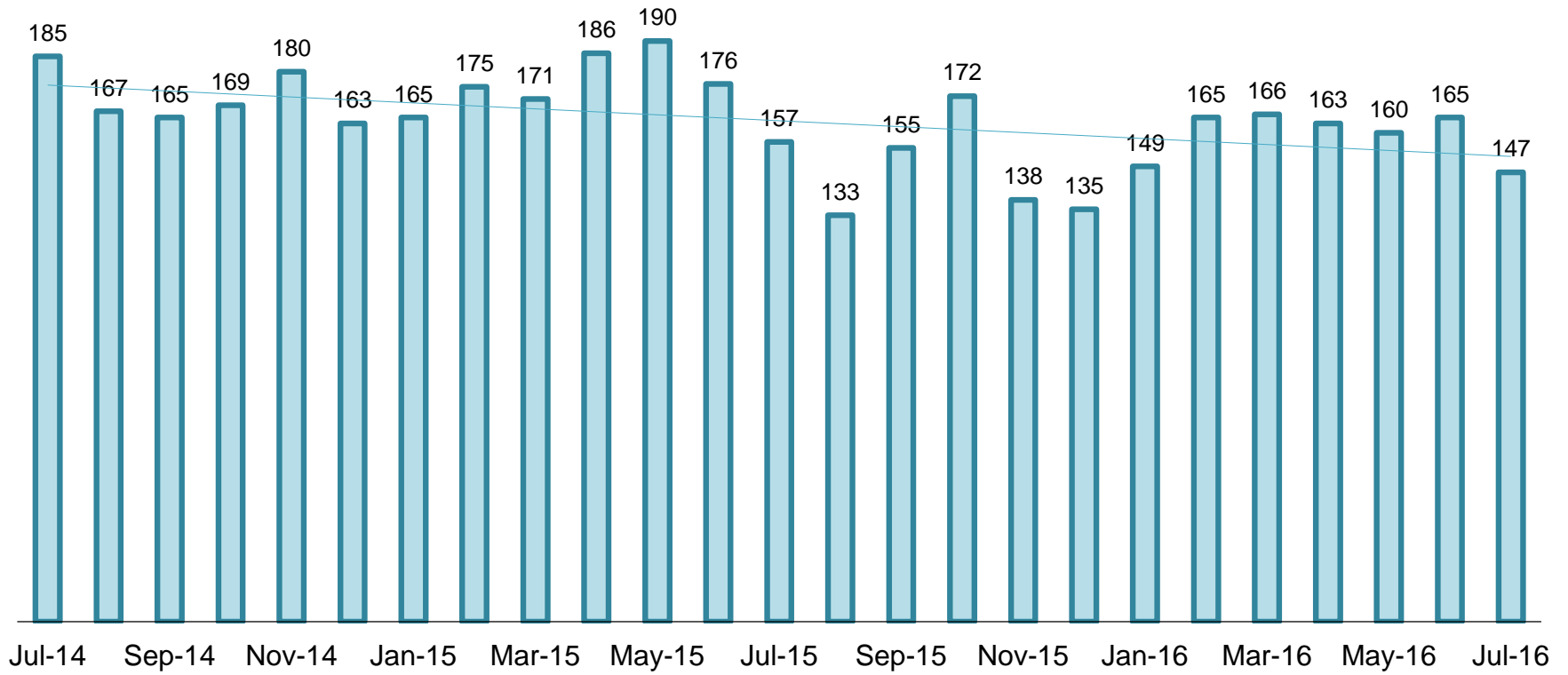
Adult Probation Intensive Supervision



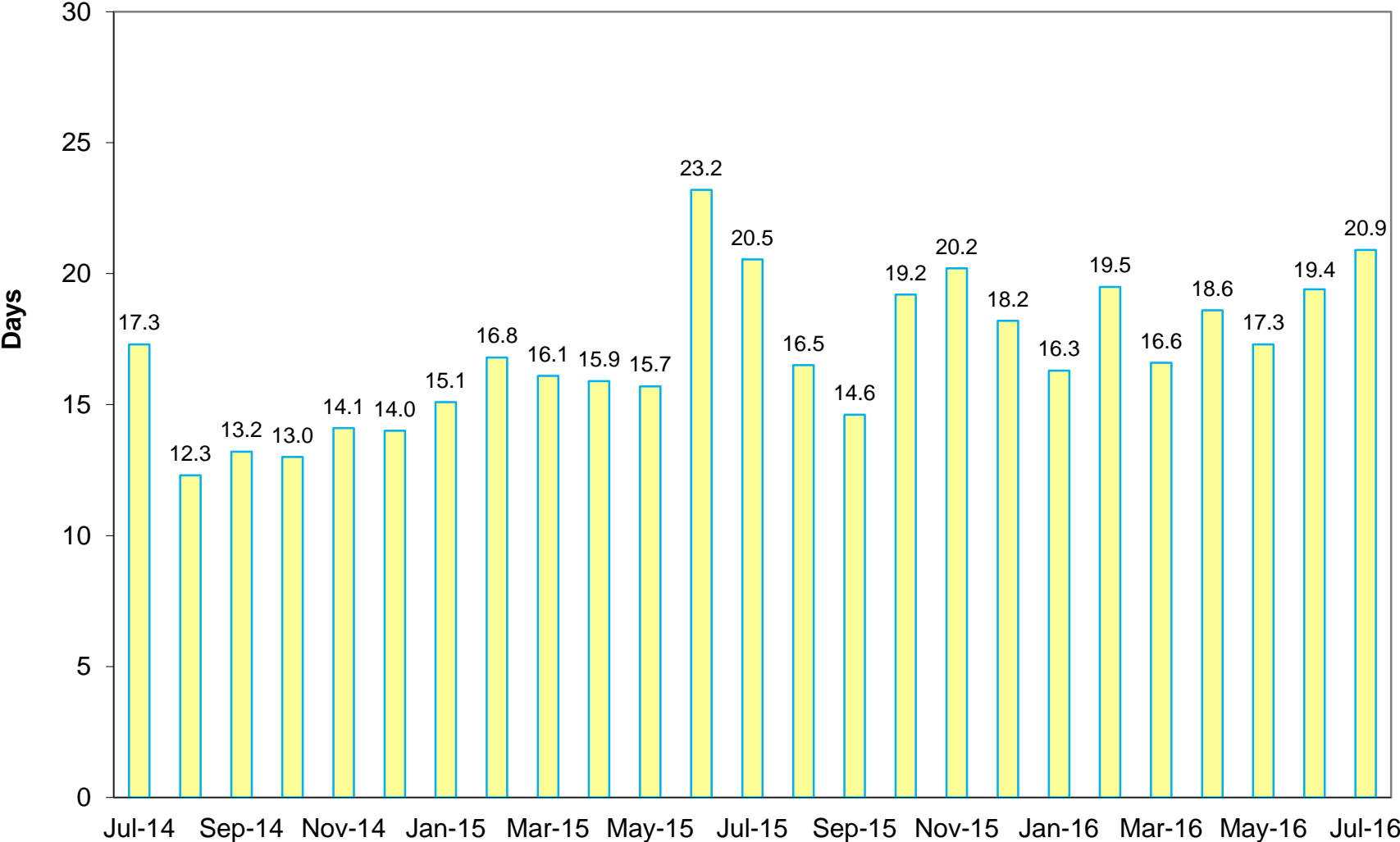
Adult Probation Unsupervised Population



Juvenile Detention Average Daily Population



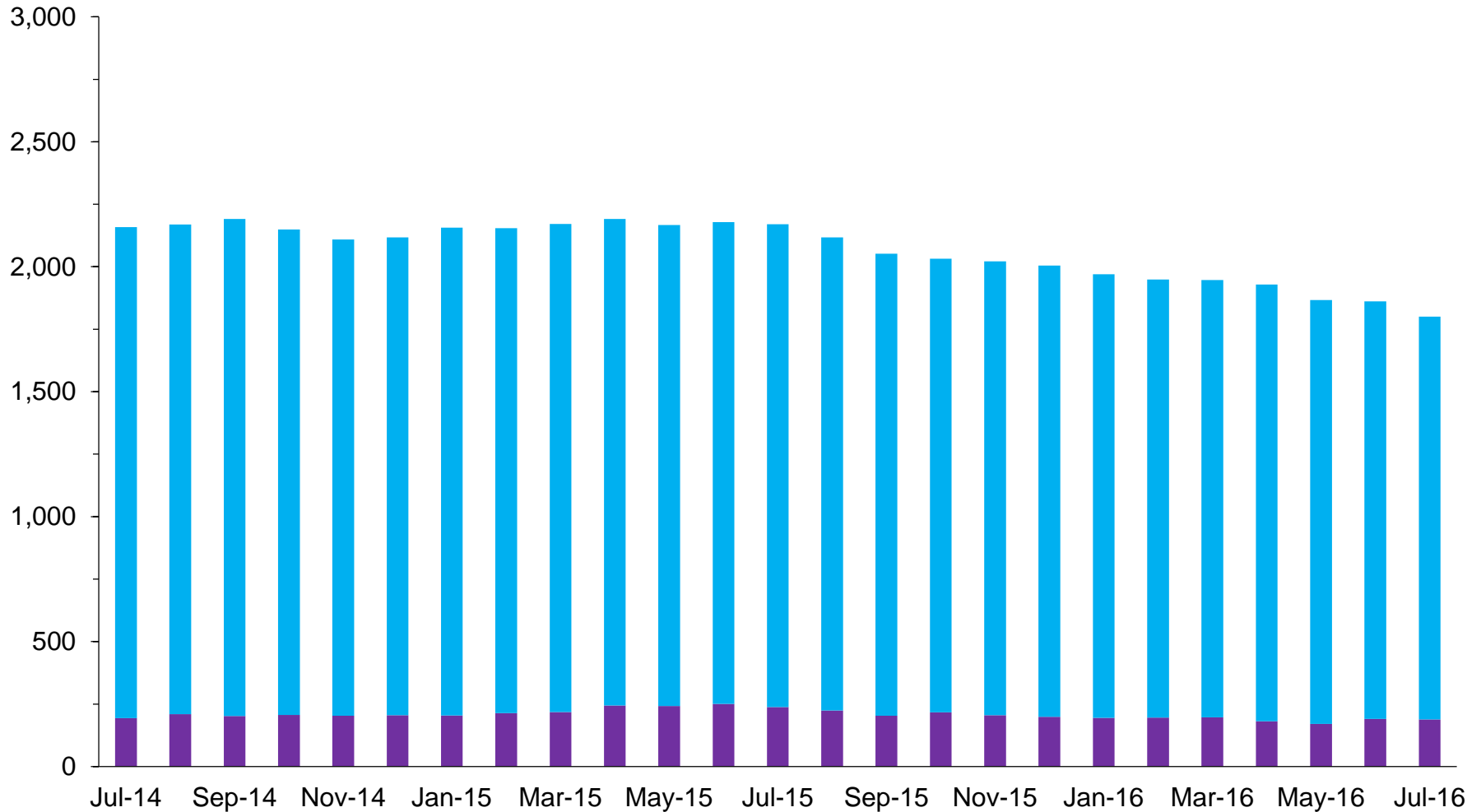
Juvenile Detention Average Length of Stay
